

ORDINANCE NO. 70776

BOARD BILL NO. 43 INTRODUCED BY ALDERWOMAN MARLENE DAVIS

1 An Ordinance recommended and approved by the Airport Commission, the Board of Public
2 Service, and the Board of Estimate and Apportionment authorizing a First Amendment to Section
3 One of the Airfield, Building & Environs Projects Ordinance 70617 approved October 16, 2017,
4 which authorized a multi-year public work and improvement program (“Airfield, Building &
5 Environs Projects”) at St. Louis Lambert International Airport®, increasing the total estimated cost
6 of the Airport, Building & Environs Projects by Four Million Dollars (\$4,000,000) to Nineteen
7 Million Dollars (\$19,000,000) and amending EXHIBIT A entitled “PROJECT LIST” by adding a
8 new project to the list entitled “Coldwater Creek Emergency Repairs – Stabilize Banks &
9 Channel”; authorizing a First Supplemental Appropriation in the total amount of Four Million
10 Dollars (\$4,000,000) from the Airport Development Fund into the Airport, Building & Environs
11 Projects Ordinance 70617 approved October 16, 2017, for the payment of costs for work and
12 services authorized therein; containing a severability clause; and an emergency clause.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

14 **SECTION ONE.** Section One of the Airfield, Building & Environs Projects Ordinance
15 70617 approved October 16, 2017, is hereby amended by deleting the following words and figures
16 from the last clause of Section One:

17 “and other necessary and related work or services for the development,
18 construction, installation, implementation, administration, management or
19 monitoring of the Airfield, Building & Environs Projects at a total estimated
20 cost of Fifteen Million Dollars (\$15,000,000).”

1 and replacing with the following words and figures:

2 “and other necessary and related work or services for the development,
3 construction, installation, implementation, administration, management or
4 monitoring of the Airfield, Building & Environs Projects at a total estimated
5 cost of Nineteen Million Dollars (\$19,000,000).”

6 **SECTION TWO.** EXHIBIT A entitled “PROJECT DESCRIPTION” to the
7 Airport, Building & Environs Projects Ordinance 70617 approved October 16, 2017, is hereby
8 amended by adding a new project to the list entitled “Coldwater Creek Emergency Repair –
9 Stabilize Banks & Channel”. A revised EXHIBIT A entitled “PROJECT LIST” dated April
10 24, 2018 is attached hereto and is incorporated herein.”

11 **SECTION THREE.** There is hereby authorized a First Supplemental Appropriation in the
12 total amount of Four Million Dollars (\$4,000,000) from the Airport Development Fund into the
13 Airport, Building & Environs Projects Ordinances 70617 approved October 16, 2017, for the
14 payment of costs for work and services authorized therein.

15 **SECTION FOUR.** It is hereby declared to be the intention of the Board of Aldermen
16 that each and every part, section, and subsection of this Ordinance will be separate and severable
17 from each and every other part, section, and subsection hereof and that the Board of Aldermen
18 intends to adopt each said part, section, and subsection separately and independently of any other
19 part, section, and subsection. In the event that any part, section, or subsection of this Ordinance
20 is determined to be unlawful or unconstitutional, the remaining parts, sections, and subsections
21 will remain in full force and effect, unless the court making such finding determines that the
22 valid portions standing alone are incomplete and are incapable of being executed in accord with

1 the legislative intent.

2 **SECTION FIVE.** This being an ordinance providing for a public work and improvement
3 program, it is hereby declared to be an emergency measure as defined in Article IV, Section 20 of
4 the City of St. Louis' Charter and will become effective immediately upon its approval by the
5 Mayor of the City of St. Louis.
