- 6 **WHEREAS**, in addition to Community Development Block Grant funds previously accepted by
- 7 and appropriated by the City for COVID-19 related expenses, the City has received a new
- 8 allocation of Community Development Block Grant funds to provide temporary financial
- 9 assistance to assist with rental payments.
- 10 BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:
- 11 **SECTION ONE.** The City is hereby authorized to accept a Community Development Block
- Grant award in the amount of \$2,390,776 (the CDBG-CV3 Funds).
- **SECTION TWO**. There are hereby appropriated Two Million Three Hundred Ninety Thousand
- Seven Hundred Seventy-Six Dollars (\$2,390,776) in CDBG-CV3 Funds to the Community
- 15 Development Administration. The Director of the Community Development Administration is
- hereby authorized to make, negotiate, and execute any and all contracts or other documents on
- behalf of the City which are necessary to expend such funds and to expend such funds as temporary
- 18 financial assistance for rental payments in accordance with the guidelines issued by HUD for the

- 1 CDBG-CV3 Funds, and the Comptroller is authorized and directed to issue warrants upon the City
- 2 Treasury for payment thereon.
- 3 **SECTION THREE**. Emergency Clause. This being an ordinance appropriated for emergency
- 4 funding for current expenses of the City government and for COVID-19 emergency relief, it is
- 5 hereby declared to be an emergency measure within the meaning of Sections 19 and 20 of Article
- 6 IV of the Charter of the City of St. Louis and shall become effective immediately upon its passage
- 7 and approval by the Mayor.
