

ORDINANCE 71242

BOARD BILL NUMBER 138 INTRODUCED BY: ALDERWOMAN MARLENE E. DAVIS

1 An Ordinance, recommended and approved by the Airport Commission and the Board of
2 Estimate and Apportionment, authorizing a First Amendment to the Ground Transportation Policy
3 **Ordinance 69382** approved February 6, 2013, deleting Section 6.A.4 of **Ordinance 69382** and
4 substituting a new Section 6.A.4 increasing the monthly permit fees for Off-Airport Rental Car
5 operators beginning April 1, 2021, containing a severability clause; and containing an emergency
6 clause.

7 **WHEREAS**, Ground Transportation Policy **Ordinance 69382** approved February 6, 2013
8 established certain ground transportation policies for St. Louis Lambert International Airport®
9 (the “Airport”); and

10 **WHEREAS**, the City of St. Louis (the “City”), the owner and operator of the Airport, has
11 determined that it is in the best interest of the City, Airport, and the traveling public to increase the
12 monthly permit fees for Off-Airport Rental Car Operators beginning April 1, 2021.

13 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

14 **SECTION 1.** Section Six entitled “Fees and Charges” of the Ground Transportation
15 Policy **Ordinance 69382** approved February 6, 2013, is hereby amended by deleting Section 6A.4
16 as follows:

- 17 “4. For Off-Airport Rental Car Operators:
- 18 a. Through December 31, 2013, the monthly permit fee shall be the greater of: i)
- 19 \$150.00 per month or \$30.00 per vehicle operated at or to or from the Airport

1 whichever is greater or ii) 8% of the monthly Adjusted Gross Receipts.

- 2 b. Beginning January 1, 2014 and thereafter the greater of \$200.00 per month or 9%
3 of the Adjusted Gross Receipts for the preceding month.”

4 and replacing in lieu thereof a new Section 6.A.4 as follows:

5 “4. For Off-Airport Rental Car Operators:

- 6 a. Through March 31, 2021, the monthly permit fee will be the greater of \$200.00 per
7 month or 9% of the monthly Adjusted Gross Receipts for the preceding month.

- 8 b. Beginning April 1, 2021 and thereafter the monthly permit fee will be the greater of
9 \$200.00 per month or 10% of the Adjusted Gross Receipts for the preceding month.”

10 **SECTION 2.** The sections or provisions of this Ordinance or portions thereof are severable.

11 In the event that any section or provision of this Ordinance or portion thereof is held invalid by a court
12 of competent jurisdiction, such holding will not invalidate the remaining sections or provisions of this
13 Ordinance unless the court finds the valid sections or provisions of this Ordinance are so essentially
14 and inseparably connected with, and so dependent upon, the illegal, unconstitutional or ineffective
15 section or provision that it cannot be presumed that the Board of Aldermen would have enacted the
16 valid sections or provisions without the illegal, unconstitutional or ineffective sections or provisions
17 or unless the court finds that the valid sections or provisions, standing alone, are incomplete and
18 incapable of being executed in accordance with the legislative intent.

19 **SECTION 3.** This Ordinance being deemed necessary for the immediate preservation of
20 the public peace, health or safety, it is hereby declared to be an emergency measure pursuant to
21 Article IV, Section 20 of the City of St. Louis’ Charter and will become effective immediately

1 upon passage and approval by the City of St. Louis' Mayor.
