This Board Bill authorizes the Department of Health (the “DOH”) to accept a Centers for Disease Control and Prevention (“CDC”) Foundation award (CDC-RFA-OT18-1802) funding of Two Thousand Eight Hundred Dollars (\$2,800.00) through a contract with the National Environmental Health Association (“NEHA”) as part of an Explorer Contract Grant to reimburse DOH during the period of April 1, 2021 through July 31, 2021 for the purpose of supporting food safety program activities, designed to explore involvement in CDC’s National Environmental Assessment Reporting System (“NEARS”), with such activities including:

- Staff time to learn about NEARS, such as
 - Taking Environmental Assessment Training Series (EATS) or equivalent training course as identified by NEHA to conduct environmental assessments
 - Participating in a NEARS webinar training session
 - Attending a regional or national NEARS presentation
- Purchase of environmental sampling/other investigation equipment to build capacity in foodborne outbreak investigation
- Activities that encourage local programs within the state to participate.

This training of Food and Beverage Inspectors at DOH will increase capacity to utilize the CDC NEARS for food-borne illness outbreaks associated with retail prepared food establishments such as restaurants, banquet facilities, schools, and other institutions in order to:

- Identify environmental causes of outbreaks;
- Take follow-up action to reduce or prevent future foodborne illness outbreaks;
- Evaluate the DOH food safety program and make improvements based on established guidelines;
- Develop or modify program policies and/or regulations;
- Focus limited program resources on actions with the highest impact; and
- Meet the Food and Drug Administration’s Retail Food Program Standard 5.

1 An Ordinance recommended by the Board of Estimate and Apportionment authorizing the
2 Department of Health (the “DOH”) to accept Centers for Disease Control and Prevention (“CDC”)
3 Foundation award (CDC-RFA-OT18-1802) funding of Two Thousand Eight Hundred Dollars
4 (\$2,800.00) through a contract with the National Environmental Health Association (“NEHA”) to
5 reimburse DOH for the purpose of supporting food safety program activities, designed to explore
6 involvement in CDC’s National Environmental Assessment Reporting System (“NEARS”);
7 appropriating the CDC NEARS grant funds to DOH; authorizing the expenditure of CDC NEARS
8 grant funds for grant purposes, and to fulfill the obligations of said grant; and containing an
9 emergency clause.

10 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

11 **SECTION ONE.** There is hereby appropriated up to Two Thousand Eight Hundred
12 Dollars (\$2,800.00) of the CDC NEARS grant. The Acting Director of the City of St. Louis
13 Department of Health is hereby authorized to accept the CDC NEARS grant by executing the
14 Subaward Agreement with NEHA, set forth in **ATTACHMENT A**; to expend such funds; and to
15 make, negotiate, and execute any and all contracts or other documents on behalf of the City
16 therefore, for the purposes of providing reimbursement funding assistance to support training of
17 DOH Food and Beverage Inspectors on the use of the NEARS during the period of April 1, 2021
18 through July 31, 2021 (and during any subsequent extensions, if any), purchasing any needed
19 environmental sampling/other investigation equipment to build capacity in foodborne outbreak
20 investigations, supporting activities that encourage local programs within Missouri to participate
21 in NEARS, and for all other purposes in the Subaward Agreement with NEHA.

1 **SECTION TWO.** Emergency Clause. This being an ordinance for the preservation of the
2 public peace, health and safety, it is hereby declared to be an emergency measure within the
3 meaning of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis, and therefore,
4 this ordinance shall become effective immediately upon its passage and approval by the Mayor.

SUBAWARD AGREEMENT

This Subaward Agreement is effective as of the date of the later signature indicated below, between the National Environmental Health Association (NEHA) with its principal place of business, 720 S Colorado Boulevard, Suite 1000N, Denver, Colorado 80246 and the City of St. Louis, by and through its Department of Health, (hereinafter referred to as "Subrecipient").

WHEREAS, NEHA wishes to hire Subrecipient to perform the services specified herein for NEHA to enhance the programmatic activities of a grant;

WHEREAS, Subrecipient wishes to perform such services for NEHA.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, do hereby agree as follows:

ARTICLE I: SPECIAL PROVISIONS

1. PURPOSE OF AGREEMENT: Subrecipient agrees to fully engage and participate in the NEARS Explorer program in support of NEHA's programmatic activities under CDC-RFA-OT18-1802 as described in Attachment I. The terms of Attachment I shall be incorporated into this Agreement as if fully set forth herein. Subrecipient shall act at all times in a professional manner consistent with the standards of the industry.
2. TERM OF AGREEMENT: The term of the Agreement shall begin on April 1, 2021 through July 31, 2021, unless earlier terminated in accordance with the terms herein. Expiration of the term or termination of this Agreement shall not extinguish any rights or obligations of the parties that have accrued prior thereto.
3. PAYMENT FOR PARTICIPATION: In consideration for participation in the NEARS Explorer program, NEHA agrees to reimburse the Subrecipient for eligible costs incurred up to \$2,800. Eligible costs are those previously approved by NEHA and are listed in Attachment I. All payments will be made within 30 days of receipt of final invoice from Subrecipient and following approval by NEHA for approved activities, as outlined on Attachment I. The final invoice must be received by NEHA no later than 30 days after the end date of the Agreement.

ARTICLE II: GENERAL PROVISIONS

1. PAYMENT OF TAXES AND OTHER LEVIES: Subrecipient understands and agrees that it will be treated as an independent contractor for federal and state tax filing purposes and will be issued any required tax forms. NEHA has no responsibility for payment of taxes or other levies on behalf of Subrecipient.
2. ALLOCATION OF RESPONSIBILITIES: Each party to this Agreement agrees that it will be responsible for its own acts and omissions and the results thereof; and, shall not be responsible for the acts and omissions of the other party and the results thereof. Each party agrees that it will assume all risk and liability to itself, its agents, or its employees for any injury to persons or property resulting in any manner from conduct of its own operations and the operations of its agents or employees under this agreement.

3. **REVISIONS AND AMENDMENTS:** Any revisions or amendments to this Agreement must be made in writing and signed by both parties.
4. **CONTINGENCY CLAUSE:** This Agreement is subject to the terms of any agreement between NEHA and its Primary Funder and in particular may be terminated by NEHA without penalty or further obligation if the Primary Funder terminates, suspends or materially reduces its funding for any reason. Additionally, the payment obligations of NEHA under this Agreement are subject to the timely fulfillment by the Primary Funder of its funding obligations to NEHA.
5. **INTERFERING CONDITIONS:** Subrecipient shall promptly and fully notify NEHA of any condition that interferes with, or threatens to interfere with, the successful carrying out of Subrecipient's duties and responsibilities under this Agreement, or the accomplishment of the purposes thereof.
6. **TERMINATION:** Either party may terminate this Agreement upon at least fifteen (15) days prior written notice to the other party.
7. **GOVERNING LAW:** This Agreement shall be governed by and construed in accordance with the laws of the subrecipient.
8. **ADDITIONAL FUNDING:** No additional funds will be allocated to this project beyond the amount listed in #3 under Special Provisions of this Agreement.
9. **NOTICE:** All notices, including invoices, required to be delivered to the other party pursuant to this Agreement shall be in writing and shall be sent via email.
