

ORDINANCE 71466

BOARD BILL NUMBER 149 INTRODUCED BY: ALDERMAN BRANDON BOSLEY

1 An ordinance repealing **Ordinance Number 70573** and in lieu thereof enacting a new ordinance
2 prohibiting the issuance of any package or drink liquor licenses for any currently non-licensed
3 premises within the boundaries of the Third Ward Liquor Control District, as established herein,
4 for a period of five years; containing exceptions and allowing, during the moratorium period, for
5 the transfer of existing licenses, under certain circumstances, and the issuance of a drink license to
6 persons operating a restaurant at a previously non-licensed premises and containing an emergency
7 clause.

8 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

9 **SECTION ONE.** **Ordinance Number 70573** is hereby repealed and in lieu thereof the
10 following provisions are enacted:

11 **SECTION TWO.** The existence of alcoholic beverage establishments appears to contribute
12 directly to numerous peace, health, safety and general welfare problems including loitering,
13 littering, drug trafficking, prostitution, public drunkenness, defacement and damaging of
14 structures, pedestrian obstructions, as well as traffic circulation, parking and noise problems on
15 public streets and neighborhood lots. The existence of such problems creates serious impacts on
16 the health, safety and welfare of residents of single- and multiple-family within the district,
17 including fear for the safety of children, elderly residents and of visitors to the district. The
18 problems also contribute to the deterioration of the neighborhood and concomitant devaluation of
19 property and destruction of community values and quality of life. The number of establishments
20 selling alcoholic beverages and the associated problems discourage more desirable and needed
21 commercial uses in the area. In order to preserve the residential character and the neighborhood-

4 Liquor Control District.

5 **SECTION THREE.** The Excise Commissioner shall not, for a period of five years,
6 beginning as of the effective date of this Ordinance, approve the issuance of a package
7 liquor license for any premises which is located within the boundaries of the Third Ward
8 Liquor Control District established in Section Two of this ordinance.

9 **SECTION FOUR.** Notwithstanding the provisions of Section Three of this Ordinance, the
10 Excise Commissioner shall have authority to:

11 (1) Approve transfer of an existing license to another premises within the petition circle of
12 the currently licensed premises, pursuant to the provisions of **subsection (B) of Section 14.06.330**
13 **of Ordinance Number 68536;** and

14 (2) Issue a drink license for premises, not licensed as of the effective date of this Ordinance,
15 which currently is or will be, upon opening, operated as a restaurant, as such term is defined in
16 **Section 14.01.390 of Ordinance Number 68536.**

17 (3) Approve the renewal of an existing license under the provisions of **Section 14.08.090**
18 **of Ordinance Number 68536.**

19 (4) Approve the issuance of a new 5 percent license (Beer License.)

20 **SECTION FIVE. Emergency Clause.** This being an ordinance for the preservation of public
21 peace, health and safety, it is hereby declared to be an emergency measure within the meaning of
22 Sections 19 and 20 of Article IV of the Charter of the City of St.
