

ORDINANCE 71532

BOARD BILL NUMBER 24 INTRODUCED BY ALDERMAN JOHN COATAR

1 Pursuant to **Ordinance Number 70333** as amended by **Ordinance Number 71394**, an ordinance
2 directing the Director of Streets to install speed humps to calm the flow of traffic on the 2200
3 block of Indiana Ave, the 2200 block of Missouri Ave, Mississippi Ave between Geyer Ave and
4 the Interstate 44 overpass, the 2200 block of Jules St, the 2100 block of Geyer Ave, the 2000 block
5 of Geyer Ave, the 2000 block of Ann Ave, 2100 block of Allen Ave, and the 2000 block of Allen
6 Ave.

7 **BE IT ORDAINED BY THE CITY OF ST. LOUIS, AS FOLLOWS:**

8 **SECTION ONE.** Pursuant to **Ordinance Number 70333** as amended by **Ordinance**
9 **Number 71394** the Director of Streets is hereby directed to install speed humps to calm the flow
10 of traffic on the 2200 block of Indiana Ave, the 2200 block of Missouri Ave, Mississippi Ave
11 between Geyer Ave and the Interstate 44 overpass, the 2200 block of Jules St, the 2100 block of
12 Geyer Ave, the 2000 block of Geyer Ave, the 2000 block of Ann Ave, 2100 block of Allen Ave,
13 and the 2000 block of Allen Ave as follows:

- 14 1. One speed hump shall be installed on the 2200 block of Indiana Ave between 2242 Indiana
15 Ave and 2244 Indiana Ave.
- 16 2. One speed hump shall be installed on the 2200 block of Missouri Ave between 2237
17 Missouri Ave and 2235 Missouri Ave.
- 18 3. One speed hump shall be installed on Mississippi Ave north of the intersection of
19 Mississippi Ave and Geyer Ave and thirty (30) feet to the south of the intersection of
20 Mississippi Ave and the east west alleyway before the Mississippi Ave Interstate 44
21 overpass.

- 1 4. One speed hump shall be installed on the 2200 block of Jules Ave between 2234 Jules Ave
2 and 2240 Jules Ave.
- 3 5. One speed hump shall be installed on the 2100 block of Geyer Ave between 2137 Geyer
4 Ave and 2139 Geyer Ave.
- 5 6. One speed hump shall be installed on the 2000 block of Geyer Ave between 2030 Geyer
6 Ave and 2032 Geyer Ave.
- 7 7. One speed hump shall be installed on the 2000 block of Ann Ave between 2025 Ann Ave
8 and 2029 Ann Ave.
- 9 8. One speed hump shall be installed on the 2100 block of Allen Ave between 2133 Allen
10 Ave and 2135 Allen Ave.
9. One speed hump shall be installed on the 2000 block of Allen Ave between 2025 Allen
 Ave and 2027 Allen Ave.

11 **SECTION TWO** Emergency Clause. This being an ordinance for the preservation of public
12 peace, health, and safety, it is hereby declared to be an emergency measure within the meaning
13 of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore shall
14 become effective immediately upon its passage and approval by the Mayor.
