

1 **BOARD BILL # 159 INTRODUCED BY ALDERWOMAN JENNIFER FLORIDA**

2 An ordinance pertaining to the Leasehold Revenue Bonds, Series 2005 authorized by Ordinance
3 66648 and Leasehold Revenue Bonds, Series 2008 authorized by Ordinance 67974
4 recommended by the Board of Estimate and Apportionment, appropriating an amount not to
5 exceed Two Million Four Hundred Thousand Dollars (\$2,400,000), from interest earnings in the
6 Leasehold Revenue Bonds, Series 2005 bond fund account to be used for convention center
7 capital improvement projects; and Twenty-Four Million Two Hundred Ten Thousand Dollars,
8 (\$24,210,000) from Leasehold Revenue Bonds, Series 2008 project bond funds for City Wide
9 Capital Improvement Projects; and authorizing the Comptroller to draw warrants from time to
10 time upon submission of properly certified vouchers in conformance with procedures established
11 by the Comptroller of the City; and containing an emergency clause.

12 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

13 **SECTION ONE.** There is hereby appropriated from interest earnings in the Leasehold
14 Revenue Bonds, Series 2005 bond funds account an amount not to exceed Two Million Four
15 Hundred Thousand Dollars (\$2,400,000) to be used for convention center capital improvement
16 projects as detailed in Exhibit A;

17 **SECTION TWO.** There is hereby appropriated from Leasehold Revenue Bonds,
18 Series 2008 project bond funds Twenty-Four Million Two Hundred Ten Thousand Dollars,
19 (\$24,210,000) for City Wide Capital Improvement Projects as detailed in Exhibit B;

20 **SECTION THREE.** The Comptroller of the City is hereby authorized to draw
21 warrants from time to time on the Treasurer of the City for payment of expenses authorized
22 herein upon submission of properly certified vouchers in conformance with procedures
23 established by the Comptroller of the City and, as necessary, the Comptroller or Treasurer are

1 hereby authorized to make such applications or certifications and provide such data to the
2 Trustee of the Leasehold Revenue Bonds, Series 2005 authorized under Ordinance 66648 and
3 the Trustee of the Leasehold Revenue Bond Series 2008 authorized under Ordinance 67974 and
4 to take whatever action necessary in order to provide for the payment or reimbursement of
5 eligible costs authorized herein.

6 **SECTION FOUR.** Emergency Clause. This being an Ordinance for public works, it
7 is hereby declared to be an immediate measure within the meaning of Sections 19 and 20 of
8 Article IV of the Charter of the City of St. Louis and therefore this Ordinance shall become
9 effective immediately upon its passage and approval by the Mayor.
