

BOARD BILL NO. 170

INTRODUCED BY: ALDERMAN JEFFREY BOYD

1 An ordinance recommended by the Board of Public Service to vacate above surface, surface and
2 sub-service rights for vehicle, equestrian and pedestrian travel in 1) Hebert from Clara to
3 Blackstone, 2) Blackstone from Hebert to Ashland, 3) Ashland beginning approximately 133 feet
4 west of Clara and continuing to Blackstone, 4) the 15 foot wide east/west alley in CB 6132 as
5 bounded by Hebert, Clara, Ashland and Blackstone, 5) the 15 foot wide "U" shaped alley in CB
6 4360 as bounded by Natural Bridge, Clara, Hebert/Blackstone and the Terminal Railroad, and 6) the
7 15 foot wide "U" shaped alley in CB 5239 as bounded by Ashland/Blackstone, Clara, Greer and
8 Terminal Railroad in the City of St. Louis, Missouri, as hereinafter described, in accordance with
9 Charter authority, and in conformity with Section 14 of Article XXI of the Charter and imposing
10 certain conditions on such vacation.

11 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

12 **SECTION ONE:** The above surface, surface and sub-surface rights of vehicle, equestrian
13 and pedestrian travel, between the rights-of-way of:

15 A tract of land being part of Mars Place Addition, a Subdivision according to the plat
16 thereof, recorded in Plat Book 22 Page 47, and part of the Resubdivision of Mars
17 Place Addition Lots 27-31 a Subdivision according to the plat thereof, recorded in
18 Survey Record Book 10 Page 1, part of the boundary adjustment of Northern
19 Missionary Baptist Church a Subdivision according to the plat thereof, recorded in
20 Plat Book 12212004 Page 394, and part of consolidated Lots A & B of the Northern
21 Missionary Baptist Church Boundary Adjustment Plat according to the plat thereof,
22 recorded in Plat Book 10272010 Pages 153 & 154 of the St. Louis City Records in
23 City Blocks 4360, 5239 and 6132, City of St. Louis, Missouri and being more
24 particularly described as follows:

26 Beginning at the intersection of the North line of Hebert Street (50
27 feet wide), and the West line of Clara Ave (60 feet wide), also being
28 the Southeast corner of Lot 1 in Block 3 of said Mars Place Addition;

20 are, upon the conditions hereinafter set out, vacated.

21 **SECTION TWO:** Petitioned by Metropolitan St. Louis Sewer District (MSD) and others.
22 Properties to be consolidated for MSD surface detention facility.

23 **SECTION THREE:** All rights of the public in the land bearing rights-of-way traversed by
24 the foregoing conditionally vacated alleys and streets, are reserved to the City of St. Louis for the
25 public including present and future uses of utilities, governmental service entities and franchise
26 holders, except such rights as are specifically abandoned or released herein.

27 **SECTION FOUR:** The owners of the land may, at their election and expense remove the
28 surface pavement of said so vacated alleys and streets provided however, all utilities within the
29 rights-of-way shall not be disturbed or impaired and such work shall be accomplished upon proper
30 City permits.

31 **SECTION FIVE:** The City, utilities, governmental service entities and franchise holders
32 shall have the right and access to go upon the land and occupation hereof within the rights-of-way

1 for purposes associated with the maintenance, construction or planning of existing or future
2 facilities, being careful not to disrupt or disturb the owners interests more than is reasonably
3 required.

4 **SECTION SIX:** The owner(s) shall not place any improvement upon, over or in the area(s)
5 vacated without: 1) lawful permit from the Building Division or Authorized City agency as
6 governed by the Board of Public Service; 2) obtaining written consent of the utilities, governmental
7 service entities and franchise holders, present or future. The written consent with the terms and
8 conditions thereof shall be filed in writing with the Board of Public Service by each of the above
9 agencies as needed and approved by such Board prior to construction.

10 **SECTION SEVEN:** The owners may secure the removal of all or any part of the facilities
11 of a utility, governmental service entity or franchise holder by agreement in writing with such
12 utilities, governmental entity or franchise holder, filed with the Board of Public Service prior to the
13 undertaking of such removal.

14 **SECTION EIGHT:** In the event that granite curbing or cobblestones are removed within
15 the vacated area, the Department of Streets of the City of St. Louis must be notified. Owner(s) must
16 have curbing cobblestones returned to the Department of Streets in good condition.

17 **SECTION NINE:** This ordinance shall be ineffective unless within three hundred sixty
18 (360) days after its approval, or such longer time as is fixed by the Board of Public Service not to
19 exceed three (3) days prior to the affidavit submittal date as specified in the last section of this
20 ordinance, the owner(s) of the area to be vacated must fulfill the following monetary requirements, if
21 applicable, as specified by the City of St. Louis Agencies listed below. All monies received will be
22 deposited by these agencies with the Comptroller of the City of St. Louis.

- 23 1) CITY WATER DIVISION to cover the full expenses of removal and/or relocation of
24 Water facilities, if any.

- 1 2) CITY TRAFFIC AND TRANSPORTATION DIVISION to cover the full expense of
2 removal, relocation and/or purchase of all lighting facilities, if any. All street signs must
3 be returned.
- 4 3) CITY STREET DEPARTMENT to cover the full expenses required for the adjustments
5 of the City's alley(s), sidewalk(s) and street(s) as affected by the vacated area(s) as
6 specified in Sections Two and Eight of the Ordinance.

7 **SECTION TEN:** An affidavit stating that all of the conditions be submitted to the Director
8 of Streets for review of compliance with conditions 2 years from the date of the signing and approval
9 of this ordinance. Once the Director of Streets has verified compliance, the affidavit will be
10 forwarded to the Board of Public Service for acceptance. If this affidavit is not submitted within the
11 prescribed time the ordinance will be null and void.
