

St. Louis City Ordinance 62829

FLOOR SUBSTITUTE

BOARD BILL NO. [92] 320

INTRODUCED BY ALDERMAN SHARON TYUS

An ordinance authorizing and directing the Board of Public Service to let contracts, purchase materials, equipment and supplies, employ labor, hire consultants, pay fees, salaries and wages and do all things necessary to provide for the extension and improvement of the Municipal Water Works System by the installation of approximately eight hundred feet (800') of eight inch (8') , cast iron water pipe in Maffitt Place, from Kingshighway Memorial Boulevard easterly to Euclid Avenue; to appropriate and pay the estimated cost of One Hundred Thousand Dollars (\$100,000.00) from the Water Works Contingent Account, pursuant to Section Twenty-three (23) of Ordinance Number 59597, approved November 20, 1985, containing sections for description of the work approval of plans and specifications, work and material guarantees, estimated expenditures allocation and reversion authorizations, applicable state and federal wage rate requirements, equal opportunity provisions, the Mayor's Executive Orders, contract advertising statutes and a public work emergency clause.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. The Board of Public Service is hereby authorized and directed to let contracts, purchase materials, equipment and supplies, employ and pay for labor, consultants, employees, supervision wages and fringe benefits, pay fees, salaries, and otherwise provide for the design and construction for the extension and improvement of the Municipal Water Works System by the installation of approximately eight hundred feet (800') of eight-inch (8'), cast iron water pipe in Maffitt Place, from Kingshighway Memorial boulevard easterly to Euclid Avenue, in accordance with the plans and specifications approved and adopted by said Board of Public Service.

SECTION TWO. The work provided for herein shall be carried out in accordance with detailed plans and specifications to be adopted and approved by the Board of Public Service before bids are advertised therefore.

SECTION THREE. Any contract, or contracts shall provide that the contractor, or contractors, doing said work shall guarantee and keep in good repair all of

the work and materials used in connection therewith for a term of at least one (1) year, commencing on the date of acceptance of the work by the City.

SECTION FOUR. The sum of One Hundred Thousand Dollars (\$100,000.00) is hereby appropriated and allocated to pay the estimated cost of the work authorized herein from the Water Works Contingent Account, pursuant to Section Twenty-three (23) of Ordinance Number 59597, approved November 20, 1985. All funds remaining in this appropriation and allocation, after the final time of acceptance of the work, shall revert to the same source from which they were appropriated or allocated, after the expiration of any guarantee period.

SECTION FIVE. All construction contracts let under authority of this ordinance shall provide that no less than the prevailing hourly rate of wages be paid in the City of St. Louis, as determined by the Federal Davis-Bacon Act and the Department of Labor and Industrial Relations of the State of Missouri; said prevailing wage shall be paid for each craft or type of workperson needed in the actual construction work of the job herein authorized, as well as the general prevailing rate of pay for legal holidays and overtime work. All labor to be performed under this contract shall be subject to the provisions of Section 290.210 to 290.340 inclusive, of the Revised Statutes of Missouri, 1986 and the charter and Code of the City of St. Louis.

SECTION SIX. The Comptroller of the City of St. Louis shall be and is hereby directed to draw warrants from time to time on the Treasurer of said City for the several payments of the costs specified in Section One hereof.

SECTION SEVEN. All specifications approved by the Board of Public Service and contracts let under authority of this ordinance shall provide for compliance with the Mayor's Executive Orders on Equal Opportunity dated March 25, 1982 and December 4, 1984 and the Mayor's Executive Order of December 22, 1986 on selection of experts and consultants except when superseded or otherwise prohibited by federal or state regulations.

SECTION EIGHT. All advertisement for bids ;pursuant to this Ordinance shall be subject to Section 8.250, of the Revised Statutes of Missouri, 1986.

SECTION NINE. This being an Ordinance providing for public work, or improvements, an emergency is hereby declared to exist within the meaning of Section Twenty (20) of Article Four of the Charter of the City of St. Louis, and shall become effective immediately upon its passage and approval by the Mayor.
