

St. Louis City Ordinance 62931

FLOOR SUBSTITUTE

BOARD BILL NO. [93] 90

INTRODUCED BY ALDERMAN Robert Ruggeri

AN ORDINANCE authorizing and directing the Board of Public Service to let contracts, purchase materials, equipment and supplies, employ labor, hire consultants, pay fees, salaries and wages, and do all things necessary for the improvement of the Municipal Water Works System by the performance of an Engineering Design to modify and improve the Pre-sedimentation Basins at the Chain of Rocks and Howard Bend Water Treatment Plants, appropriating Nine Hundred Fifty Thousand Dollars (\$950,000) from the Water Works Contingent Account pursuant to Section Twenty-three (23) of Ordinance No. 59597 approved November 20, 1985, and containing an emergency clause.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. The Board of Public Service is hereby authorized and directed to let contracts, purchase materials, equipment and supplies, employ labor, hire consultants, pay fees, salaries and wages, and do all things necessary for the improvement of the Municipal Water Works System by Performing an Engineering Design to modify and improve the Pre-sedimentation Basins at the Chain of Rocks and Howard Bend Water Treatment Plants in accordance with a Professional Service Agreement approved and adopted by said Board of Public Service.

SECTION TWO. There is hereby appropriated the sum of Nine Hundred Fifty Thousand Dollars (\$950,000) from the Water Works Contingent Account pursuant to Section Twenty-three (23) of Ordinance No. 59597 approved November 20, 1985 to be expended for the work authorized under Section One of this Ordinance. Any funds appropriated under this Ordinance which remain after the complete and final payment for all work authorized under Section One of this Ordinance shall revert to the Water Works Contingent Account pursuant to Section Twenty-three (23) of Ordinance No. 59597 approved November 20, 1985.

SECTION THREE. The Comptroller of the City of St. Louis shall be and is hereby directed to draw warrants from time to time on the Treasurer of said City for the several payments of the costs specified in Section One hereof.

SECTION FOUR. All contracts let pursuant to this Ordinance shall be subject to Section 290.210 to 290.340 inclusive, of the Revised Statutes of Missouri, 1986, as amended.

SECTION FIVE. This being an Ordinance providing for public work and improvements, and the passage thereof being deemed necessary for the immediate preservation of the public health and safety, an emergency is hereby declared to exist within the meaning of Section 20 of Article IV of the Charter of the City of St. Louis and this Ordinance shall become effective immediately upon its passage and approval by the Mayor.
