

St. Louis City Ordinance 64447

FLOOR SUBSTITUTE

BOARD BILL NO. [98] 106

INTRODUCED BY ALDERMAN ROBERT RUGGERI

An ordinance, recommended and approved by the Airport Commission and the Board of Estimate and Apportionment amending Section One of Ordinance No. 64217 approved December 15, 1997 by adding certain public works and improvement projects that provided for the planning, designing and construction of the new East Terminal and were authorized by City Ordinance No. 61828 approved February 28, 1990, Ordinance No. 62908 approved June 29, 1993, and Ordinance No. 63196 approved July 1, 1994 as amended by Ordinance No. 63669 approved March 12, 1996 to the list of eligible public work and improvement projects listed by ordinance number in Section One of Ordinance No. 64217; and containing an emergency clause.

WHEREAS, The City of St. Louis, Missouri (the "City") owns and operates an airport known as the Lambert - St. Louis International Airport (the "Airport"); and

WHEREAS, Ordinance No. 64217 approved December 15, 1997 appropriated certain funds and authorized the Comptroller of the City of St. Louis (the "City") to transfer such funds from the sub-account of the Series 1997 Airport Construction Account in the Airport Construction Fund designated as the Series 1997 Improvement Project Sub-account (the "Airport Construction Fund") established pursuant to Ordinance No. 64120 approved July 23, 1997 (the "1997 Airport Bond Ordinance") to the Airport Development Fund established pursuant to Ordinance No. 59286, Section 13, approved October 26, 1984 and the Passenger Facility Charge Fund Account established pursuant to Ordinance No. 62501, Section 6, approved February 10, 1992 in such amounts for public work and improvement projects authorized by City ordinances as listed in SECTION ONE of Ordinance No. 64217 and consistent with the terms provided for therein; authorized the Comptroller or the Treasurer of the City to make such applications or certifications and provide such data to the Trustee of the "Series 1997 Bonds" authorized under the 1997 Airport Bond Ordinance and to take whatever actions that may be necessary in order to provide for the transfers authorized herein; and contained an emergency clause.

WHEREAS, it is in the best interest of the operation of the Airport to add certain public works and improvement projects that provided for the planning, designing and construction of the new East Terminal and were authorized by City Ordinance No. 61828 approved February 28, 1990, Ordinance No. 62908 approved June 29, 1993 and Ordinance No. 63196 approved July 1, 1994 as amended by Ordinance No. 63669 approved March 12, 1996 to the list of eligible public work and improvement projects listed by ordinance number in Section One of Ordinance No. 64217.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. Section One of Ordinance No. 64217 approved December 15, 1997 is hereby amended by adding certain public works and improvement projects that provided for the planning, designing and construction of the new East Terminal to the list of eligible public work and improvement project listed by ordinance number as follows:

This being an ordinance providing for a public work and improvement, it is hereby declared to be an emergency measure as defined in Article IV, Section 19 and 20, of the City Charter and shall become effective immediately upon passage and approval by the Mayor of the City of St. Louis.
