

BOARD BILL NO.213 INTRODUCED BY: ALDERWOMAN HEATHER NAVARRO

1 An ordinance pertaining to parking within the "Skinker-Fauquier Parking District;"
2 establishing the location and restrictions for curb parking in the restricted parking zone within
3 the "Skinker-Fauquier Parking District;" authorizing the placement of Permit Parking Only
4 signs within the District; and prohibiting the parking, within the District, of any vehicle which
5 does not display the authorized permit; containing definitions, a penalty clause and an
6 emergency clause.

8 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

9

10 **SECTION ONE.** Definitions.

11 A. The "Skinker-Fauquier Parking District" is defined as follows:

12 The rectangular area comprising of the width of thirty (30) feet of Fauquier
13 Drive as measured from the northern curb of Fauquier Drive toward the
14 southern curb of Fauquier Drive extending along Fauquier Drive from the
15 northwest corner of parcel #58480001500 which has an address of 225 S.
16 Skinker Blvd. extending east to the southeast corner of parcel
17 #58480001500 which has an address of 225 S. Skinker Blvd.; and the
18 rectangular area comprising of the width of eight (8) feet of Skinker Blvd.
19 as measured from the western curb of Skinker Blvd. toward the center of
20 Skinker Blvd. extending along Skinker Blvd. from the southeast corner of
21 parcel #58480001500 which has an address of 225 S. Skinker Blvd

1 extending north to the northeast corner of parcel #58480001500 which has
2 an address of 225 S. Skinker Blvd.

4 B. "Parking permit" is a valid parking permit issued separately for the district
5 by the Traffic and Transportation Administrator of the City of St. Louis or
6 its designees.

7

8 C. "Resident" is a person who lives in a property abutting a restricted parking
9 zone.

10

12 D. "Employee" is any person who is employed at a business abutting a
13 restricted parking zone.

14

15 E. "Restricted parking zone" is either of the two sections and portions of
16 Skinker Boulevard and Fauquier Drive within the District which is
17 designated and posted as a restricted parking zone with specific parking
18 restrictions.

21 F. "Visitor" is any person who is a household guest, a visitor, a worker
22 performing services for, or domestic help for, a resident or employee.

SECTION TWO. Designation of restricted parking zone. The entire Skinker-

3

Fauquier Parking District is hereby established as an independent restricted parking

4

zone.

SECTION THREE. Permit use. Signs are to be erected in the District designating

7

"Permit Parking Only" which state the following restrictions:

For the Skinker-Fauquier Parking District, restricted use of parking with

9

permit only are to be posted and no person, firm or corporation shall park

10

or cause to be parked any vehicle in the restricted parking zone that does

11

not display a valid parking permit for the Fauquier-Skinker Parking

12

District.

SECTION FOUR. Permit issuance. Permits may be issued to employees and

15

residents per the following guidelines:

16

A. For the Skinker-Fauquier Parking District, the Traffic and Transportation

17

Administrator may issue annual parking permits to:

18

(1) employees of business on parcels that abut or are across the

19

street from the district, and

1 (2) residents of parcels that abut or are across the street from the
2 district at a rate of \$0.00 per annum for residents and
3 employees.

4 The Traffic and Transportation Administrator may contract with a Missouri nonprofit
5 corporation at no cost to the City for the procurement, assignment and distribution of
6 said annual parking permits, and the procurement and installation of said signs.

7

8 **SECTION FIVE. Penalty for violation.**

9 A. Any person, firm or corporation who shall park or cause to be parked any
10 vehicle in violation of the provisions of this ordinance shall upon the
11 conviction thereof be fined twenty dollars (\$20.00) for each such offense.

12

13 B. Any person, firm or corporation who shall distribute a standard or visitor
14 parking permit to any person, firm or corporation not authorized to display
15 such parking permit shall have his or her parking permits suspended by the
16 Traffic and Transportation Administrator for a period not to exceed one
17 year.

19 **SECTION SIX. EMERGENCY CLAUSE.** This being an ordinance for the
20 preservation of public peace, health, and safety, it is hereby declared to be an
21 emergency measure within the meaning of Sections 19 and 20 of Article IV of the

1 Charter of the City of St. Louis and therefore shall become effective immediately upon
2 its passage and approval by the
