

1 **BOARD BILL #97** **INTRODUCED BY ALDERMAN JOSEPH RODDY**  
2 AN ORDINANCE RECOMMENDED BY THE BOARD OF ESTIMATE AND  
3 APPORTIONMENT AUTHORIZING AND DIRECTING THE ISSUANCE AND DELIVERY  
4 OF NOT TO EXCEED \$10,000,000 PLUS ISSUANCE COSTS PRINCIPAL AMOUNT OF  
5 TAX INCREMENT REVENUE NOTES (100 N. EUCLID REDEVELOPMENT PROJECT)  
6 SERIES 201\_-A/B, OF THE CITY OF ST. LOUIS, MISSOURI; PRESCRIBING THE FORM  
7 AND DETAILS OF SUCH NOTES AND THE COVENANTS AND AGREEMENTS MADE  
8 BY THE CITY TO FACILITATE AND PROTECT THE PAYMENT THEREOF;  
9 PRESCRIBING OTHER MATTERS RELATING THERETO; AND CONTAINING A  
10 SEVERABILITY CLAUSE.

11 **WHEREAS**, the City of St. Louis, Missouri (the “City”), is a body corporate and  
12 political subdivision of the State of Missouri, duly created, organized and existing under and by  
13 virtue of its charter, the Constitution and laws of the State of Missouri; and

14 **WHEREAS**, the Real Property Tax Increment Allocation Redevelopment Act, Sections  
15 99.800 through 99.865, Revised Statutes of Missouri (the “TIF Act”), authorizes the City to  
16 undertake redevelopment projects within designated areas of the City; and

17 **WHEREAS**, staff and consultants of the City and City Walk on Euclid, L.L.C., a Missouri  
18 limited liability company (the “Developer”), prepared a plan for redevelopment titled “100 N.  
19 Euclid Tax Increment Financing (TIF) Redevelopment Plan” amended May 3, 2013, with further  
20 amendments, if any, and as may be amended from time to time (the “Redevelopment Plan”), for  
21 an area located in City Block 3893 and containing one parcel known as and numbered 100 North  
22 Euclid in the City of St. Louis (the “Redevelopment Area” or “Area”), which Redevelopment

1 Area is more fully described in the Redevelopment Plan, such legal description being attached  
2 hereto and incorporated herein as **Exhibit A**; and

3 **WHEREAS**, on May 22, 2013, the TIF Commission found that completion of the  
4 Redevelopment Project (as hereinafter defined) would provide a substantial and significant  
5 public benefit through the elimination of blighting conditions, the strengthening of the  
6 employment and economic base of the City, increased property values and tax revenues,  
7 stabilization of the Redevelopment Area, facilitation of the economic stability of the City as a  
8 whole, and further found that without the assistance of tax increment financing in accordance  
9 with the TIF Act, the Redevelopment Project is not financially feasible and would not otherwise  
10 be completed; and

11 **WHEREAS**, on or prior to the effective date of this Ordinance, after due consideration of  
12 the TIF Commission’s recommendations and approval by the Board of Aldermen, the Mayor  
13 signed the Approving Ordinance, hereinafter defined, designating the Redevelopment Area as a  
14 “redevelopment area” as provided in the TIF Act, approving the Redevelopment Plan, and  
15 approving the redevelopment project described in the Redevelopment Plan (the “Redevelopment  
16 Project”), adopting tax increment allocation financing within the Redevelopment Area, and  
17 establishing the 100 N. Euclid Special Allocation Fund; and on or prior to the effective date of  
18 this Ordinance, after approval by the Board of Aldermen, the Mayor signed the Authorizing  
19 Ordinance, hereinafter defined authorizing the City to enter into a redevelopment agreement with  
20 Developer; and

21 **WHEREAS**, pursuant to the Redevelopment Plan and Redevelopment Agreement, the  
22 City proposes to finance a portion of the costs of the Redevelopment Project by utilizing tax  
23 increment allocation financing in accordance with the TIF Act; and



1 “qualified institutional buyer” under Rule 144A promulgated under the Securities Act of 1933,  
2 (d) any general business company or enterprise with total assets in excess of \$50,000,000, (e)  
3 any Project Lender, or (f) any governmental entity, agency or instrumentality of the City of St.  
4 Louis.

5 “Approving Ordinance” means Ordinance No. \_\_\_\_\_ [Board Bill No. \_\_\_\_]  
6 designating the Redevelopment Area, approving the Redevelopment Plan, approving the  
7 Redevelopment Project, making certain findings with respect thereto, adopting tax increment  
8 financing within the Redevelopment Area, establishing the Special Allocation Fund, and  
9 authorizing certain related actions by City officials.

10 “Authorized Denominations” means an initial amount of \$100,000 or any integral  
11 multiple of \$1,000 in excess thereof, except with respect to the TIF Note issued upon acceptance  
12 by the City of the final Certificate of Reimbursable Redevelopment Project Costs, which TIF  
13 Note may be issued in any denomination, subject to the limitation on the aggregate Principal  
14 Amount, subject to the limitation provided in **Section 2.1** of this Ordinance.

15 “Authorizing Ordinance” means Ordinance No. \_\_\_\_\_ [ Board Bill No. \_\_\_\_], affirming  
16 adoption of the Redevelopment Plan, Redevelopment Area, and Redevelopment Project,  
17 authorizing execution of a Redevelopment Agreement for the construction of the Redevelopment  
18 Project and making certain findings related thereto.

19 “Available Revenues” means all monies on deposit from time to time (including  
20 investment earnings thereon) in (a) the PILOTS Account; and (b) subject to annual  
21 appropriation, the EATS Account that have been appropriated to the repayment of TIF Notes,  
22 excluding (i) any amount paid under protest until the protest is withdrawn or resolved against the

1 taxpayer or (ii) any sum received by the City which is the subject of a suit or other claim  
2 communicated to the City which suit or claim challenges the collection of such sum.

3 “Bond Counsel” means Armstrong Teasdale LLP, St. Louis, Missouri, or an attorney at  
4 law or a firm of attorneys acceptable to the City of nationally recognized standing in matters  
5 pertaining to the tax-exempt nature of interest on obligations issued by states and their political  
6 subdivisions duly admitted to the practice of law before the highest court of any state of the  
7 United States of America or the District of Columbia.

8 “Certificate of Commencement of Construction” means a document substantially in the  
9 form of Exhibit C to the Redevelopment Agreement, delivered by the Developer to the City in  
10 accordance with the Redevelopment Agreement and evidencing commencement of construction  
11 of the Redevelopment Project.

12 “Certificate of Reimbursable Redevelopment Project Costs” means a document  
13 substantially in the form of Exhibit D to the Redevelopment Agreement provided by the  
14 Developer to the City in accordance with Redevelopment Agreement evidencing Reimbursable  
15 Redevelopment Project Costs incurred by the Developer.

16 “Certificate of Substantial Completion” means a document substantially in the form of  
17 Exhibit E to the Redevelopment Agreement, issued by the Developer to the City in accordance  
18 with the Redevelopment Agreement and evidencing the Developer’s satisfaction of all  
19 obligations and covenants to construct the Redevelopment Project in accordance with the  
20 Redevelopment Plan and the Redevelopment Agreement.

21 “City” means the City of St. Louis, Missouri, a body corporate and political subdivision  
22 duly authorized and existing under its charter and the Constitution and laws of the State of  
23 Missouri.

1           “Debt Service Fund” means the fund by that name created in **Section 4.1** of this  
2 Ordinance.

3           “Debt Service Reserve Fund” means the fund by the name created in **Section 4.1** of this  
4 Ordinance.

5           “Debt Service Reserve Fund Requirement” means that amount as reasonably determined  
6 by the underwriter or placement agent for the TIF Notes, with the reasonable concurrence of the  
7 City’s Financial Advisor. This requirement shall not apply to any TIF Notes initially issued to  
8 Developer or any Related Entity.

9           “Developer” means City Walk on Euclid, L.L.C., a Missouri limited liability company,  
10 duly organized and existing under the laws of the State of Missouri, or its permitted successors  
11 or assigns in interest.

12           “Disclosure Counsel” means Armstrong Teasdale LLP, St. Louis, Missouri, or an  
13 attorney at law or a firm of attorneys acceptable to the City of nationally recognized standing in  
14 matters pertaining to offerings of municipal securities duly admitted to the practice of law before  
15 the highest court of any state of the United States of America or the District of Columbia.

16           “Economic Activity Taxes” or “EATs” shall have the meaning ascribed to such term in  
17 Section 99.805(4) of the TIF Act, excluding any taxes not subject to tax increment financing  
18 pursuant to Missouri law.

19           “EATs Account” means the Economic Activity Tax Account of the Special Allocation  
20 Fund.

21           “Finance Officer” means the Comptroller of the City or her authorized agent.

22           “Issuance Costs” means all costs reasonably incurred by the City in furtherance of the  
23 issuance of TIF Notes, including without limitation, the fees and expenses of financial advisors

1 and consultants, the City’s attorneys (including issuer’s counsel, Disclosure Counsel, and Bond  
2 Counsel), the City’s administrative fees and expenses (including fees and costs of its planning  
3 consultants and the St. Louis Development Corporation), underwriters’ discounts and fees, if  
4 any, the costs of printing any TIF Notes and any official statements relating thereto, the costs of  
5 credit enhancement, if any, capitalized interest, debt service reserves and the fees of any rating  
6 agency rating any TIF Notes.

7 “Issuance Date” means the dated date of the TIF Notes.

8 “Maturity Date” means \_\_\_\_\_, which is the date that is twenty-three (23) years  
9 after the effective date of the Approving Ordinance.

10 “Ordinance” or “Note Ordinance” means this Ordinance as from time to time amended in  
11 accordance with the terms hereof.

12 “Original Purchaser” means the Developer, a Related Entity, a Qualified Institutional  
13 Buyer or a Project Lender; provided, however, that any such Related Entity or Project Lender  
14 shall also qualify as an Approved Investor and shall be designated in writing by the Developer as  
15 the Original Purchaser.

16 “Owner” or “Registered Owner” means, when used with respect to any TIF Note, the  
17 person in whose name such TIF Note is registered.

18 “Payment Date” means, with respect to any TIF Note, each May 1 and November 1,  
19 commencing on the first May 1 or November 1 that immediately succeeds the City’s acceptance  
20 of a Certificate of Substantial Completion for the Redevelopment Project.

21 “Payments in Lieu of Taxes” or “PILOTS” shall have the meaning ascribed to such term  
22 in Section 99.805(11) of the TIF Act.

1           “PILOTs Account” means the Payments in Lieu of Taxes Account of the Special  
2 Allocation Fund.

3           “Project Fund” means the fund by that name created in **Section 4.1** of this Ordinance.

4           “Project Lender” means a commercial bank, savings bank, savings and loan association,  
5 credit union, other financial institution, or governmental or quasi-governmental agency that has  
6 loaned funds to the Developer to be used for construction of the Redevelopment Project and has  
7 secured such loan with a mortgage or security interest in the Redevelopment Project.

8           “Qualified Institutional Buyer” means a “qualified institutional buyer” under Rule 144A  
9 promulgated under the Securities Act of 1933.

10          “Redevelopment Agreement” or “Agreement” means that certain Redevelopment  
11 Agreement dated as of \_\_\_\_\_, 201\_ between, the City and the Developer, as may be  
12 amended from time to time.

13          “Redevelopment Area” means the real property legally described and set forth on **Exhibit**  
14 **A**, attached hereto and incorporated herein by reference.

15          “Redevelopment Plan” means the plan titled “100 N. Euclid TIF Redevelopment Plan”  
16 amended May 3, 2013, as approved by the City pursuant to the Approving Ordinance, as such  
17 plan may from time to time be amended in accordance with the TIF Act.

18          “Redevelopment Project” or “100 N. Euclid Redevelopment Project” means the  
19 redevelopment project as described in Section 6 of the Redevelopment Plan.

20          “Register” or “Note Register” means the books for registration, transfer and exchange of  
21 the TIF Notes kept at the office of the Finance Officer.

1           “Reimbursable Redevelopment Project Costs” means those Redevelopment Project Costs  
2 for which the Developer is eligible for reimbursement in accordance with the TIF Act and in  
3 accordance with the Redevelopment Agreement.

4           “Related Entity” means any party or entity related to the Developer by one of the  
5 relationships described in Section 267(b), Section 707(b)(1)(A) or Section 707(b)(1)(B) of the  
6 Internal Revenue Code of 1986, as amended.

7           “Revenue Fund” means the fund by that name created in **Section 4.1** of this Ordinance.

8           “Series A Account” means the account by that name created in **Section 4.1** of this  
9 Ordinance.

10           “Series A Note(s)” means the [Taxable][Tax-Exempt] Tax Increment Revenue Note (100  
11 N. Euclid Redevelopment Project), Series 201\_-A, issued pursuant to this Ordinance in an  
12 aggregate amount not to exceed \$10,000,000 plus Issuance Costs, in substantially the form set  
13 forth in **Exhibit B**, attached hereto and incorporated herein by reference.

14           “Series B Account” means the account by that name created in **Section 4.1** of this  
15 Ordinance.

16           “Series B Note” means the [Taxable][Tax-Exempt] Tax Increment Revenue Note (100 N.  
17 Euclid Redevelopment Project), Series 201\_-B, issued pursuant to the Note Ordinance in an  
18 aggregate amount not to exceed \$10,000,000 plus Issuance Costs, less the aggregate outstanding  
19 principal amount of the Series A Notes, in substantially the form set forth in **Exhibit B**, attached  
20 hereto and incorporated herein by reference.

21           “Special Allocation Fund” means the City of St. Louis, Missouri, 100 N. Euclid Special  
22 Allocation Fund created by the Approving Ordinance and including the accounts into which TIF

1 Revenues are from time to time deposited in accordance with the TIF Act and this Ordinance,  
2 including a PILOTS Account and an EATS Account.

3 “Taxable TIF Notes” means any TIF Note, the interest on which (in the opinion of Bond  
4 Counsel), is not exempt from federal income taxation.

5 “Tax-Exempt TIF Notes” means any TIF Note, the interest on which (in the opinion of  
6 Bond Counsel), is exempt from federal income taxation.

7 “TIF Notes” means one or more series of not to exceed \$10,000,000 plus Issuance Costs  
8 Tax Increment Revenue Notes (100 N. Euclid Redevelopment Project), Series 201\_-A/B issued  
9 by the City pursuant to and subject to the Redevelopment Agreement and this Ordinance in  
10 substantially the form set forth in **Exhibit B**, attached hereto and incorporated herein by  
11 reference.

12 “TIF Revenues” means: (1) payments in lieu of taxes (as that term is defined in  
13 Section 99.805(11) of the TIF Act), penalties, and interest, attributable to the increase in the  
14 current equalized assessed valuation of each taxable lot, block, tract, or parcel of real property  
15 located within the Redevelopment Area over and above the initial equalized assessed value (as  
16 that term is used and described in Sections 99.845.1 and 99.855.1 of the TIF Act) of each such  
17 unit of property, as paid to the City Treasurer by the City Collector of Revenue during the term  
18 of the Redevelopment Plan and the Redevelopment Project, and (2) subject to annual  
19 appropriation by the Board of Aldermen, fifty percent (50%) of the total additional revenues  
20 from taxes, penalties and interest, which are imposed by the City or other taxing districts (as that  
21 term is defined in Section 99.805(17) of the TIF Act) and which are generated by economic  
22 activities within the Redevelopment Area over the amount of such taxes generated by economic  
23 activities within the Redevelopment Area in the calendar year ending December 31, 2012

1 (subject to annual appropriation by the City as provided in the TIF Act), as defined and described  
2 in Sections 99.805(4) and 99.845 of the TIF Act, but excluding therefrom personal property  
3 taxes, taxes imposed on sales or charges for sleeping rooms paid by transient guests of hotels and  
4 motels, taxes levied pursuant to Section 70.500 of the Revised Statutes of Missouri, as amended,  
5 taxes levied for the purpose of public transportation pursuant to Section 94.660 of the Revised  
6 Statutes of Missouri, as amended, and licenses, fees or special assessments other than payments  
7 in lieu of taxes and penalties and interest thereon, all as provided in Section 99.845 of the TIF  
8 Act. Notwithstanding the foregoing, TIF Revenues shall not include the operating levy for  
9 school purposes imposed by or any sales tax imposed by the Transitional School District of the  
10 City of St. Louis and any other taxes not subject to tax increment financing pursuant to Missouri  
11 law.

12 **Section 1.2 Rules of Construction.** For all purposes of this Ordinance, except as  
13 otherwise expressly provided or unless the context otherwise requires:

14 Words of masculine gender shall be deemed and construed to include correlative words  
15 of the feminine and neuter genders.

16 Words importing the singular number shall include the plural and vice versa and words  
17 importing person shall include firms, associations and limited liability companies, including  
18 public bodies. The headings and captions herein are not a part of this document.

19 Terms used in an accounting context and not otherwise defined shall have the meaning  
20 ascribed to them by generally accepted principles of accounting.

21 Whenever an item or items are listed after the word “including,” such listing is not  
22 intended to be an exhaustive listing that excludes items not listed.



1 applicable rules and regulations of any governmental authority or any usage or requirement of  
2 law with respect thereto.

3 (c) Terms of TIF Notes. The TIF Notes shall mature (subject to redemption  
4 and payment prior to maturity as provided in Article III hereof), on the date that is twenty-three  
5 (23) years after the effective date of the Approving Ordinance. Each TIF Note shall bear interest  
6 at a fixed rate per annum determined on the date that is not less than ten (10) and not more than  
7 sixty (60) business days prior to the scheduled closing date for issuance of the TIF Notes (the  
8 “Pricing Date”) based on the municipal yield curve for general obligation bonds (the “MMD”)   
9 compiled by Municipal Market Data Line ® (or its successors) and published by Thomson  
10 Financial, an operating unit of The Thomson Corporation (or its successors) using the MMD  
11 yield published as of the Issuance Date for general obligation bonds rated “AAA” that mature in  
12 the same year as the TIF Notes, (i) plus four percent (4%) if the interest on such TIF Note, in the  
13 opinion of Bond Counsel, is not exempt from Federal income taxation (the “Taxable Rate”), or  
14 (ii) plus two percent (2%) if the interest on such TIF Note, in the opinion of Bond Counsel, is  
15 exempt from Federal income taxation (the “Tax Exempt Rate”); provided, in no event shall the  
16 interest rate on the TIF Notes exceed ten percent (10%) per annum. All TIF Notes shall have a  
17 stated maturity of the Maturity Date. Interest shall be computed on the basis of a 360-day year  
18 of twelve 30-day months. The TIF Notes shall bear interest from their registration date or from  
19 the most recent Payment Date to which interest has been paid or duly provided for.

20 (d) Denominations. The TIF Notes shall be issuable as fully registered TIF  
21 Notes in Authorized Denominations.

22 (e) Numbering. Unless the City directs otherwise, each series of TIF Notes  
23 shall be numbered from R-1 upward.

1 (f) Dating. The TIF Notes shall be dated as provided in **Section 2.7**, as  
2 evidenced by the Finance Officer's signature on Schedule A to each TIF Note.

3 (g) Evidence of Principal Payments. The payment of principal of the TIF  
4 Notes on each Payment Date shall be noted on the TIF Notes on **Schedule A** thereto. The  
5 original **Schedule A** to the TIF Note shall be held by the Finance Officer in trust, unless  
6 otherwise directed in writing by the Owners thereof. If such **Schedule A** is held by the Finance  
7 Officer, the Finance Officer shall, on each Payment Date, send a revised copy of Schedule A via  
8 facsimile to the Owner. Absent manifest error, the amounts shown on Schedule A held by the  
9 Finance Officer shall be conclusive evidence of the principal amount paid on the TIF Notes.

10 (h) Sale of TIF Notes. When TIF Notes have been executed and authenticated  
11 as required by this Ordinance, the Finance Officer shall hold the TIF Notes in trust or, if directed  
12 in writing by the Owners thereof, deliver the TIF Notes to or upon the order of the Owners  
13 thereof, as provided in paragraph (g) above, but only upon payment to the City of a purchase  
14 price equal to one hundred percent (100%) of the face amount of the TIF Notes, which payment  
15 shall be deemed to have occurred under the circumstances described in **Section 4.5** of this  
16 Ordinance.

17 **Section 2.3 Finance Officer to Serve as Paying Agent and Registrar.** The Finance  
18 Officer or the authorized representative thereof is hereby designated as the paying agent for the  
19 payment of principal of and interest on the TIF Notes and the bond registrar with respect to the  
20 registration, transfer and exchange of the TIF Notes and for allocating and holding funds as  
21 provided herein.

22 **Section 2.4 Security for TIF Notes.** The Series A Notes shall be equally and ratably  
23 secured by Available Revenues. The Series B Notes (the "Subordinate Notes") shall be equally

1 and ratably secured by the Available Revenues on a subordinate basis to the Series A Notes. The  
2 TIF Notes shall be special, limited obligations of the City payable solely from and secured as to  
3 the payment of principal and interest by a pledge of the Available Revenues. The taxing power  
4 of the City is not pledged to the payment of the TIF Notes either as to principal or interest. The  
5 TIF Notes shall not be or constitute a general obligation of the City, nor shall they constitute an  
6 indebtedness of the City within the meaning of any constitutional, statutory or charter provision,  
7 limitation or restriction. No payment of principal or interest on any Subordinate Notes may be  
8 made while any Series A Notes are outstanding. THE OBLIGATIONS OF THE CITY WITH  
9 RESPECT TO THE TIF NOTES SHALL TERMINATE ON THE FIRST TO OCCUR OF THE  
10 FULL PAYMENT AND DISCHARGE OF THE TIF NOTES OR THE MATURITY DATE  
11 (WHETHER OR NOT THE PRINCIPAL AMOUNT OR INTEREST HAS BEEN PAID IN  
12 FULL).

13 **Section 2.5 Method and Place of Payment of TIF Notes.** The principal of and  
14 interest on the TIF Notes shall be payable in any coin or currency which, on the respective dates  
15 of payment thereof, is legal tender for the payment of debts due the United States of America.  
16 Payment shall be made by the Finance Officer as provided in this Note Ordinance and as set  
17 forth in **Exhibit B**. Principal and interest shall be payable by check or draft at the office of the  
18 Finance Officer or by wire transfer to the order of the person in whose name such TIF Note is  
19 registered on the Register on each Payment Date.

20 **Section 2.6 Registration, Transfer and Assignment.** So long as the TIF Notes  
21 remain outstanding, the City shall cause to be kept at the office of the Finance Officer books for  
22 the registration, transfer and exchange of the TIF Notes as herein provided. The TIF Notes when  
23 issued shall be registered in the name of the Original Purchaser thereof on the Register.

1           The TIF Notes and beneficial interest therein may only be purchased by an Original  
2 Purchaser and transferred or assigned to an Approved Investor upon the execution by each  
3 proposed purchaser, transferee or assignee of a letter in substantially the form of **Exhibit C**,  
4 attached hereto and incorporated herein by reference, stating that such Original Purchaser,  
5 transferee or assignee (i) is an Approved Investor and (ii) has sufficient knowledge and  
6 experience in business and financial matters in general, and investments such as the TIF Notes in  
7 particular, to enable the Original Purchaser, transferee or assignee to evaluate the risks involved  
8 in an investment in the TIF Notes. The TIF Notes may be transferred and exchanged only upon  
9 the records of the City. Upon surrender of a TIF Note to the Finance Officer, the Finance Officer  
10 shall transfer or exchange the TIF Notes for a new TIF Note or TIF Notes, which shall be (i) in  
11 the form of fully registered Notes without coupons in minimum denominations of One Thousand  
12 Dollars (\$1,000), except with respect to the TIF Notes issued upon acceptance by the City of the  
13 final Certificate of Reimbursable Redevelopment Project Costs, which TIF Notes may be issued  
14 in any denomination, subject to the limitation on the aggregate principal amount, and (ii) of the  
15 same Maturity Date and in the same aggregate principal amount outstanding as the TIF Note  
16 which was presented for transfer or exchange. The TIF Notes presented for transfer or exchange  
17 shall be accompanied by a written instrument or instruments of transfer or authorization for  
18 exchange, in a form and with guarantee of signature satisfactory to the Finance Officer, duly  
19 executed by the Owner thereof or by the Owner's duly authorized agent. Upon any transfer,  
20 exchange or assignment as provided in this Section, the transferor shall reimburse the City for all  
21 of the reasonable out-of-pocket costs incurred by the City in connection with the administration  
22 of such transfer, exchange or assignment. The Finance Officer may execute on behalf of the City  
23 from time to time consents and administrative agreements with the Owners and their Project

1 Lenders or other holders of beneficial interests in the Project or the TIF Notes regarding  
2 collateral assignment, transfer, and payment of the TIF Notes.

3       **Section 2.7 Execution, Authentication and Delivery of the TIF Notes.** Each of the  
4 TIF Notes, including any TIF Notes issued in exchange or as substitution for the TIF Notes  
5 initially delivered, shall be signed by the manual or facsimile signature of the Mayor and the  
6 Finance Officer of the City, attested by the manual or facsimile signature of the City Register,  
7 and shall have the official seal of the City affixed thereto or imprinted thereon. If any officer  
8 whose signature appears on any TIF Note ceases to be such officer before the delivery of such  
9 TIF Note, such signature shall nevertheless be valid and sufficient for all purposes, the same as if  
10 such person had remained in office until delivery. Any TIF Note may be signed by such persons  
11 who at the actual time of the execution of such TIF Note are the proper officers to sign such TIF  
12 Note although at the date of such TIF Note such persons may not have been such officers.

13       The Mayor, Finance Officer and City Register are hereby authorized and directed to  
14 prepare and execute the TIF Notes as hereinbefore specified, and when duly executed, to deliver  
15 the TIF Notes to the Finance Officer for authentication.

16       The TIF Notes shall have endorsed thereon a certificate of authentication substantially in  
17 the form set forth in **Schedule A** of **Exhibit B** hereto, which shall be manually executed by an  
18 authorized signatory of the Finance Officer, but it shall not be necessary that the same signatory  
19 sign the certificate of authentication on all of the TIF Notes that may be issued hereunder at any  
20 one time. No TIF Note shall be entitled to any security or benefit under this Ordinance or be  
21 valid or obligatory for any purpose until the certificate of authentication has been duly executed  
22 by the Finance Officer. Such executed certificate of authentication upon any TIF Note shall be

1 conclusive evidence that such TIF Note has been duly authenticated and delivered under this  
2 Ordinance.

3         The TIF Notes shall be initially executed and authenticated by the City upon the last to  
4 occur of the following: (i) acceptance or deemed acceptance of the Certificate of Substantial  
5 Completion; (ii) approval of a Certificate of Reimbursable Redevelopment Project Costs; (iii)  
6 receipt of an opinion of Bond Counsel regarding the taxable nature of the TIF Notes; (iv) the full  
7 payment of all advances required to be paid under Section 2.2 of the Redevelopment Agreement;  
8 (v) receipt of such other documentation as the City shall reasonably require of Developer and  
9 any Original Purchaser, in order for the City to obtain an opinion of Bond Counsel as required by  
10 this Section 5.1 of the Redevelopment Agreement; (vi) the completion of Section 4.3 of the  
11 Redevelopment Agreement and (vii) determination of the size of the TIF Notes.

12         TIF Notes shall either be held or delivered to or upon the order of the party submitting  
13 the Certificate of Reimbursable Redevelopment Project Costs relating to such Notes. Upon  
14 acceptance by the City of such a Certificate of Reimbursable Redevelopment Project Costs in  
15 accordance with the Redevelopment Agreement and upon execution and authentication of the  
16 TIF Notes as required by this Ordinance, the Developer shall be deemed to have advanced funds  
17 to the City in an amount equal to the purchase price of the TIF Notes, which shall be one  
18 hundred percent (100%) of the face amount of the TIF Notes, and, upon the issuance of an  
19 endorsement of the TIF Notes as provided in the preceding paragraph, the City shall be deemed  
20 to have reimbursed the Developer in full for such Reimbursable Redevelopment Project Costs.

21         **Section 2.8 Mutilated, Lost and Stolen TIF Notes.** If any mutilated TIF Note is  
22 surrendered to the Finance Officer or the Finance Officer receives evidence to his/her  
23 satisfaction of the destruction, loss or theft of any TIF Note and there is delivered to the Finance

1 Officer such security or indemnity as may be required by it to save the City and the Finance  
2 Officer harmless, then, in the absence of notice to the Finance Officer that such TIF Note has  
3 been acquired by a bona fide purchaser, the City shall execute and the Finance Officer shall  
4 register and deliver, in exchange for or in lieu of any such mutilated, destroyed, lost or stolen TIF  
5 Note, a new TIF Note with the same Maturity Date and of like tenor and principal amount. Upon  
6 the issuance of any new TIF Note under this Section, the City and the Finance Officer may  
7 require the payment by the Owner of a sum sufficient to cover any tax or other governmental  
8 charge that may be imposed in relation thereto and any other expenses connected therewith. If  
9 any such mutilated, destroyed, lost or stolen TIF Note has become or is about to become due and  
10 payable, the Finance Officer may, in its discretion, pay such TIF Note instead of issuing a new  
11 TIF Note.

12 **Section 2.9 Cancellation, Discharge and Abatement of TIF Notes.** All TIF Notes  
13 that have been paid or redeemed or that otherwise have been surrendered to the Finance Officer,  
14 either at or before the Maturity Date, shall be canceled and destroyed by the Finance Officer in  
15 accordance with existing security regulations upon the payment or redemption of such TIF Note  
16 and the surrender thereof to the Finance Officer. The Finance Officer shall execute a certificate  
17 in duplicate describing the TIF Notes so cancelled and destroyed, and shall file an executed  
18 counterpart of such certificate with the City.

19 **ARTICLE III**

20

21 **REDEMPTION AND PAYMENT OF PRINCIPAL AND INTEREST**

22 **Section 3.1 Optional Redemption.** The TIF Notes are subject to optional redemption  
23 by the City in whole at any time or in part on any Payment Date at a redemption price of 100%

1 of the principal amount of the TIF Note to be redeemed, plus accrued interest thereon to the date  
2 fixed for redemption. The TIF Notes shall be called by the City for optional redemption  
3 pursuant to this Section without the necessity of any action by the City other than as provided in  
4 **Section 4.3** of this Ordinance. No Subordinate Notes may be redeemed while any Series A  
5 Notes are outstanding. If only a partial redemption is to occur, then each TIF Note shall be  
6 selected for redemption in accordance with **Section 3.3** hereof. In the event of an optional  
7 redemption of the Notes, unless waived by any Registered Owner of Notes to be redeemed,  
8 official notice of any redemption shall be given by the Finance Officer on behalf of the City by  
9 mailing a copy of an official redemption notice by first class mail, postage prepaid, at least thirty  
10 (30) days (five days if all of the Notes are owned by the Developer) and not more than sixty (60)  
11 days prior to the date fixed for redemption, to each Registered Owner of the Notes to be  
12 redeemed at the address shown on the Note Register.

13 All official notices of optional redemption shall be dated and shall contain the following  
14 information: (a) the redemption date; (b) the redemption price; (c) if less than all outstanding  
15 Notes are to be redeemed, the identification number and maturity date(s) (and, in the case of  
16 partial redemption of any Notes, the respective principal amounts) of the Notes to be redeemed;  
17 (d) a statement that on the redemption date the redemption price will become due and payable  
18 upon each Note or portion thereof called for redemption and that interest thereon shall cease to  
19 accrue from and after the redemption date; and (e) the place where such Notes are to be  
20 surrendered for payment of the redemption price, which shall be the office of the Finance  
21 Officer. The failure of any Registered Owner to receive notice given as heretofore provided or  
22 an immaterial defect therein shall not invalidate any redemption.

1           **Section 3.2 Special Mandatory Redemption.** All TIF Notes are subject to special  
2 mandatory redemption by the City on each Payment Date, at a redemption price equal to 100%  
3 of the principal amount being redeemed, together with accrued interest thereon to the date fixed  
4 for redemption, which amount of principal being redeemed shall be an amount equal to  
5 Available Revenues then on deposit in the applicable account of the Special Allocation Fund and  
6 which will not be required for the payment of interest on such Payment Date. No Subordinate  
7 Notes may be redeemed while any Series A Notes are outstanding.

8           In the event of a special mandatory redemption of any Notes with a Registered Owner  
9 other than Developer or a Related Entity, unless waived by such Registered Owner of Notes to  
10 be redeemed, official notice of any redemption shall be given by the Finance Officer on behalf of  
11 the City by mailing a copy of an official redemption notice by first class mail, postage prepaid, at  
12 least thirty (30) days and not more than sixty (60) days prior to the date fixed for redemption, to  
13 each Registered Owner other than Developer or a Related Entity of the Notes to be redeemed at  
14 the address shown on the Note Register.

15           **Section 3.3 Selection of Notes to be Redeemed.** TIF Notes shall be redeemed only in  
16 Authorized Denominations. When less than all of the outstanding TIF Notes are to be redeemed  
17 and paid prior to maturity, such TIF Notes or portions of TIF Notes from within the same Series  
18 to be redeemed shall be redeemed pro-rata in accordance with their then-outstanding principal  
19 and interest balances, rounded to the nearest Authorized Denomination. However, no  
20 Subordinate Notes may be redeemed while any Series A Notes are outstanding. In the case of a  
21 partial redemption of TIF Notes from within the same Series when TIF Notes of denominations  
22 greater than the minimum Authorized Denomination are then outstanding, then for all purposes  
23 in connection with such redemption each Authorized Denomination unit of face value shall be

1 treated as though it was a separate TIF Note of the denomination of the minimum Authorized  
2 Denomination.

3 **Section 3.4 Notice and Effect of Call for Redemption.** In the event of any optional  
4 or special mandatory redemption of the Notes, unless waived by any Registered Owner of Notes  
5 to be redeemed, official notice of any redemption shall be given by the Finance Officer on behalf  
6 of the City by mailing a copy of an official redemption notice by first class mail to each  
7 Registered Owner of the Notes to be redeemed at the address shown on the Note Register.

8 All official notices of redemption shall be dated and shall contain the following  
9 information:

10 (a) the redemption date;

11 (b) the redemption price;

12 (c) if less than all outstanding Notes are to be redeemed, the identification  
13 (and, in the case of partial redemption of any Notes, the respective principal amounts) of the  
14 Notes to be redeemed;

15 (d) a statement that on the redemption date the redemption price will become  
16 due and payable upon each Note or portion thereof called for redemption and that interest  
17 thereon shall cease to accrue from and after the redemption date; and

18 (e) the place where such Notes are to be surrendered for payment of the  
19 redemption price, which shall be the office of the Finance Officer.

20 The failure of any Registered Owner to receive notice given as heretofore provided or an  
21 immaterial defect therein shall not invalidate any redemption. All Notes that have been  
22 redeemed shall be cancelled and destroyed by the Finance Officer as provided herein and shall  
23 not be reissued.

1 **ARTICLE IV**

2  
3 **FUNDS AND REVENUES**

4 **Section 4.1 Creation of Funds and Accounts.** There are hereby created or ratified  
5 and ordered to be established in the treasury of the City:

6 (a) the Special Allocation Fund into which all TIF Revenues shall be deposited, and  
7 within it, the following separate funds and accounts:

8 (1) a PILOTS Account;

9 (2) an EATS Account;

10 (3) a Revenue Fund into which all Available Revenues shall be deposited,  
11 from time to time, five (5) days prior to each Payment Date, and, within it, (A) a  
12 RF PILOTs Account; and (B) an RF EATS Account;

13 (4) a Debt Service Fund, and, within it, (i) a Series A Account; and (ii) a  
14 Series B Account; and

15 (5) a Debt Service Reserve Fund, if established on the Issuance Date; and

16 (b) a Project Fund.

17 **Section 4.2 Administration of Funds and Accounts.** The Special Allocation Fund  
18 and the funds and accounts established therein shall be maintained in the treasury of the City and  
19 administered by the City solely for the purposes and in the manner as provided in the TIF Act,  
20 this Ordinance, the Approving Ordinance, and the Authorizing Ordinance so long as any TIF  
21 Notes remain outstanding hereunder.

22 **Section 4.3 Revenue Fund.**

1 (a) On or before the date that is five (5) days prior to each Payment Date  
2 while the TIF Notes remain outstanding, the City shall transfer and deposit:

3 (i) Those Available Revenues attributable to PILOTs from the  
4 PILOTs Account of the Special Allocation Fund into the RF PILOTs  
5 Account of the Revenue Fund; and

6 (ii) Those Available Revenues attributable to EATs from the EATs  
7 Account of the Special Allocation Fund into the RF EATs Account of the  
8 Revenue Fund.

9 (b) Available Revenues in the Revenue Fund shall be applied, first from the  
10 RF EATs Account and second from the RF PILOTs Account for the purposes and in the  
11 amounts as follows:

12 *First*, to payment of arbitrage rebate, if any, owed with respect to the TIF Notes under  
13 Section 148 of the Internal Revenue Code of 1986, as amended, including any costs of  
14 calculating arbitrage rebate;

15 *Second*, to the Finance Officer of the City and the St. Louis Development Corporation  
16 (which monies shall be paid one half to the Finance Officer and one half to the St. Louis  
17 Development Corporation), 0.2% of the Notes outstanding on each Payment Date, plus any  
18 accumulated deficiency from previous years, plus an amount sufficient to pay all or any portion  
19 of the fees and expenses incurred by the City pursuant to Section 7.15 of the Agreement that  
20 have not otherwise been reimbursed to the City through the issuance of TIF Notes;

21 *Third*, to Series A Account of the Debt Service Fund, an amount sufficient to pay all or  
22 any portion of the past due interest owing as a result of prior deficiencies of moneys to pay  
23 interest due on any Series A Notes on each Payment Date;

1           *Fourth*, to the Series A Account of the Debt Service Fund, an amount sufficient to pay all  
2 or any portion of the accrued interest becoming due and payable on any Series A Notes on each  
3 Payment Date;

4           *Fifth*, to the Series A Account of the Debt Service Fund, an amount sufficient to pay the  
5 interest on the Series A Notes on the next succeeding Payment Date;

6           *Sixth*, for transfer to the Debt Service Reserve Fund, if established, such amount as may  
7 be required to restore any deficiency in the Debt Service Reserve Fund if the amount on deposit  
8 in the Debt Service Reserve Fund is less than the Debt Service Reserve Requirement;

9           *Seventh*, to the Series A Account of the Debt Service Fund, an amount sufficient to pay  
10 the principal of any Series A Notes that are subject to redemption pursuant to the Note Ordinance  
11 on each Payment Date;

12           *Eighth*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service  
13 Fund, an amount sufficient to pay all or any portion of the past due interest owing as a result of  
14 prior deficiencies of moneys to pay interest due on the Series B Note on each Payment Date;

15           *Ninth*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service  
16 Fund, an amount sufficient to pay all or any portion of the accrued interest becoming due and  
17 payable on any Series B Note on each Payment Date;

18           *Tenth*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service  
19 Fund, an amount sufficient to pay the interest on the Series B Notes on the next succeeding  
20 Payment Date;

21           *Eleventh*, if no Series A Notes are outstanding, to the Series B Account of the Debt  
22 Service Fund, an amount sufficient to pay the principal of any Series B Note that is subject to  
23 redemption pursuant to this Note Ordinance on each Payment Date; and

1           *Twelfth*, all other remaining money in the Revenue Fund shall annually be declared as  
2 surplus and distributed in the manner provided in the TIF Act, as applicable.

3           If monies available in the Special Allocation Fund are insufficient to reimburse the City  
4 as provided above on any Payment Date, then the unpaid portion shall be carried forward to the  
5 next Payment Date, with interest thereon at the same rate as the Series A Notes.

6           (c)     Upon the payment in full of the principal of and interest on all TIF Notes  
7 (or provision has been made for the payment thereof as specified in the Note Ordinance),  
8 payment in full of the fees and expenses of the Finance Officer and the St. Louis Development  
9 Corporation, and payment in full of any other amounts required to be paid under this Ordinance,  
10 all amounts remaining on deposit in the Special Allocation Fund shall be declared as surplus and  
11 distributed in the manner provided in the TIF Act.

12           **Section 4.4   Debt Service Fund.**

13           (a)     All amounts paid and credited to the Debt Service Fund shall be expended  
14 solely for (i) the payment of the principal of and interest on the TIF Notes as the same mature  
15 and become due or upon the redemption thereof, said TIF Notes all being subject to special  
16 mandatory redemption thereof, or (ii) to purchase Notes for cancellation prior to maturity.

17           (b)     The City hereby authorizes and directs the Finance Officer to withdraw  
18 sufficient moneys from the Debt Service Fund to pay the principal of and interest on the TIF  
19 Notes as the same become due and payable, and to make said moneys so withdrawn available for  
20 the purpose of paying said principal of and interest on the TIF Notes.

21           (c)     After payment in full of the principal of and interest on the TIF Notes (or  
22 provision has been made for the payment thereof as specified in this Ordinance), payment of the  
23 fees and expenses of the Finance Officer, and payment of any other amounts required to be paid

1 under this Ordinance, all amounts remaining in the Debt Service Fund shall be declared as  
2 surplus and distributed in the manner provided in the TIF Act.

3 **Section 4.5 Project Fund.** Upon acceptance by the City of a Certificate of  
4 Reimbursable Redevelopment Project Costs and the issuance or endorsement of a TIF Note  
5 pursuant to **Section 2.7** of this Ordinance, the Developer shall be deemed to have advanced  
6 funds necessary to purchase such TIF Note and the City shall be deemed to have deposited such  
7 funds in the Project Fund and shall be deemed to have reimbursed the Developer or paid for in  
8 full for such costs from the amounts deemed to be on deposit in the Project Fund.

9 **Section 4.6 Debt Service Reserve Fund.** No Debt Service Reserve Fund shall be  
10 required for any TIF Notes originally issued to Developer or a Related Entity. Except as herein  
11 otherwise provided, funds on deposit in the Debt Service Reserve Fund shall be used and applied  
12 by the Finance Officer solely to prevent a default in the event moneys on deposit in the Debt  
13 Service Fund shall be insufficient to pay the principal of and interest on the Series A Notes as the  
14 same become due. The Finance Officer may disburse and expend moneys from the Debt Service  
15 Reserve Fund whether or not the amount therein equals the Debt Service Reserve Fund  
16 Requirement. Moneys on deposit in the Debt Service Reserve Fund may be used to pay Series A  
17 Notes called for redemption or to purchase Series A Notes in the open market, prior to the  
18 Maturity Date, provided all Notes at the time outstanding are called for redemption or purchased  
19 and sufficient funds are available therefore. Moneys on deposit in the Debt Service Reserve  
20 Fund shall be used to pay and retire the Series A Notes last becoming due, unless such Notes and  
21 all interest thereon are otherwise paid.

22 So long as the sum on deposit in the Debt Service Reserve Fund shall aggregate an  
23 amount equal to the Debt Service Reserve Fund Requirement, investment earnings on funds on

1 deposit in the Debt Service Reserve Fund shall be deposited into the Series A Account of the  
2 Debt Service Fund; provided, however, that if no Series A Notes are then outstanding, such  
3 investment earnings shall be deposited into the Series B Account of the Debt Service Fund. If  
4 the sum on deposit in the Debt Service Reserve Fund shall be less than the Debt Service Reserve  
5 Fund Requirement, investment earnings on funds in the Debt Service Reserve Fund shall remain  
6 therein and be applied to reducing such deficiency.

7 So long as the sum on deposit in the Debt Service Reserve Fund shall aggregate an  
8 amount equal to the Debt Service Reserve Fund Requirement on each Payment Date, no further  
9 deposits to said Debt Service Reserve Fund shall be required. Investments and moneys in the  
10 Debt Service Reserve Fund shall be valued at the market value thereof, exclusive of accrued  
11 interest, by the Finance Officer on and the amount on deposit therein determined accordingly.

12 (a) After payment in full of the principal of, premium, if any, and  
13 interest on the Notes (or provision has been made for the payment thereof as specified in the  
14 Ordinance), the fees, charges and expenses of the Finance Officer and any Paying Agent and any  
15 other amounts required to be paid under the Ordinance or any other instrument entered into with  
16 respect to the Notes, all amounts remaining in the Debt Service Reserve Fund shall be declared  
17 as surplus and distributed in the manner provided in the TIF Act.

18 **Section 4.7 Nonpresentment of Notes.** If any TIF Note is not presented for payment  
19 when the principal thereof becomes due at stated maturity or prior redemption date, if funds  
20 sufficient to pay such TIF Note have been made available to the Finance Officer, all liability of  
21 the City to the Registered Owner thereof for the payment of such TIF Note shall forthwith cease,  
22 determine and be completely discharged, and thereupon it shall be the duty of the Finance  
23 Officer to hold such funds, without liability for interest thereon, for the benefit of the Registered

1 Owner of such TIF Note, who shall thereafter be restricted exclusively to such funds for any  
2 claim of whatever nature on his part under this Ordinance or on, or with respect to, said TIF  
3 Note. If any TIF Note is not presented for payment within five (5) years following the date when  
4 such TIF Note becomes due at maturity, the Finance Officer shall repay to the City the funds  
5 theretofore held by it for payment of such TIF Note, and such TIF Note shall, subject to the  
6 defense of any applicable statute of limitation, thereafter be an unsecured obligation of the City,  
7 and the Registered Owner thereof shall be entitled to look only to the City for payment, and then  
8 only to the extent of the amount so repaid to it by the Finance Officer, and the City shall not be  
9 liable for any interest thereon and shall not be regarded as a Finance Officer of such money.

10 **ARTICLE V**

11  
12 **REMEDIES**

13 **Section 5.1 Remedies.** The provisions of this Ordinance, including the covenants and  
14 agreements herein contained, shall constitute a contract between the City and the Owner. The  
15 Owner shall have the right:

16 (a) by mandamus or other suit, action or proceedings at law or in equity to  
17 enforce the rights of the Owner against the City and its officers, agents and employees, and to  
18 require and compel duties and obligations required by the provisions of this Ordinance or by the  
19 constitution and laws of the State of Missouri;

20 (b) by suit, action or other proceedings in equity or at law to require the City,  
21 its officers, agents and employees to account as if they were the trustees of an express trust; and

22 (c) by suit, action or other proceedings in equity or at law to enjoin any acts or  
23 things which may be unlawful or in violation of the rights of the Owner.





1 extent within its power or discretion) and the Developer shall not use or permit the use of any  
2 proceeds of the Tax Exempt TIF Note, and shall not take or permit to be taken any other action  
3 or actions, which would result in the Tax Exempt TIF Note being treated as other than an  
4 obligation described in Section 103(a) of the Code. The City (to the extent within its power or  
5 discretion) and the Developer shall not use any portion of the proceeds of the Tax Exempt TIF  
6 Note, including any investment income earned on such proceeds, in any manner that would cause  
7 the Tax Exempt TIF Note to be a “private activity bond” within the meaning of Section 141(a) of  
8 the Code. The officers of the City, including the Mayor, the Finance Officer and the City  
9 Register, shall be, and they hereby are, authorized and directed to execute all documents and take  
10 such actions as they may deem necessary or advisable in order to carry out and perform the  
11 purposes of this Section.

12           **Section 7.3    Payments Due on Saturdays, Sundays and Holidays.** In any case where  
13 the Payment Date is a Saturday, a Sunday or a legal holiday or other day that is not a business  
14 day, then payment of principal or interest need not be made on such date but may be made on the  
15 next succeeding business day with the same force and effect as if made on the Payment Date, and  
16 no interest shall accrue for the period after such date.

17           **Section 7.4    Notices, Consents and Other Instruments.** Any notice, consent, request,  
18 direction, approval, objection or other instrument required by this Ordinance to be signed and  
19 executed by the Owner of the TIF Notes may be in any number of concurrent writings of similar  
20 tenor and may be signed or executed by such Owner in person or by agent appointed in writing.  
21 Proof of the execution of any such instrument or of the writing appointing any such agent and of  
22 the ownership of the TIF Note, if made in the following manner, shall be sufficient for any of the

1 purposes of the Ordinance, and shall be conclusive in favor of the City with regard to any action  
2 taken, suffered or omitted under any such instrument, namely:

3 (a) The fact and date of the execution by any person of any such instrument  
4 may be proved by a certificate of any officer in any jurisdiction who by law has power to take  
5 acknowledgments within such jurisdiction that the person signing such instrument acknowledged  
6 before such officer the execution thereof, or by affidavit of any witness to such execution.

7 (b) The fact of ownership of the TIF Note, the amount or amounts and other  
8 identification of the TIF Note, and the date of holding the same shall be proved by the  
9 registration books of the City.

10 **Section 7.5 Execution of Documents; Further Authority.** The City is hereby  
11 authorized to enter into and the Mayor and the Finance Officer of the City are hereby authorized  
12 and directed to execute and deliver, for and on behalf of and as the act and deed of the City, the  
13 TIF Notes and such other documents, certificates and instruments as may be necessary or  
14 desirable to carry out and comply with the intent of this Ordinance. The officers of the City,  
15 including without limitation the Mayor, the Finance Officer and the Register, are hereby  
16 authorized and directed to execute, and the City Register is hereby authorized and directed where  
17 appropriate to attest, all certificates, documents or other instruments, and take such actions as  
18 they may deem necessary or advisable in order to carry out and perform the purposes of this  
19 Ordinance and to make ministerial alterations, changes or additions in the foregoing agreements,  
20 statements, instrument and other documents herein approved, authorized and confirmed which  
21 they determine to be in the City's best interest, and the execution or taking of such action shall  
22 be conclusive evidence of such determination.

1           **Section 7.6 Severability.** If any section or other part of this Ordinance, whether large  
2 or small, is for any reason held invalid, the invalidity thereof shall not affect the validity of the  
3 other provisions of this Ordinance.

4           **Section 7.7 Governing Law.** This Ordinance shall be governed exclusively by and  
5 constructed in accordance with the applicable internal laws of the State of Missouri.

6           **Section 7.8 Private Sale.** The Board of Aldermen of the City hereby declares that it is  
7 in the City’s best interest to sell the TIF Notes at private sale because a public sale of the TIF  
8 Notes would cause additional expense to the City and because the condition of the current  
9 financial markets makes such a public sale not feasible or the best course of action for the City.

10           **Section 7.9 Termination.** After adoption of this Ordinance by the Board of  
11 Aldermen, this Ordinance shall become effective on the 30<sup>th</sup> day after its approval by the Mayor  
12 or adoption over his veto; provided that if, within ninety (90) days after the effective date of the  
13 Authorizing Ordinance, the Developer has not (i) executed the Redevelopment Agreement  
14 pertaining to the Redevelopment Project and (ii) paid all fees due to the City in accordance with  
15 the terms of the Redevelopment Agreement, the provisions of this Ordinance shall be deemed  
16 null and void and of no effect and all rights conferred by this Ordinance on Developer, shall  
17 terminate, provided further, however, that prior to any such termination the Developer may seek  
18 an extension of time in which to execute the Redevelopment Agreement, which extension may  
19 be granted in the sole discretion of the Board of Estimate and Apportionment of the City of St.  
20 Louis.

R. Grimes Consulting Engineers, Inc.

REFERENCE IS MADE TO THE NOTE ORDINANCE FOR A COMPLETE DESCRIPTION OF THE CITY’S OBLIGATIONS HEREUNDER.**

Subject to the preceding paragraph, the principal of and interest on this TIF Note shall be paid at maturity or upon earlier redemption as provided in Article III of the Note Ordinance to the person in whose name this TIF Note is registered at the maturity or redemption date hereof, upon presentation and surrender of this TIF Note at the payment office of the Finance Officer of the City or her authorized agent (the “Finance Officer”). The principal of and interest on the TIF Notes shall be payable in any coin or currency of the United States of America which, at the respective dates of payment thereof, is legal tender for the payment of debts due the United States of America. The principal of or interest on this TIF Note shall be payable by check or draft or by wire transfer to the person in whose name this TIF Note is registered at the office of the Finance Officer to the Registered Owner on the Register on each Payment Date. Except as otherwise provided in Section 2.8 of the Note Ordinance with respect to mutilated, destroyed, lost or stolen TIF Notes, no principal on the TIF Notes is payable unless the Registered Owner thereof has surrendered such TIF Notes at the office of the Finance Officer.

This TIF Note is one of an authorized series of fully registered Notes of the City designated “City of St. Louis, Missouri, [Taxable][Tax-Exempt] Tax Increment Revenue Notes (100 N. Euclid Redevelopment Project), Series 2010\_-A/B,” issued in an aggregate principal amount of not to exceed \$10,000,000 plus Issuance Costs (the “TIF Notes” or “Notes”). The TIF Notes are being issued for the purpose of paying a portion of the Redevelopment Project Costs in connection with the Redevelopment Plan, under the authority of and in full compliance with the Constitution and laws of the State of Missouri, including particularly the Real Property Tax Increment Allocation Redevelopment Act, Sections 99.800 to 99.865, of the Revised Statutes of Missouri, as amended (the “Act”), and pursuant to the Note Ordinance.

The TIF Notes and the interest thereon are and shall be special, limited obligations of the City payable solely from and secured as to the payment of principal and interest, by the Available Revenues and other moneys pledged thereto and held by the Finance Officer as provided herein. “Available Revenues” means all monies on deposit from time to time (including investment earnings thereon) in (a) the PILOTS Account; and (b) subject to annual appropriation, the EATS Account that have been appropriated to the repayment of TIF Notes, excluding (i) any amount paid under protest until the protest is withdrawn or resolved against the

taxpayer or (ii) any sum received by the City which is the subject of a suit or other claim communicated to the City which suit or claim challenges the collection of such sum.

The monies on deposit in the PILOTs Account of the Special Allocation Fund are those payments in lieu of taxes (“PILOTs”), as defined in Sections 99.805(11) and 99.845 of the TIF Act) attributable to the increase in the current equalized assessed valuation of each taxable lot, block, tract or parcel of real property in the Redevelopment Area (as described in Exhibit A to the Note Ordinance) and any applicable penalty and interest over and above the initial equalized assessed value (as provided for by Section 99.855 of the TIF Act) of such unit of property in the Redevelopment Area, as allocated and paid to the City’s Treasurer by the City’s Collector of Revenue who shall deposit such PILOTs into the Special Allocation Fund while tax increment financing remains in effect.

The monies on deposit in the EATs Account of the Special Allocation Fund are those amounts subject to annual appropriation by the Board of Aldermen, equal to fifty percent (50%) of the total additional revenues from taxes, penalties and interest which are imposed by the City or other taxing districts (as that term is defined in Section 99.805(17) of the TIF Act) and which are generated by economic activities within the Redevelopment Area over the amount of such taxes generated by economic activities within the Redevelopment Area in the calendar year ending December 31, 2012 (subject to annual appropriation by the City as provided in the TIF Act), while tax increment financing remains in effect, but excluding personal property taxes, taxes imposed on sales or charges for sleeping rooms paid by transient guests of hotels and motels, licenses, fees or special assessments other than payments in lieu of taxes and penalties and interest thereon, taxes levied pursuant to Section 70.500 of the Revised Statutes of Missouri, as amended, and taxes levied for the purpose of public transportation pursuant to Section 94.660 of the Revised Statutes of Missouri, as amended, all in accordance with Section 99.845.3 of the TIF Act, as may be amended from time to time. Notwithstanding the foregoing, TIF Revenues shall not include the operating levy for school purposes imposed by or any sales tax imposed by the Transitional School District of the City of St. Louis.

The Series A Notes shall be equally and ratably secured by Available Revenues. The Series B Notes shall be equally and ratably secured by the Available Revenues on a subordinate basis to the Series A Notes. The TIF Notes shall be special, limited obligations of the City payable solely from and secured as to the payment of principal and interest by a pledge of the Available Revenues. The taxing power of the City is not pledged to the payment of the TIF Notes either as to principal or interest. The TIF Notes shall not be or constitute a general obligation of the City, nor shall they constitute an indebtedness of the City within the meaning of any constitutional, statutory or charter provision, limitation or restriction. **THE OBLIGATIONS OF THE CITY WITH RESPECT TO THE TIF NOTES SHALL TERMINATE ON THE FIRST TO OCCUR OF THE FULL PAYMENT AND DISCHARGE OF THE TIF NOTES OR THE MATURITY DATE (WHETHER OR NOT THE PRINCIPAL AMOUNT OR INTEREST HAS BEEN PAID IN FULL).**

Available Revenues shall be applied, first from the RF EATS Account of the Revenue Fund and then from the RF PILOTS Account of the Revenue Fund to payments on this TIF Note as follows:

*First*, to payment of arbitrage rebate, if any, owed with respect to the TIF Notes under Section 148 of the Internal Revenue Code of 1986, as amended, including any costs of calculating arbitrage rebate;

*Second*, to the Finance Officer of the City and the St. Louis Development Corporation (which monies shall be paid one half to the Finance Officer and one half to the St. Louis Development Corporation), 0.2% of the Notes outstanding on each Payment Date, plus any accumulated deficiency from previous years, plus an amount sufficient to pay all or any portion of the fees and expenses incurred by the City pursuant to Section 7.15 of the Agreement that have not otherwise been reimbursed to the City through the issuance of TIF Notes;

*Third*, to Series A Account of the Debt Service Fund, an amount sufficient to pay all or any portion of the past due interest owing as a result of prior deficiencies of moneys to pay interest due on any Series A Notes on each Payment Date;

*Fourth*, to the Series A Account of the Debt Service Fund, an amount sufficient to pay all or any portion of the accrued interest becoming due and payable on any Series A Notes on each Payment Date;

*Fifth*, to the Series A Account of the Debt Service Fund, an amount sufficient to pay the interest on the Series A Notes on the next succeeding Payment Date;

*Sixth*, for transfer to the Debt Service Reserve Fund, if established, such amount as may be required to restore any deficiency in the Debt Service Reserve Fund if the amount on deposit in the Debt Service Reserve Fund is less than the Debt Service Reserve Requirement;

*Seventh*, to the Series A Account of the Debt Service Fund, an amount sufficient to pay the principal of any Series A Notes that are subject to redemption pursuant to the Note Ordinance on each Payment Date;

*Eighth*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service Fund, an amount sufficient to pay all or any portion of the past due interest owing as a result of prior deficiencies of moneys to pay interest due on the Series B Note on each Payment Date;

*Ninth*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service Fund, an amount sufficient to pay all or any portion of the accrued interest becoming due and payable on any Series B Note on each Payment Date;

*Tenth*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service Fund, an amount sufficient to pay the interest on the Series B Notes on the next succeeding Payment Date;

*Eleventh*, if no Series A Notes are outstanding, to the Series B Account of the Debt Service Fund, an amount sufficient to pay the principal of any Series B Note that is subject to redemption pursuant to this Note Ordinance on each Payment Date; and

*Twelfth*, all other remaining money in the Revenue Fund shall annually be declared as surplus and distributed in the manner provided in the TIF Act, as applicable.

Upon the payment in full of the principal of and interest on the TIF Notes (or provision has been made for the payment thereof as specified in the Note Ordinance), payment in full of the fees and expenses of the Finance Officer and the St. Louis Development Corporation, and payment in full of any other amounts required to be paid under the Note Ordinance, all amounts remaining on deposit in the Special Allocation Fund and the Debt Service Fund shall be declared as surplus and distributed in the manner provided in the TIF Act.

The City covenants that it shall comply with the Charter of the City of St. Louis, Article XVI, Section 3 for each fiscal year that TIF Notes are outstanding and the City official(s) shall request an appropriation of all Available Revenues on deposit in the Special Allocation Fund for application to the payment of the principal of (including, but not limited to, payment of a premium, if any) and interest on the TIF Notes.

**NOTWITHSTANDING ANY PROVISION HEREIN OR IN THE NOTE ORDINANCE TO THE CONTRARY, THE TIF NOTES ARE SUBJECT TO CANCELLATION AND DISCHARGE BY THE CITY IN WHOLE OR IN PART WITHOUT PENALTY UNDER THE CONDITIONS SET FORTH IN SECTION 7.8 OF THE REDEVELOPMENT AGREEMENT.**

The TIF Notes are subject to optional redemption by the City in whole at any time or in part on any Payment Date at a redemption price of 100% of the principal amount of the TIF Note to be redeemed, plus accrued interest thereon to the date fixed for redemption.

The TIF Notes are subject to special mandatory redemption by the City on each Payment Date, at a redemption price equal to 100% of the principal amount being redeemed, together with accrued interest thereon to the date fixed for redemption, in an amount equal to Available Revenues on deposit in the applicable accounts of the Special Allocation Fund and which are not required for the payment of accrued interest on such Payment Date.

The TIF Notes or portions of Notes to be redeemed shall become due and payable on the redemption date, at the redemption price therein specified, and from and after the redemption date (unless the City defaults in the payment of the redemption price) such TIF Notes or portion of TIF Notes shall cease to bear interest. Upon surrender of such TIF Notes for redemption in accordance with such notice, the redemption price of such TIF Notes shall be paid by the Finance Officer. Installments of interest due on or prior to the redemption date shall be payable as herein provided for payment of interest. Upon surrender for any partial redemption of any TIF Note, there shall be prepared for the Registered Owner a new TIF Note or Notes of the same maturity in the amount of the unpaid principal as provided herein. All TIF Notes that have been redeemed shall be cancelled and destroyed by the Finance Officer as provided herein and shall not be reissued.

TIF Notes shall be redeemed only in the principal amount of One Thousand Dollars (\$1,000) or any integral multiple thereof. When less than all of the outstanding TIF Notes are to be redeemed and paid prior to maturity, such TIF Notes shall be selected by the Finance Officer in One Thousand Dollar (\$1,000) units of face value in such equitable manner as the Finance Officer may determine.

The TIF Notes are issuable in the form of fully registered Notes without coupons in minimum denominations of One Hundred Thousand Dollars (\$100,000) or any integral multiple \$1,000 in excess thereof, except with respect to the Notes issued upon acceptance by the City of the final Certificate of Reimbursable Redevelopment Project Costs, which Notes may be issued in any denomination, subject to the limitation on the aggregate Principal Amount.

This TIF Note may be transferred or exchanged as provided in the Note Ordinance only upon the Register, upon surrender of this TIF Note together with a written instrument of transfer satisfactory to the Finance Officer duly executed by the Registered Owner or the Registered Owner's duly authorized agent.

**THE OWNER HEREOF EXPRESSLY AGREES, BY SUCH OWNER'S ACCEPTANCE HEREOF, THAT THE RIGHT TO PURCHASE, TRANSFER, ASSIGN OR NEGOTIATE THIS TIF NOTE SHALL BE LIMITED TO PURCHASE, TRANSFER, ASSIGNMENT OR NEGOTIATION TO AN APPROVED INVESTOR AS SUCH TERM IS DEFINED IN THE NOTE ORDINANCE, AND UPON THE EXECUTION BY THE PROPOSED PURCHASER OR TRANSFEREE OF AN INVESTMENT LETTER IN SUBSTANTIALLY THE FORM OF EXHIBIT C TO THE NOTE ORDINANCE, SIGNED BY THE PROPOSED PURCHASER OR TRANSFEREE, SHOWING THAT THE PROPOSED PURCHASER OR TRANSFEREE IS AN APPROVED INVESTOR. "Approved Investor" is defined in the Note Ordinance, and includes, among others, (a) the Developer or a Related Entity, (b) an "accredited investor" under Rule 501(a) of Regulation D promulgated under the Securities Act of 1933, (c) a "qualified institutional buyer" under Rule 144A promulgated under the Securities Act of 1933 (d) any general business company or enterprise with total assets in excess of \$50,000,000, or (e) any Project Lender.**

Subject to the limitations of the preceding paragraph, upon surrender thereof at the office of the Finance Officer, the Finance Officer shall transfer or exchange any TIF Note for a new TIF Note of the same maturity and in the same principal amount as the outstanding principal amount of the TIF Note that was presented for transfer or exchange. Any TIF Note presented for transfer or exchange shall be accompanied by a written instrument or instruments of transfer or authorization for exchange, in a form and with guarantee of signature satisfactory to the Finance Officer, duly executed by the Registered Owner thereof or by the Registered Owner's duly authorized agent.

This TIF Note shall not be valid or binding on the City or be entitled to any security or benefit under the Indenture until the Certificate of Authentication hereon has been executed by the Finance Officer.

The TIF Notes are secured in the manner set forth in Ordinance No. \_\_\_\_ [Board Bill No. \_\_\_\_] of the City adopted on \_\_\_\_\_, 201\_ (the "Note Ordinance"). The undersigned hereby represents to each of you and agrees with each of you, as follows:

1. The undersigned is an Approved Investor (as defined in the Note Ordinance).
2. The undersigned acknowledges that the City has not made any representation or warranty concerning the accuracy or completeness of any information furnished in connection with the purchase by the undersigned of the TIF Notes. Accordingly, the undersigned has not relied upon the City as to the accuracy or completeness of such information. As a sophisticated investor, the undersigned has made its own decision to purchase the TIF Notes based solely upon its own inquiry and analysis.
3. The undersigned understands that the TIF Notes do not constitute an indebtedness of the City or a loan or credit thereof within the meaning of any constitutional or statutory debt limitation or restriction.
4. The undersigned is familiar with and has counsel who are familiar with the federal and state legislation, rules, regulations and case law pertaining to the transfer and distribution of securities, including, but not limited to, disclosure obligations of the seller incident to any such transfer or distribution. The undersigned hereby covenants and agrees that the undersigned will not sell, offer for sale, pledge, transfer, convey, hypothecate, mortgage or dispose of the TIF Notes or any interest therein in violation of applicable federal or state law or

in violation of restrictions on sale, assignment, negotiation or transfer of the TIF Notes as set forth in paragraph 6 below.

5. The undersigned is purchasing the TIF Notes for its own account for investment (and not on behalf of another) and, other than a contemplated pledge of the TIF Notes, has no present intention of reselling the TIF Notes or dividing its interest therein. Notwithstanding the foregoing, the undersigned has the right to sell, offer for sale, pledge, transfer, convey, hypothecate, mortgage or dispose of the TIF Notes at some future date determined by it, provided that such disposition is not in violation of restrictions on sale, assignment, negotiation or transfer of the TIF Notes as set forth in paragraph 6 below.

6. The undersigned acknowledges that the right to sell, assign, negotiate or otherwise transfer the TIF Notes shall be limited to Approved Investors (as defined in the Note Ordinance).

7. The undersigned agrees to indemnify and hold you harmless from any and all claims, judgments, attorneys' fees and expenses of whatsoever nature, whether relating to litigation or otherwise, resulting from any attempted or affected sale, offer for sale, pledge, transfer, conveyance, hypothecation, mortgage or disposition of the TIF Notes in violation of this letter.

8. The undersigned has satisfied itself that the TIF Notes may be legally purchased by the undersigned.
