This Board Bill is authorizing and directing the Circuit Attorney, on behalf of the City of St. Louis, to enter into a grant agreement with the United States Department of Justice, Bureau of Justice Assistance, Office of Justice Programs for funding to create The St. Louis Circuit Attorney Navigation, Diversion, and Opportunity (also referred as STL CAN DO) Program 2019-AR-BX-K018. It contains an emergency clause.

1 An ordinance recommended by the Board of Estimate and Apportionment authorizing and
2 directing the Circuit Attorney, on behalf of the City of St. Louis, to enter into a grant agreement
3 with the United States Department of Justice, Bureau of Justice Assistance, Office of Justice
4 Programs for funding to create The St. Louis Circuit Attorney Navigation, Diversion, and
5 Opportunity (also referred as STL CAN DO) Program 2019-AR-BX-K018 and authorizing the
6 Circuit Attorney to expend related grant funds necessary to support this effort including hiring
7 staff and program development resources; and containing an emergency clause.

8 **WHEREAS**, the Circuit Attorney of the City of St. Louis has been awarded a grant with
9 the United States Department of Justice, Bureau of Justice Assistance, Office of Justice
10 Programs, for the purpose of providing staffing, program development, and data collection &
11 analysis resources required for the STL CAN DO Program within the Circuit Attorney; and

12 **WHEREAS**, the United States has provided funding in the amount of \$1,159,234 to the
13 Circuit Attorney's Office for the purpose of providing additional staff and resources for this STL
14 CAN DO Program in addition to, and not to supplant or replace, their existing allocation; and

15 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

16 **SECTION ONE.** The Circuit Attorney is hereby authorized and directed to enter into
17 and execute a grant agreement with the United States Department of Justice, Bureau of Justice
18 Assistance, Office of Justice Programs for a grant to fund the STL CAN DO Program.

19 **SECTION TWO.** The Circuit Attorney is hereby authorized, upon approval of the Board
20 of Estimate and Apportionment, to expend the funds received pursuant to the grant agreement,

21 by grant agreement or otherwise, in manner and purpose that is consistent with the provisions of
22 said agreement.

23 **SECTION THREE.** Emergency Clause. This being an ordinance for the preservation of
24 public peace, health, and safety, it is hereby declared to be an emergency measure within the
25 meaning of Section 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore
26 this ordinance shall become effective immediately upon its passage and approval by the Mayor.
