1 An ordinance pertaining to ward boundaries for the City of St. Louis; repealing **Ordinance 68981**,
2 codified as **Chapter 2.12 of the Revised Code** of the City of St. Louis 2020 Anno.; establishing
3 new ward boundaries; with an emergency clause.

4 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

5 **SECTION ONE. Ordinance No. 68981**, presently codified as **Chapter 2.12 of the Revised**
6 **Code** of the City of St. Louis 2020, Anno., is hereby repealed.

7 **SECTION TWO.** This City is divided into fourteen (14) wards, the boundaries of which are set
8 forth in **Exhibit A** (pages 1-10) attached hereto and incorporated herein by this reference.

9 **SECTION THREE.** This being an ordinance for the preservation of the public peace, health and
10 safety, it is hereby declared to be an emergency measure within the meaning of Sections 19 and
11 20 of Article IV of the Charter of the City of St. Louis and shall become effective immediately
12 upon its passage and approval by the Mayor.
