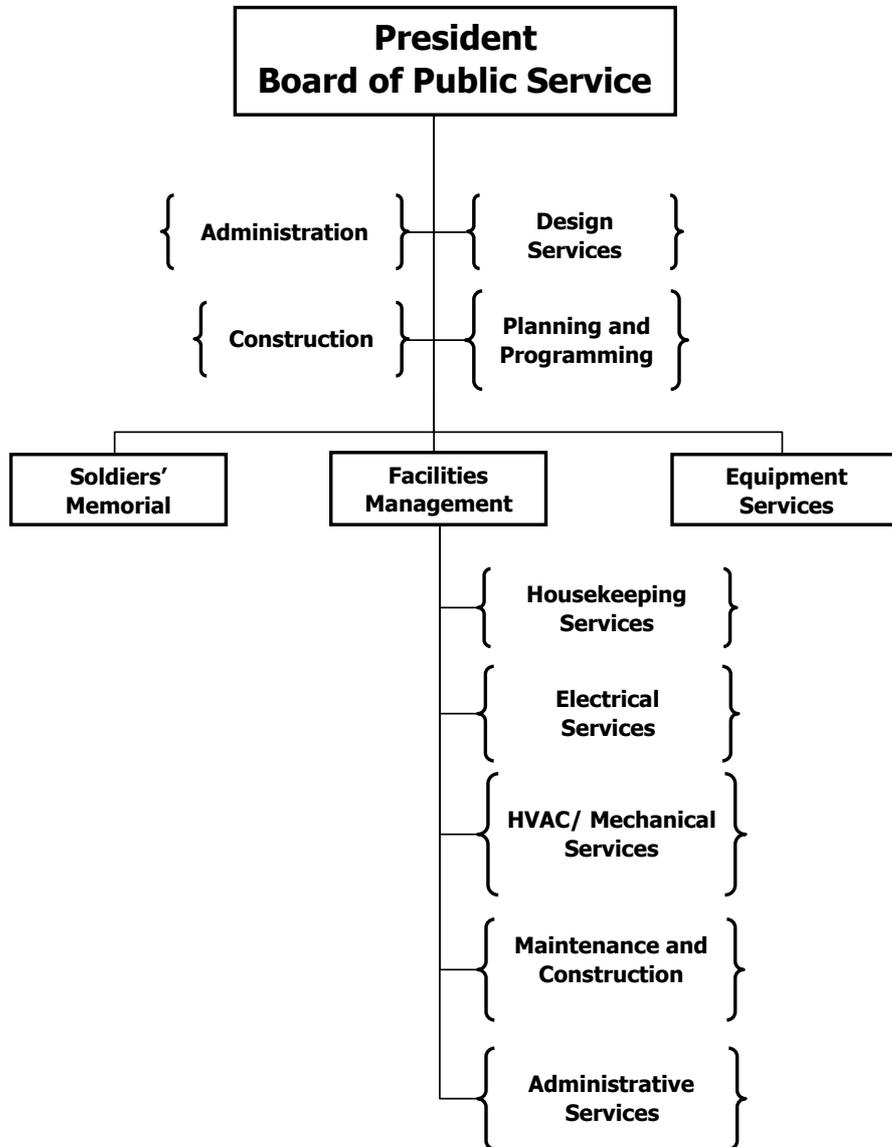

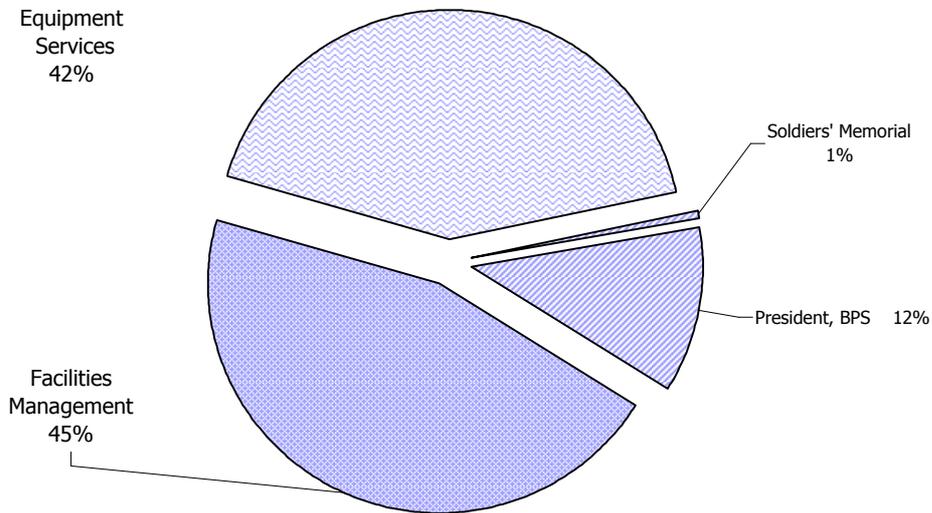

FY14 GENERAL FUND BUDGET BY DIVISION



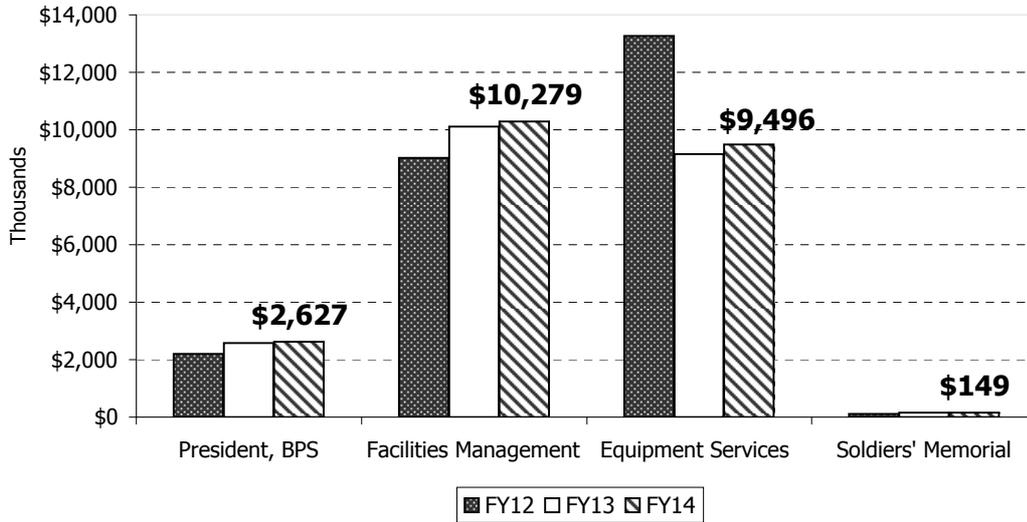

DIVISION HIGHLIGHTS

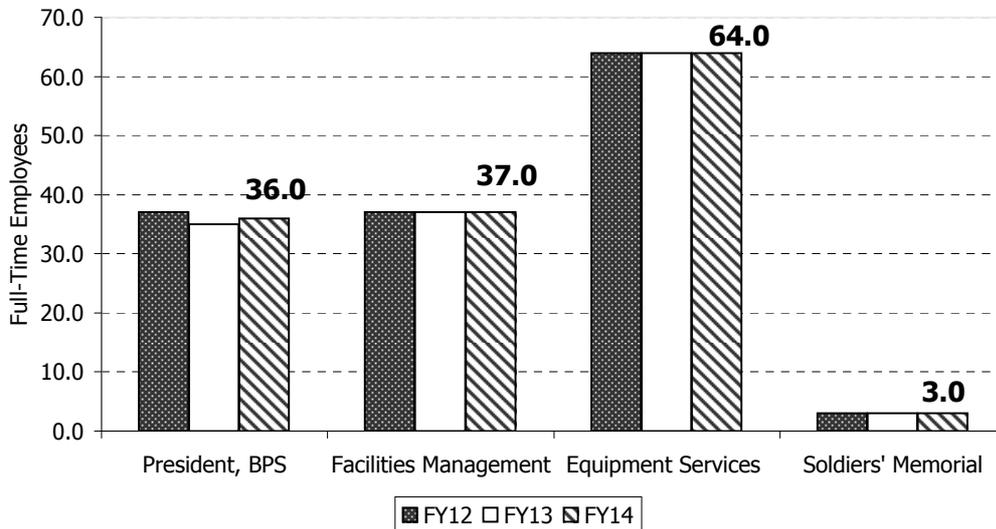
- Housekeeping fully implemented Single Stream Recycling at City Hall and the 1520 Market street building.

FY11 - FY13 GENERAL FUND BUDGET HISTORY

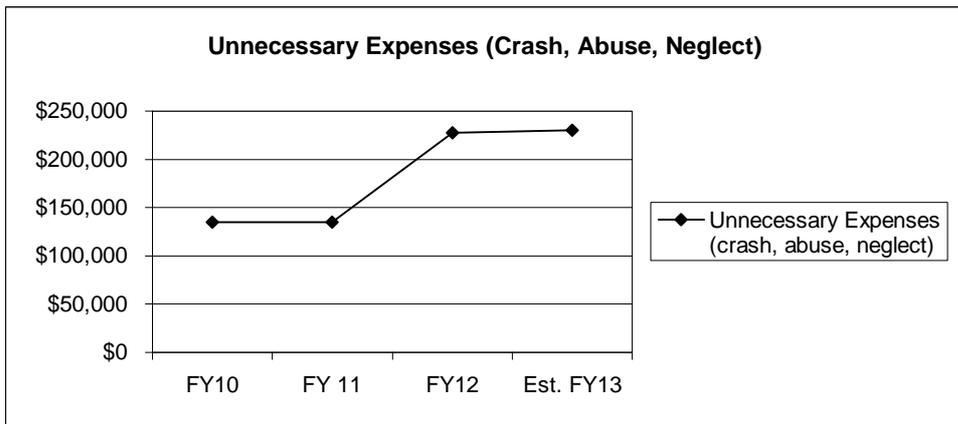
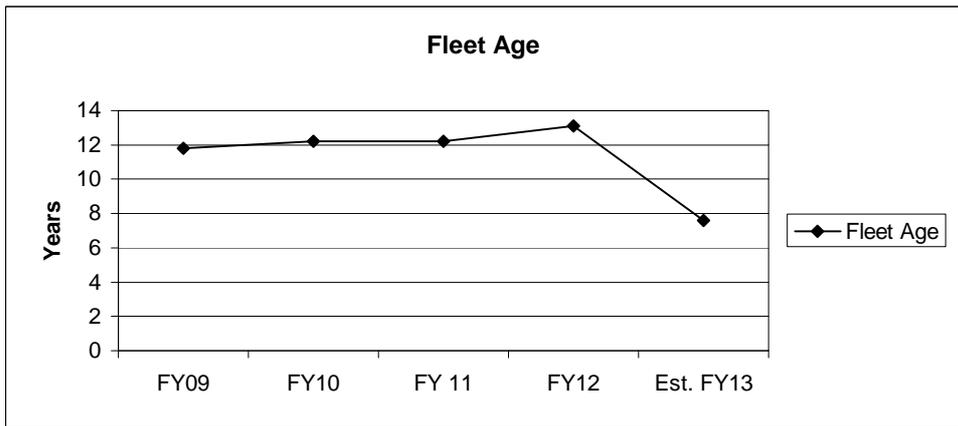
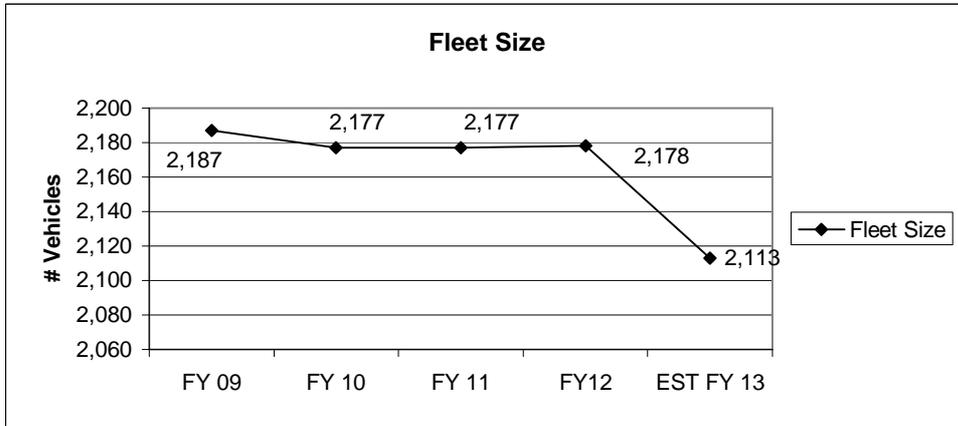


FY12 - FY14 GENERAL FUND PERSONNEL HISTORY BY DIVISION



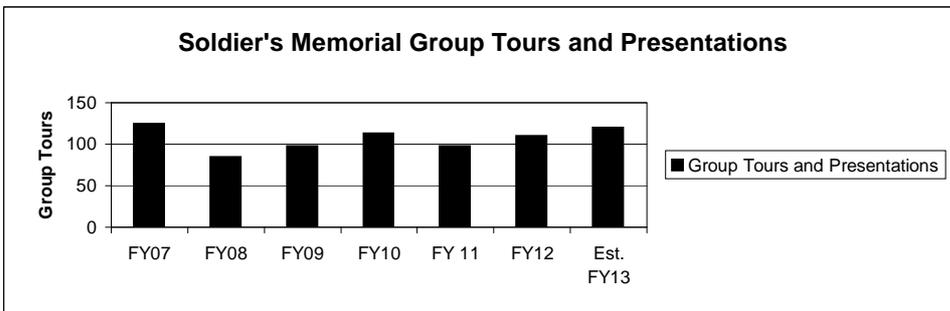
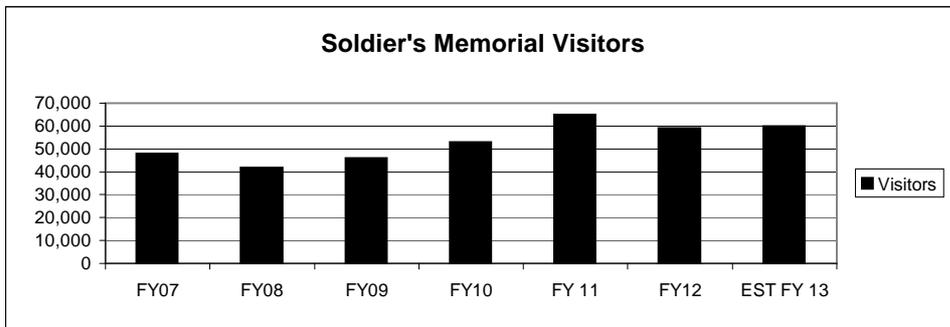
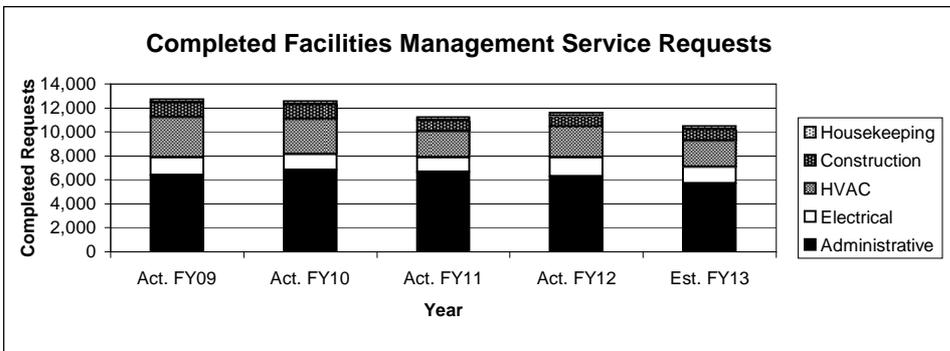
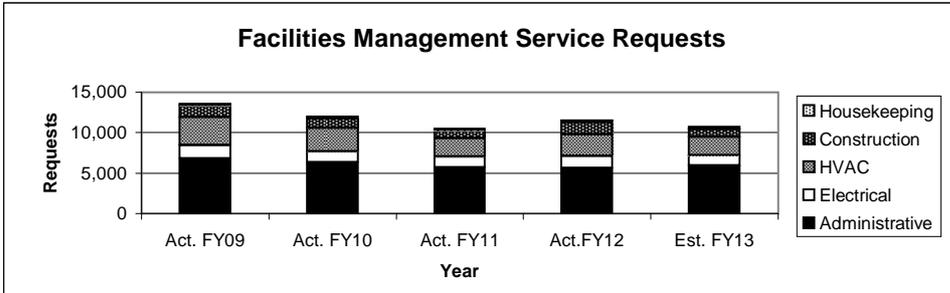
