7. from propose handhole on the south side of Julian approx. 190' southeast of Amherst Pl. to existing utility pole approx. 5' southeast of the proposed handhole and 195' southeast of Amherst Pl.

11 Applications for MCI Metro Access as follows:

1. 2" HDPE pipe to be placed for fiber cable starting at 5600 Delmar Blvd. place new conduit from existing handhole located on the west side of the intersection of Clara and Delmar placing east for 85' at this point turn south boring Delmar and continue down the east side of Clara for 963' ending at 63 Kingsbury Pl.,
2. 2" HDPE pipe to be placed for fiber cable starting at 1101 So. Kingshighway place conduit form handhole located on the southeast corner of Oakland and So. Kingshighway place conduit west along the south side of Oakland for 460' place new handhole at 4971 Oakland and continue west for 1,000' and place new handhole at 5050 Oakland and continue west for 1,200' and enter existing handhole located at 1000 Macklind. New fiber will continue from this point on another permit,
3. 2" HDPE pipe to be placed for fiber cable starting at existing handhole located at 1000 Macklind place fiber in existing conduit heading west for 5,100' at this point place new handhole at 6400 Oakland. New fiber will be placed from this point south on another permit,
4. 2" HDPE pipe to be placed for fiber cable starting at 6400 Oakland from this handhole located on the corner of Oakland and Tamm place conduit south for 500' at this point place new handhole at 1046 Tamm and continue south for 540' at this point place new handhole at 6401 Clayton etc.,
5. 2" HDPE pope to be placed for fiber cable starting at 733 No. Union. Place new handhole and continue south along the west side of Union for 540' at this point place new handhole at 5350 Delmar and continue south 400' and place new handhole at 1 Washington Terr. And continue placing west along north side of Washington Terr for 840' ending at 17 Washington Terr,
6. 2" HDPE pipe to be placed for fiber cable starting at 5454 Delmar. From existing handhole located at the intersection of Delmar and Belt place conduit along east side of Belt for 445' ending at 5479 Enright,
7. 2" HDPE pipe to be placed for fiber cable starting at 5854 Delmar. Place conduit from existing handhole located on the north side of Delmar at the intersection of Laurel St. bore south along the west side of Laurel for 1,022' at this point place new handhole at 459 Laurel etc.,
8. 2" HDPE pipe to be placed for fiber cable starting at 6211 Delmar. At the west side of the intersection of Skinker and Delmar place from existing handhole along the north side of Delmar for 620' leaving St. Louis right of way at 6561 Delmar,
9. 2" HDPE pipe to be placed for fiber cable starting at 1 Brookings Dr. at existing handhole located at the intersection of Lindell and Skinker place conduit south along the west side of Skinker for 530' at this point turn and continue west along the north side of Forsyth for 620' placing new handhole at 6300 Forsyth leaving St. Louis City right of way,
10. 2" HPDE pipe to be placed for fiber cable starting at 6825 Clayton from existing handhole bore and place conduit to the west crossing Skinker and continue along the south side of Clayton for 600', place new handhole at 7036 Clayton and continue west leaving St. Louis City right of way at 6300 Clayton Rd.,
11. 2" HPDE pipe to be placed for fiber cable starting at 5708 Oakland from existing handhole place conduit east for 192' at this point turn south and continue down the east side of Highlander Dr. 700' ending at 1110 Highlands Plaza Dr,

3. start from existing AT and T handhole at the side of 1500 Park and bore and place one fiber cable east 2' off edge of sidewalk in grass for 150' across Dillion to an existing pipe at the side of 1419 Carroll St.,
4. starting at power pole across from 10 E. Bremen bore across E. Bremen for 40' entering customer property at 10 E Bremen,
5. place a 24x36x36" handhole in alley at the rear of 1315 Allen then bore north across alley 75' to new building construction at 1400 Russell and place fiber cable,
6. in St. Louis County right of way along Dautel Ln bore approx. 130' in Dautel Ln right of way in section of Grand fathered STL City Water property before continuing back into St. Louis County right of way along Dautel Ln. Due to work taking place in St. Louis County, only city utility involved is water.
