1 Application Filed as follows:

Metropolitan St. Louis Sewer District, permanent easement and temporary construction easement (TCE) on the airport lot owned by City of St. Louis at 4401 Springdale.

Union Electric d/b/a Ameren Missouri, to install a 45' pole and sidewalk guywire for service extension to new customer at 2300 So. 2nd St. (south of intersection of Shenandoah and So. 2nd St.),

AT and T, contractor to place/bore new copper cable from AT and T manhole at the front of 316 No. Skinker. Lane closure will be needed for northbound right lane. Bore will continue east in alley to the rear of 6184 Waterman,

AT and T, contractor will cut and restore 4'x4' for splice pit. New copper cable to be placed down utility pole riser and pick up existing splice/cable in splice pit at base of pole in alley at the rear of 6040 Kingsbury,

MCI Metro Access, 2" HDPE pipe to be placed for fiber cable starting by placing handhole in front of 4051 Bingham. From this handhole, bore northwest 580' along the north side of Bingham to Newport. Turn north and bore 528' along west side of Newport and place handhole in front of 4078 Meramec. From this handhole, bore 860' northwest to along south side of Meramec to tracks (separate Union Pacific permit to be applied for crossing),

MCI Metro Access, 2" HDPE pipe to be placed for fiber cable starting at handhole (sheet 217) in front of 5900 Arsenal (placed on prior permit) bore 1418' west along the south side of Arsenal and place handhole (sheet 219) in front of 6098 Arsenal. From this handhole (sheet 219), bore one leg 1066' northeast along the east side of Watson Rd. Turn north and bore 299' along the west side of Sulphur and place handhole (sheet 260) at the corner of 6031 Southwest.
