Resolution No. 32

Dr. Barbara Anderson

WHEREAS, Dr. Barbara Anderson has served St. Louis Public Schools for 32 years. She first entered the St. Louis Public Schools at the Marshall Elementary school as a student. After completing her education at O'Fallon Technical High School (and McKinley High School), she began her college education and completed a Bachelor of Arts Degree from Harris Teacher's College. Dr. Anderson earned a Master of Arts in Teaching Degree from Webster University. She earned a Master of Arts in Administration Degree from St. Louis University. Dr. Anderson earned a Doctorate of Education Degree from St. Louis University in 2012; and

WHEREAS, Dr. Anderson began her teaching career at Clark 7th and 8th Grade Center. She spent ten years teaching in middle schools and then transitioned to Shaw Visual and Performing Arts Center, where she spent eight years teaching 1st grade; and

WHEREAS, after leaving Shaw, Dr. Anderson re-entered middle school and taught Language Arts at Busch Athletic Academic Academy. Then she left the regular classroom and became a Chapter I math teacher at Marquette Visual and Performing Arts Center, after which she again taught Math and Language Arts at Langston Middle School. After leaving Langston Middle, she entered administration as an Instructional Coordinator assigned to Elliot Elementary; and

WHEREAS, in 2004, Dr. Anderson was assigned to be Principal of Lexington Elementary School. She received an Apple for the Teacher Award in 2007 and a Pettus Teacher of Excellence Award in 2010. During her tenure at Lexington as principal, Lexington was listed as a "most improved school" by DESE in 2005; and

WHEREAS, Lexington has achieved Adequate Yearly Progress (AYP) in all areas four times. Lexington has achieved the State Target on the MAP in communication arts five times. Currently and for the past three years, only the gifted school scored higher in communication arts; and

WHEREAS, in 2009, Lexington was honored with Monsanto's School of Excellence Award; Secretary of Education Arne Duncan was a visitor as was Missouri Senator Claire McCaskill. Lexington has received national recognition for excellence from Randi Weingarten the national president of the AFT Teachers' Union and from Arne Duncan for collaborating with the labor union and having a collegial staff.

Resolution No. 33

Consuelo Hopkins Wilkins, MD

WHEREAS, Consuelo Hopkins Wilkins, MD is an associate professor in the Department of Medicine, Division of Geriatrics and Nutritional Science, with secondary appointments in Psychiatry and Surgery (Public Health Sciences) at the School of Medicine at Washington University in St. Louis. She currently serves as co-director of the Center for Community Engaged Research in the Institute of Clinical and Translational Science, director of the Community Outreach Program in the Nutrition Obesity Research Center, and director of Our Community, Our Health - a collaborative program with Saint Louis University to disseminate culturally relevant health information and facilitate community-academic partnerships to address health disparities. Dr. Wilkins has served as Medical Director of Barnes-Jewish Extended Care since 2001; and

WHEREAS, Dr. Wilkins is also the founding director of the Center for Community Health and Partnerships at the Institute for Public Health at Washington University. The Office focuses on building and sustaining mutually-beneficial community-academic partnerships that effectively address the health needs of the St. Louis community; and

WHEREAS, the primary focus of her research has been on identifying and addressing risk factors (such as socioeconomic status, depression, weight, and vitamin D status) for cognitive impairment in older adults. Dr. Wilkins' research experience also includes a spectrum of clinical and translational projects

including neuropathological studies of dementia in African Americans, neuroimaging studies in depressed older adults, and the development of tools to assess functional status in community-dwelling elderly; and

WHEREAS, in 2008, Dr. Wilkins launched CARE in Our Community, a transdisciplinary program, that uses community-based team approach and evidence-based interventions to improve mobility, decrease falls and decrease depressive symptoms (using individualized problem solving therapy). CARE is currently in its second cycle of funding and has enrolled more than 650 adults (65% live in HUD subsidized housing and 82% are African American); and

WHEREAS, Dr. Wilkins is also firmly committed to improving the health of underserved and disadvantaged groups. She has held offices in multiple professional and civic organizations including President of the Mound City Medical Forum (the St. Louis affiliate of the National Medical Association), Vice Chair for Region V of the National Medical Association, and Chair of the City of St. Louis' Affordable Housing Commission which administers grants and awards of more than \$4 million annually to support low-income families. She also serves as the Health Editor and a columnist of the nationally-recognized St. Louis American Newspaper, which reaches an audience of 200,000, mostly African Americans, weekly.

NOTICE OF ST. LOUIS LIVING WAGE RATES EFFECTIVE APRIL 1, 2012

In accordance with Ordinance No. 65597, the St. Louis Living Wage Ordinance ("Ordinance") and the Regulations associated therewith, the City Compliance Official for the City of St. Louis has determined that the following living wage rates are now in effect for employees of covered contracts:

- 1) Where health benefits as defined in the Ordinance are provided to the employee, the living wage rate is **\$11.93** per hour (130% of the federal poverty level income guideline for a family of three); and

- 2) Where health benefits as defined in the Ordinance are **not** provided to the employee, the living wage rate is **\$15.52** per hour (130% of the federal poverty level income guideline for a family of three, plus fringe benefit rates as defined in the Ordinance).
- 3) Wages required under Chapter 6.20 of the Revised Code of the City of St. Louis: **\$3.59** per hour.

These rates are based upon federal poverty level income guidelines as defined in the Ordinance and these rates are effective as of **April 1, 2012**. These rates will be further adjusted periodically when the federal poverty level income guideline is adjusted by the U.S. Department of Health and Human Services or pursuant to Chapter 6.20 of the Revised Code of the City of St. Louis.

The Ordinance applies to employers who are covered by the Ordinance as defined in the Ordinance, where the contract or grant is entered into or renewed after the effective date of the Ordinance, which is November 3, 2002. LIVING WAGE REQUIREMENTS

Bidders [Proponents] are hereby advised that the St. Louis Living Wage Ordinance #65597 and associated Regulations apply to the service [concession] [lease] [City Financial Assistance] for which [bids] [proposals] are being sought herein. This Ordinance requires that, unless specific exemptions apply, all individuals who perform work pursuant to a contract executed between the successful [bidder] [proponent] and the City [Agency] must be paid a minimum of the applicable Living Wage rates set forth in the attached Living Wage Bulletin, and, if the rates are adjusted during the term of the contract pursuant to the Ordinance, applicable rates after such adjustment is made.
