AN ORDINANCE AMENDING ORDINANCE NO. 65528 ADOPTED BY THE BOARD OF ALDERMEN ON APRIL 26, 2002; AUTHORIZING THE EXECUTION OF AN AMENDMENT TO REDEVELOPMENT AGREEMENT BY AND BETWEEN THE CITY AND 4200 LACLEDE CORP.; PRESCRIBING THE FORM AND DETAILS OF SAID AMENDMENT; MAKING CERTAIN FINDINGS WITH RESPECT THERETO; AUTHORIZING OTHER RELATED ACTIONS; AND CONTAINING A SEVERABILITY CLAUSE.

WHEREAS, pursuant to Ordinance No. 65527, the City designated a portion of the City a Redevelopment Area and approved the 4200 Laclede TIF Redevelopment Plan (the "Redevelopment Plan") and the Redevelopment Project, all as described therein; and

WHEREAS, pursuant to Ordinance No. 65527, the City adopted tax increment allocation financing within the Redevelopment Area, and established the Special Allocation Fund for the Redevelopment Project, all as provided for and in accordance with the TIF Act and described therein; and

WHEREAS, pursuant to Ordinance No. 65528, the City authorized the execution of a TIF Redevelopment Agreement (the "Redevelopment Agreement") between the City and 4200 Laclede Corp. (the "Developer"), in furtherance of the Redevelopment Plan, with such Redevelopment Agreement to be in the form attached thereto; and

WHEREAS, the Redevelopment Agreement was subsequently executed by the City and Developer, as provided in and in accordance with Ordinance No. 65528, which Redevelopment Agreement is dated as of November 19, 2002 ; and

WHEREAS, Section 3.4 of the Redevelopment Agreement, as authorized by the City, provides that the Developer shall complete or cause the completion of all of the Work, as those terms are defined therein, not later than December 31, 2003 absent any event of force majeure and not later than July 1, 2004 in the event of a delay caused by an event of force majeure; and

WHEREAS, it is hereby found and determined that it is necessary and advisable and in the best interest of the City and of its inhabitants to authorize the City to execute an Amendment to the Redevelopment Agreement, in order to amend the Redevelopment Agreement as it concerns the date by which the Work must be complete or substantially complete; and

WHEREAS, the Board of Aldermen hereby determines that the terms of the Amendment to Redevelopment Agreement attached as **Exhibit A** hereto and incorporated herein by reference are acceptable and that the execution, delivery and performance by the City and Developer of the attached Amendment to Redevelopment Agreement is necessary and desirable and in the best interests of the City and the health, safety, morals and welfare of its residents, and in accord with the public purposes specified in the TIF Act.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. The Board of Aldermen hereby approves, and the Mayor and Comptroller of the City are hereby authorized and directed to execute, on behalf of the City, the Amendment to Redevelopment Agreement by and between the City and the Developer attached hereto as **Exhibit A**, and the City Register is hereby authorized and directed to attest to the Amendment to Redevelopment Agreement and to affix the seal of the City thereto. The Amendment to Redevelopment Agreement shall be in substantially the form attached, with such changes therein as shall be approved by said Mayor and Comptroller executing the same and as may be consistent with the intent of this Ordinance and necessary and appropriate in order to carry out the matters herein authorized.

SECTION TWO. The Mayor and Comptroller of the City or their designated representatives are hereby authorized and directed to take any and all actions to execute and deliver for and on behalf of the City any and all additional certificates, documents, agreements or other instruments as may be necessary and appropriate in order to carry out the matters herein authorized, with no such further action of the Board of Aldermen necessary to authorize such action by the Mayor and the Comptroller or their designated representatives.

SECTION THREE. The Mayor and the Comptroller or their designated representatives, with the advice and concurrence of the City Counselor and after approval by the Board of Estimate and Apportionment, are hereby further authorized and directed to make any changes to the documents, agreements and instruments approved and authorized by this Ordinance as may be consistent

with the intent of this Ordinance and necessary and appropriate in order to carry out the matters herein authorized, with no such further action of the Board of Aldermen necessary to authorize such changes by the Mayor and the Comptroller or their designated representatives.

SECTION FOUR. It is hereby declared to be the intention of the Board of Aldermen that each and every part, section and subsection of this Ordinance shall be separate and severable from each and every other part, section and subsection hereof and that the Board of Aldermen intends to adopt each said part, section and subsection separately and independently of any other part, section and subsection. In the event that any part, section or subsection of this Ordinance shall be determined to be or to have been unlawful or unconstitutional, the remaining parts, sections and subsections shall be and remain in full force and effect, unless the court making such finding shall determine that the valid portions standing alone are incomplete and are incapable of being executed in accord with the legislative intent.

EXHIBIT A
Amendment to Redevelopment Agreement

AMENDMENT TO REDEVELOPMENT AGREEMENT

This Amendment to Redevelopment Agreement ("**Amendment**") is made this ___ day of January, 2008 by and between the CITY OF ST. LOUIS, MISSOURI ("**City**"), a city and political subdivision duly organized and existing under its charter and the Constitution and laws of the State of Missouri, and 4200 LACLEDE CORP., a Missouri corporation ("**Developer**"). Capitalized terms used in this Amendment which are defined in the Agreement (as defined herein) shall have the same meanings as defined therein, unless otherwise defined herein.

RECITALS

A. The City is a party to that certain Redevelopment Agreement ("**Agreement**") dated as of November 19, 2002, by and between the City and Developer, for redevelopment of a portion of the City of St. Louis in accordance with that certain 4200 Laclede TIF Redevelopment Plan and, as approved and authorized by the City of St. Louis, Missouri pursuant to Ordinance Nos. 65527 and 65528; and

B. Section 3.4 of the Agreement did provide that the Developer shall complete or cause the completion of the Work absent any event of force majeure, not later than December 31, 2003, and, alternatively provided that in the event of a delay caused by an event of force majeure the Developer shall complete or cause the completion of the Work by not later than July 1, 2004, as such terms are defined in the Agreement, and did provide to the City the right to take certain actions pursuant to Sections 7.2 and 7.4 of the Agreement in the event that such Work was not complete by December 31, 2003; and

C. Due to certain circumstances, additional time beyond that provided in the Agreement was required to complete the Work related to the Redevelopment Project, and the City acknowledges that it is in the best interests of the City and its residents for the general health, safety, morals and public welfare to grant Developer the additional time needed to fulfill its obligation.

AGREEMENT

NOW, THEREFORE, in consideration of the above premises and of the mutual promises and covenants set forth herein, the parties hereby agree as follows:

1. Section 3.4 of the Agreement as originally executed is by this Amendment deleted, and replaced with the following:

"3.4 Developer to Construct the Work. The Developer shall commence or cause the commencement of the construction of the Work within one hundred twenty (120) days of the date of this Agreement, which Work shall be constructed in a good and workmanlike manner in accordance with the terms of this Agreement and the Concept Site Plan. The Developer shall complete or cause the completion of all of the Work not later than June 29, 2006 absent an event of force majeure.

2. This Amendment shall be construed and enforced in accordance with the laws of the State of Missouri and shall be binding upon and shall inure to the benefit of the successors and assigns of the parties hereto.

- 3. No provision of this Amendment may be amended or modified, except by an instrument in writing signed by the parties.
- 4. Unless otherwise defined herein, any capitalized terms in this Amendment shall have the meanings provided in the Agreement.
- 5. This Amendment may be executed in multiple counterparts.

EXHIBIT A

Legal Description of the Redevelopment Area

A lot in City Block 3916 of the City of St. Louis, fronting 191 feet 8 ½ inches on the South line of Laclede Avenue by a depth Southwardly of 187 feet 6 inches, more particularly described as follows: Beginning at a point on the South line of Laclede Avenue, 421 feet 8 ½ inches East of the East line of Boyle Avenue, thence Eastwardly along the South line of Laclede Avenue, 191 feet 6 ½ inches; thence Southwardly, 187 feet 6 inches; thence Westwardly, 191 feet 6 ½ inches; thence Northwardly, 187 feet 6 inches to the point of beginning.
