

**ORDINANCE NUMBER 70149**

**BOARD BILL NO. 183**

**INTRODUCED BY ALDERMAN JOHN COATAR &  
ALDERWOMAN TAMMIKA HUBBARD**

1 An ordinance recommended by the Planning Commission approving the renaming of the  
2 entire length of an existing public street from North 3rd Street to Lumiere Place Boulevard --  
3 extending between O’Fallon St. on the north to Washington Ave. on the south.

4 **Whereas**, Ordinance 60797, approved April 11, 1988, established procedures for the  
5 naming and renaming of public streets in the City of St. Louis, and such procedures have been  
6 codified as Chapter 20.12 of the Revised Code of the City of St. Louis by Ordinance 68604,  
7 approved March 16, 2010;

8 **Whereas**, the Planning Commission recommended approval of the renaming of North  
9 3rd Street at its meeting on September 2, 2015; and

10 **Whereas**, the Board of Aldermen finds that the procedures and approvals required by  
11 said Chapter of the City Code have been followed and obtained with respect to such renaming of  
12 the existing public street.

13 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

14 **SECTION ONE.**

15 North 3rd Street, an existing public street, extends approximately 0.5 miles between  
16 O’Fallon Street on the north to Washington Avenue on the south. The location of North 3rd  
17 Street, as well as the parcels located along the street, is shown on the attached general location  
18 map. (See Exhibit “A”.)

**INTRODUCED BY ALDERMAN JOHN COATAR &  
ALDERWOMAN TAMMIKA HUBBARD**

1           A petition to rename the street was submitted to the Planning and Urban Design Agency  
2   by Tropicana St. Louis LLC, the property owners of sixteen (16) of the twenty-five (25) parcels

1 which front on North 3rd Street, and the aldermen within whose wards the street is located. The  
2 Planning Commission reviewed the renaming of the street at its meeting on September 2, 2015.  
3 At that meeting, the Planning Commission found that the proposed street name meets the criteria  
4 for street names and recommended approval of the petition as submitted to the Board of  
5 Aldermen.

6 The Board of Aldermen finds that the procedures and approvals required by said Chapter  
7 of the City Code have been followed and obtained with respect to such renaming of the existing  
8 public street, and that the entire length of the street shall be renamed from North 3rd Street to  
9 Lumiere Place Boulevard.

10 **SECTION TWO.**


11 The Director of Streets is hereby directed to coordinate with the Missouri Department of

13 to Lumiere Place Boulevard.


# General Location Map of N. 3rd St.
