

1 **BOARD BILL NO. 67AA INTRODUCED BY ALDERMAN ANTONIO**
2 **FRENCH, PRESIDENT LEWIS E. REED, ALDERWOMAN DAVIS,**
3 **ALDERMAN KENNEDY, ALDERMAN VACCARO, AND ALDERMAN**

6 An ordinance revising The Transparency in Government Law, Ordinance 69707,
7 codified at Chapter 3.115 of the Revised Code of the City of St. Louis, to require the
8 video recording of all public meetings of the St. Louis Board of Aldermen, including
9 committee meetings; the Board of Estimate & Apportionment; and the Preservation
10 Board.

11 **WHEREAS**, all of this bill's changes and revisions to the existing ordinance as
12 codified in the Revised Code of the City of St. Louis are shown in Exhibit A.

13 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

14 **SECTION ONE. Repeal of Section Four of Ordinance 69707.**

15 Section Four of Ordinance 69707 and Section 3.115.040 of the Revised Code of
16 the City of St. Louis are hereby repealed.

17 **SECTION TWO. Recording public meetings.**

18 A new Section Four of Ordinance 69707, which shall replace the current Section
19 3.115.040 of the Revised Code of the City of St. Louis, is hereby enacted and shall read
20 as follows:
