

ORDINANCE 70894

BOARD BILL NO. 148CS INTRODUCED BY: ALDERWOMAN HEATHER NAVARRO

1 An ordinance repealing paragraph (f) of Section Two of Ordinance 62622, approved
2 on May 29, 1992, as amended by Ordinance 63840, approved on July 19, 1996, as amended
3 by Ordinance 64935, approved on May 17, 2000, as amended by Ordinance 68202, approved
4 December 8, 2008 and in lieu thereof a new paragraph is enacted extending the period of time
5 during which the Central West End North Special Business District shall be permitted to
6 collect the tax within the boundaries of the district therein established; submitting to the
7 qualified voters residing in the Central West End North Special Business District a proposal
8 to continue the levy of a tax on the real property located in said district for ten years;
9 submitting said proposal to the voters of said district at the General Election on April 2, 2019;
10 and containing effectiveness and emergency clauses.

12 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

14 **SECTION ONE.** Paragraph (f) of Section 2 of Ordinance 62622, approved on May 29,
15 1992, as amended by Ordinance 63840, approved on July 19, 1996, as amended by Ordinance
16 64935, approved on May 17, 2000, as amended by Ordinance 68202, approved December 8,
17 2008, is hereby repealed and in lieu thereof a new paragraph (f) of Section 2 of Ordinance
18 62622 is enacted to be and read as follows:

19 c. The tax provided for by this ordinance shall only be levied and collected for tax
20 years 2019, 2020, 2021, 2022, 2023, 2024, 2025, 2026, 2027 and 2028.

2 **SECTION TWO.** The continuation of the tax levy authorized in Section One of this
3 ordinance shall not be effective unless and until the following proposition, submitted to the
4 qualified voters residing in the District at an election in the District to be held on April 2,
5 2019, shall receive in its favor the votes of the majority of the qualified voters voting at said
6 election for or against said proposition, the tax as set forth within said proposition shall be
7 authorized and adopted and become part of the laws of the City of St. Louis from the date of
8 said election. The qualified voters may, at such election, vote a ballot substantially the
9 following form:

10 **OFFICIAL BALLOT**

11 Shall a tax of \$.85 per \$100.00 valuation be imposed for the tax years 2019, 2020, 2021,
12 2022, 2023, 2024, 2025, 2026, 2027 and 2028 on all real property located in the Central West
13 End North Special Business District as defined in Ordinance No.62622, approved May
14 29,1992, for the purposes as set forth in said Ordinance?

18 **SECTION THREE.** Notice of the election on such proposition shall be published and said
19 election shall be conducted in the manner provided by law.

1 **SECTION FOUR.** Immediately upon the passage and approval of this Ordinance, the City
2 Register shall certify a copy thereof to the Board of Election Commissioners for the City of
3 St. Louis for action and proceedings by said Board in accordance herewith and as required by
4 law.

6 **SECTION FIVE.** This being an ordinance to set a tax levy and for the immediate
7 preservation of public peace, health and safety, it is declared to be an emergency measure
8 within the meaning of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis
9 and therefore this ordinance shall become effective upon its passage and approval by the
10 Mayor.
