

ORDINANCE 70973

BOARD BILL NO. 22 INTRODUCED BY: ALDERWOMAN CAROL HOWARD

1 An ordinance pertaining to parking within the "5347 Nottingham Parking District;"
2 establishing the location and restrictions for curb parking in the restricted parking zone within
3 the "5647 Nottingham Parking District;" authorizing the placement of Permit Parking Only
4 signs within the District; and prohibiting the parking, within the District, of any vehicle which
5 does not display the authorized permit; containing definitions, a penalty clause and an
6 emergency clause.

8 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

10 **SECTION ONE.** Definitions.

11 A. The "5347 Nottingham Residential Parking District" is the area along the
12 north curb line of Nottingham, beginning immediately east of Macklind
13 and continuing east along the north curb line to the property line of 5347
14 Nottingham; is the area along the east curb line of Macklind, beginning
15 immediately north of Nottingham and continuing north along the east curb
16 line to the property line of 5347 Nottingham.

18 B. "Parking permit" is a valid parking permit issued separately for the district
19 by the Traffic and Transportation Administrator of the City of St. Louis or
20 its designees.

1 C. "Resident" is a person who resides in a dwelling located at 5347
2 Nottingham.

3
4 D. "Restricted parking zone" is the sections and portions of the 5347
5 Nottingham Parking District within the District which is designated and
6 posted as a restricted parking zone with specific parking restrictions.

7
8 E. "Visitor" is any person who is a household guest, a visitor, a worker
9 performing services for, or domestic help for, a resident of 5347
10 Nottingham.

12 **SECTION TWO.** Designation of restricted parking zone. The entire 5347
13 Nottingham Parking District is hereby established as an independent restricted parking
14 zone.

15 **SECTION THREE.** Permit use. Signs are to be erected in the District designating
16 "Permit Parking Only" which state the following restrictions:

17 For 5347 Nottingham Parking District, restricted use of parking with
18 permit only are to be posted and no person, firm or corporation shall park
19 or cause to be parked any vehicle in the restricted parking zone that does
20 not display a valid parking permit for the 5347 Nottingham Parking
21 District.

SECTION FOUR. Permit issuance. Permits may be issued to employees and residents per the following guidelines:

A. For the 5347 Nottingham Parking District, the Traffic and Transportation Administrator may issue annual parking permits to:

(1) persons residing in dwellings located in 5347 Nottingham Avenue the district at a rate of \$0.00 per annum for residents.

The Traffic and Transportation Administrator may contract with an individual or entity at no cost to the City for the procurement, assignment and distribution of said annual parking permits, and the procurement and installation of said signs.

SECTION FIVE. Penalty for violation.

A. Any person, firm or corporation who shall park or cause to be parked any vehicle in violation of the provisions of this ordinance shall upon the conviction thereof be fined twenty dollars (\$20.00) for each such offense.

B. Any person, firm or corporation who shall distribute a standard or visitor parking permit to any person, firm or corporation not authorized to display such parking permit shall have his or her parking permits suspended by the Traffic and Transportation Administrator for a period not to exceed one year.

1 **SECTION SIX. EMERGENCY CLAUSE.** This being an ordinance for the
2 preservation of public peace, health, and safety, it is hereby declared to be an
3 emergency measure within the meaning of Sections 19 and 20 of Article IV of the
4 Charter of the City of St. Louis and therefore shall become effective immediately upon
5 its passage and approval by the
