4 An ordinance submitting to the qualified voters residing in the Tower Grove South
5 Concerned Citizens Special Business District Special Business District as designated in
6 Ordinance No. _____, approved June __, 2008 (Board Bill No. 89) a proposal to
7 renew and continue the levy a tax on the real property located in said district; submitting
8 said proposal to the voters of said district at an Election on November 4, 2008; and
9 containing an emergency clause.

10 BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

11 SECTION ONE. The following proposition is hereby submitted to the qualified voters
12 residing in the Tower Grove South Concerned Citizens Special Business District Special
13 Business District, as designated in Ordinance No. _____, approved June __ 2008,
14 (Board Bill No. 89)and shall be voted upon at the election to be held as hereinafter
15 provided. The proposition shall read substantially in words and figures as follows:

16 Shall a tax not to exceed \$.85 per \$100.00 valuation be imposed for the tax years
17 2009, 2010, 2011, 2012 and 2013 on all real property located in the Tower Grove South
18 Concerned Citizens Special Business District as defined in Ordinance No. _____,
19 approved June __, 2008, (Board Bill No. 89) for the purposes as set forth in said
20 Ordinance?

21 SECTION TWO. The foregoing proposition shall be submitted to qualified voters
22 residing in the Tower Grove South Concerned Citizens Special Business District at a
23 special election in said District to be held on Tuesday, November 4, 2008. If the
24 proposition shall receive in its favor the votes of the majority of the qualified voters
25 voting at said election for or against said proposition, the tax as set forth within said

1 proposition shall be authorized and adopted and become part of the laws of the City of St.
2 Louis from the date of said election. The qualified voters may, at such election, vote a
3 ballot substantially in the following form:

5 Shall a tax not to exceed \$.85 per \$100.00 valuation be imposed for the tax years 2009,
6 2010, 2011, 2012 and 2013 on all real property located in the Tower Grove South
7 Concerned Citizens Special Business District as defined in Ordinance No. _____,
8 approved June ____ 2008, (Board Bill No.89) for the purposes as set forth in said
9 Ordinance?

12 SECTION THREE. Notice of the election on such proposition shall be published and said
13 election shall be conducted in the manner provided by law.

14 SECTION FOUR. Immediately upon the passage and approval of this Ordinance, the
15 City Register shall certify a copy thereof to the Board of Election Commissioners for the
16 City of St. Louis for action and proceedings by said Board in accordance herewith and as
17 required by law.

18 SECTION FIVE. This being an ordinance calling and providing for an election and vote
19 by the people and fixing a tax rate, it is declared to be an emergency measure as defined
20 by Article IV, Sections 19 and 20 of the Charter of the City of St. Louis and shall take
21 effect and be in force from and after its adoption and approval by the Mayor.
