

St. Louis City Ordinance 62352

FLOOR SUBSTITUTE

BOARD BILL NO. [91] 113

INTRODUCED BY ALDERMAN JO ANNE WAYNE

An ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing a Fourteenth Supplemental Appropriation in the total amount of Two Million Seven Hundred Sixty Two Thousand Dollars, (\$2,762,000.00) from the Airport Construction Fund and the Airport Development Fund into Ordinance 58493 approved February 26, 1982 for the payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 58493 as amended authorized the acquisition of property in Kinloch at a revised total estimated cost of Thirty Nine Million Five Hundred Thousand Dollars (\$39,500,000.00), made an initial appropriation of Two Million Dollars (\$2,000,000.00), and made provision for supplemental appropriations; and

WHEREAS, Ordinance 58798, 59044, 59399, 59594, 59890, 60111, 60272, 60440, 60662, 60808, 61590, 62023, and 62089 made supplemental appropriations in the amount of Twenty Million, Nine Hundred Thousand Dollars, (\$20,900,000.00); and

WHEREAS, it is now necessary to authorize a Fourteenth supplemental appropriation in the amount of Two Million Seven Hundred Sixty Two Thousand Dollars (\$2,762,000.00) in order to continue said program.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. There is hereby authorized a Fourteenth supplemental appropriation in the total amount of Two Million Seven Hundred Sixty Two Thousand Dollars, (\$2,762,000.00), the aforementioned supplemental appropriation to be derived as follows:

\$1,762,000.00 from the Airport Construction Fund and \$1,000,000.00 from the Airport Development Fund for a Total Amount of \$2,762,000.00 for this Supplemental Appropriation into Ordinance 58493 approved February 26, 1982 for payment of cost authorized therein.

SECTION TWO. This being an Ordinance providing additional funds for a Public Works and Expansion Program is hereby declared to be an emergency measure as defined in Article IV, Section 20, of the City Charter and shall become effective immediately upon approval of the Mayor of the City of St. Louis.
