

## *St. Louis City Ordinance 62430*

FLOOR SUBSTITUTE

BOARD BILL NO. [91] 246

INTRODUCED BY ALDERMAN Fred Wessels

An Ordinance authorizing and directing the Health Commissioner, on behalf of the City of St. Louis, to enter into and execute an Agreement with the Missouri Department of Health for a grant to fund services of nutrition, food outreach, transportation and housing referral under the HIV Care Consortium component of Ryan White Title II Care Act of 1990 and authorizing the Health Commissioner on behalf of the City, upon approval of the Board of Estimate and Apportionment, to expend the funds by entering into contracts or otherwise for services of nutrition, food outreach, transportation and housing referral under the HIV Care Consortium component of Ryan White Title II Care Act of 1990 and containing an emergency clause.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. The Health Commissioner is hereby authorized and directed, on behalf of the City of St. Louis, to enter into and execute an Agreement with the Missouri Department of Health for a grant to fund services of nutrition, food outreach, transportation and housing referral under the HIV Care Consortium component of Ryan White Title II Care Act of 1990. Said Agreement shall substantially in words and figures as the attached Agreement, which is made part of this Ordinance and is on file in the Register's Office.

SECTION TWO. The Health Commissioner is hereby authorized and directed, upon approval of the Board of Estimate and Apportionment, to expend the funds received pursuant to the Agreement in a manner that is consistent with the provisions of said Agreement.

SECTION THREE. Emergency Clause. This being an Ordinance for the immediate preservation of public peace, health and safety, it is hereby declared to be an immediate measure within the meaning of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore this Ordinance shall become effective immediately upon its passage and approval by the Mayor.
