

## *St. Louis City Ordinance 62905*

FLOOR SUBSTITUTE

BOARD BILL NO. [93] 46

INTRODUCED BY ALDERMAN JoAnne Wayne

An Ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing an Eighteenth Supplemental Appropriation in the amount of Two Million Dollars (\$2,000,000.00) from the Airport Development Fund into Kinloch Land Acquisition Ordinance 58493 approved February 26, 1982, for the payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 58493 as amended authorized the acquisition of property in Kinloch at a total estimated cost of Thirty Nine Million Five Hundred Thousand Dollars (\$39,500,000.00), and made provision for supplemental appropriations; and

WHEREAS, Ordinance 58798, 59044, 59399, 59594, 59890, 60111, 60272, 60440, 60662, 60808, 61590, 62023, 62089, 62352, 62409, 62678 and 62762 made Supplemental Appropriations in the amount of Twenty eight Million Six Hundred Sixty two Thousand Dollars (\$28,662,000.00); and

WHEREAS, it is now necessary to authorize an Eighteenth Supplemental Appropriation in the amount of Two Million Dollars (\$2,000,000.00) in order to continue said program.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

Section One. There is hereby authorized an Eighteenth Supplemental Appropriation in the total amount of Two Million Dollars (\$2,000,000.00) from the Airport Development Fund into Ordinance 58493 approved February 26, 1982, for payment of costs authorized therein.

Section Two. This being an ordinance providing additional funds for a Public Works and Improvement Program is hereby declared to be an emergency measure as defined in Article IV, Section 20, of the City Charter and shall become effective immediately upon approval of the Mayor of the City of St. Louis.
