

# *St. Louis City Ordinance 62925*

FLOOR SUBSTITUTE

BOARD BILL NO. [93] 10

INTRODUCED BY ALDERMAN Freeman Bosley, Jr.

An ordinance designating a portion of Ward 3 as the Lindell Park; Conservation District, said area being bound as follows:

Beginning at a point of the middle of the intersection of Vandeventer Avenue and Natural Bridge and thence south along the center line of Vandeventer Avenue to its intersection with Greer, and then hence eastwardly along the center line of Greer to its intersection with Prairie and then southwardly along the center line of Prairie Avenue to its intersection with St. Louis Avenue, and thence eastwardly along the center line of St. Louis Avenue and thence eastwardly along the center line of St. Louis Avenue to its intersection with Grand Avenue and then north along the center line of Grand Avenue to its intersection with Sullivan Avenue and thence eastwardly along the center line of Sullivan Avenue to its intersection with Glasgow Avenue and thence northward along the center line of Glasgow Avenue to its intersection with Natural Bridge and from thence westwardly along the center line of Natural Bridge to its intersection with Vandeventer Avenue, the point of beginning.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE: A Housing Conservation District to be known as the Lindell Park Conservation District shall be established for a portion of Ward 3 within the following Boundaries:

Beginning at a point of the middle of the intersection of Vandeventer Avenue and Natural Bridge and thence south along the center line of Vandeventer Avenue to its intersection with Greer, and then hence eastwardly along the center line of Greer to its intersection with Prairie and then southwardly along the center line of Prairie Avenue to its intersection with St. Louis Avenue, and thence eastwardly along the center line of St. Louis Avenue and thence eastwardly along the center line of St. Louis Avenue to its intersection with Grand Avenue and then north along the center line of Grand Avenue to its intersection with Sullivan Avenue and thence eastwardly along the center line of Sullivan Avenue to its intersection with Glasgow Avenue and thence northward along the center line of Glasgow Avenue to its intersection with

Natural Bridge and from thence westwardly along the center line of Natural Bridge to its intersection with Vandeventer Avenue, the point of beginning.
