

## *St. Louis City Ordinance 63198*

FLOOR SUBSTITUTE

BOARD BILL NO. [94] 167

INTRODUCED BY ALDERMAN JO ANNE WAYNE

An Ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing a Fourth Supplemental Appropriation in the amount of One Million Dollars (\$1,000,000.00) from the Airport Development Fund into Robertson Land Acquisition Ordinance 60810, approved April 11, 1988, for payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 60810 authorized an Expansion and Improvement Program at Lambert St. Louis International Airport for noise mitigation purposes at a total estimated cost of Eleven Million Two Hundred Thousand Dollars (\$11,200,000.00), authorized an initial appropriation of Two Million Five Hundred Thousand Dollars (\$2,500,000.00) and provided for supplemental appropriations as funds become available to meet Land Acquisition Schedules; and

WHEREAS, Ordinance 61490 authorized a First Supplemental Appropriation in the amount of Two Million Dollars (\$2,000,000.00), to continue the Program; and

WHEREAS, Ordinance 62912 authorized a Second Supplemental Appropriation in the amount of Two Million Dollars (\$2,000,000.00), to continue the Program; and

WHEREAS, Ordinance 63085 authorized a Third Supplemental Appropriation in the amount of One Million Two Hundred Thousand Dollars (\$1,200,000.00) to continue the Program; and

WHEREAS, it is now necessary to authorize a Fourth Supplemental Appropriation in the amount of One Million Dollars (\$1,000,000.00) to continue the Program.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

Section One. There is hereby established a Fourth Supplemental Appropriation in the total amount of One Million Dollars (\$1,000,000.00) from the Airport

Development Fund into Robertson Land Acquisition Ordinance 60810 approved April 11, 1988, for payment of cost authorized therein.

Section Two. This being an ordinance providing additional funds for a Public Work and Expansion Program, it is hereby declared to be an emergency measure as defined in Article IV, Section 20, of the City Charter and shall become effective immediately upon approval of the Mayor of the City of St. Louis.
