

St. Louis City Ordinance 63519

FLOOR SUBSTITUTE

BOARD BILL NO. [95] 84

INTRODUCED BY ALDERMAN ALFRED WESSELS JR.

An ordinance amending Ordinance No. 61398, approved June 27, 1989, as amended by Ordinance No. 62567, approved April 6, 1992, now codified as Chapter 8.109 of the Revised Code of the City of St. Louis 1994 (the "Code"), pertaining to the regulation of vendors at fairs and festivals; amending Section One of said Ordinance No. 61398, as amended and now codified as Section 8.109.010 of the Code, requiring registration of vendors at fairs and festivals, by repealing Section One of said Ordinance No. 63198 and enacting in lieu thereof a new Section One of said Ordinance No. 61398 pertaining to the same subject matter, but exempting vendors at fair and festivals which are two (2)-calendar days or less from registration and payment of a registration fee; amending Section Two of said Ordinance No. 61398, as amended and now codified as Section 8.109.020 of the Code, by repealing Section Two of said Ordinance No. 61398, which provides for a registration certificate, a thirty-five dollar (\$35.00) registration fee, and a one (1)-day registration certificate, and enacting in lieu thereof a new Section Two pertaining to the same subject matter, but deleting the provision for issuance of a one (1)-day registration certificate; providing authorization for the License Collector to promulgate rules and regulations necessary to administer the provisions of said Ordinance No. 61398 as amended and now codified as Chapter 8.109 of the Code and as amended by this Ordinance; and containing an emergency clause.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. Section One of Ordinance No. 61398, approved June 27 1989, as amended by Ordinance No. 62567, approved April 6, 1992, and now codified as Section 8.109.010 of the Revised Code of the City of St. Louis 1994 (the "Code") is hereby amended by deleting Section One of said Ordinance No. 61398, and enacted in lieu thereof is the following new Section One of said Ordinance No. 61398, which shall read as follows and be codified as Section 8.109.010 of the Code: Section One. Any person who sells or offers for sale any goods, wares, merchandise, food, or beverages at a fair or festival must register with the License Collector, and the License Collector shall issue a certificate of registration; provided, however, that a vendor at a fair or festival

which is two (2)-calendar days or less shall be exempt from said registration requirement and from payment of the registration fee as required herein.

SECTION TWO. Section Two of Ordinance No. 61398, approved June 27, 1989, as amended by Ordinance No. 62567, approved April 6, 1992, and now codified as Section 8.109.020 of the Code, is hereby amended by deleting said Section Two of said Ordinance No. 61398, and enacted in lieu thereof is the following new Section Two of said Ordinance No. 61398, which shall read as follows and be codified as Section 8.109.020 of the Code: Section Two. The Certificate of Registration shall be valid for any fifteen (15) days of a calendar year, and there shall be a thirty-five dollar (\$35.00) registration fee.

SECTION THREE. The License Collector is authorized to promulgate rules and regulations necessary for the administration and enforcement of the provisions of said Ordinance No. 61378, as amended and now codified as Chapter 8.109 of the Code and as amended by this Ordinance.

SECTION FOUR. This being an Ordinance for the preservation of the public peace, health and safety, it is hereby declared to be an emergency measure within the meaning of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore this Ordinance shall become effective immediately upon its passage and approval by the Mayor or its approval over his veto.
