

St. Louis City Ordinance 63647

FLOOR SUBSTITUTE

BOARD BILL NO. [95] 265

INTRODUCED BY ALDERMAN MARY ROSS

An ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing a third supplemental appropriation in the amount of Eight Hundred Thousand Dollars (\$800,000.00) from the Airport Development Fund into Ordinance 61273, approved February 15, 1989, for the payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 61273, approved February 15, 1989, authorized a Public Work and Improvement Program at Lambert St. Louis International Airport providing for the acoustical treatment of approximately 15 educational institutions for noise mitigation purposes ("the Program") at a total estimated cost of Six Million Five Hundred Thousand Dollars (\$6,500,000.00), authorized an initial appropriation of One Million, Five Hundred Thousand Dollars (\$1,500,000.00), provided for supplemental appropriations as funds become available to continue the Program and contained an emergency clause; and

WHEREAS, Ordinance 61958, approved April 12, 1990, authorized a first supplemental appropriation in the amount of One Million, Five Hundred Thousand Dollars (\$1,500,000.00), to continue the Program and contained an emergency clause; and

WHEREAS, Ordinance 63058, approved December 22, 1993, authorized a second supplemental appropriation in the amount of Five Hundred Thousand Dollars (\$500,000.00) to continue the Program and contained an emergency clause.

WHEREAS, it is now necessary to authorize a third supplemental appropriation in the amount of Eight Hundred Thousand Dollars (\$800,000.00) to continue the Program.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. There is hereby authorized a third supplemental appropriation in the amount of Eight Hundred Thousand Dollars (\$800,000.00) from the Airport Development Fund established under authority of Ordinance 59286, Section 13, approved October 26, 1984, into Ordinance 61273 approved February 15, 1989, for payment of costs authorized therein.

SECTION TWO. This being an ordinance providing additional funds for Public Work and Improvement, it is hereby declared to be an emergency measure as defined in Article IV, Section 20, of the City Charter and shall become effective immediately upon approval of the Mayor of the City of St. Louis.
