

St. Louis City Ordinance 63681

FLOOR SUBSTITUTE

BOARD BILL NO. [95] 247

INTRODUCED BY ALDERMAN NANCY WEBER

An ordinance to amend Exhibit "A" of Board Bill 322 and Ordinance No. 63409 and the legal description of "The Blighting Study and Plan for the N. Broadway/Douglass Area" and to properly identify the property located within the N. Broadway/Douglass Area with the correct legal description to read as follows:

Portions of City Blocks 2492 and 2493 in the City of St. Louis, Missouri, and being more particularly described as follows:

Beginning at the point of the east line of Broadway, 80 feet wide, with the south line of Bissell Street, 50 feet wide; thence east along the south line of Bissell Street 160 feet to the east line of the existing north/south alley, 20 feet wide, in City Blocks 2492 and 2493, thence southwardly along the east line of said north/south alley, across Douglass St., 50 feet wide, 371 feet to the south line of property owned now or formerly by John R. and Marlene Mueller, thence westwardly along said property line to the east line of N. Broadway, thence north along the east line of N. Broadway, across Douglass St., 50 feet wide, to the point of beginning.

WHEREAS, an incorrect legal description was printed in the preparation of Board Bill 322 and erroneously carried forward into Ordinance No. 63409.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

20 Exhibit "A" of Ordinance No. 63409 and of the original Board Bill 322 and the legal description of "The Blighting Study and Plan for the N. Broadway/Douglass Area" is hereby amended to read as follows:

Beginning at the point of the east line of Broadway, 80 feet wide, with the south line of Bissell Street, 50 feet wide; thence east along the south line of Bissell Street 160 feet to the east line of the existing north/south alley, 20 feet wide, in City Blocks 2492 and 2493, thence southwardly along the east line of said north/south alley, across Douglass St., 50 feet wide, 371 feet to the south

line of property owned now or formerly by John R. and Marlene Muellr, thence westwardly along said property line to the east line of N. Broadway, thence north along the east line of N. Broadway, across DouglassSt., 50 feet wide, to the point of beginning.
