

St. Louis City Ordinance 63765

FLOOR SUBSTITUTE

BOARD BILL NO. [95] 262

INTRODUCED BY ALDERMAN MARY ROSS

An Ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing a Twenty Second Appropriation in the amount of Two Million Dollars (\$2,000,000) from the Airport Development Fund into Kinloch Land Acquisition Ordinance 58493 approved February 26, 1982 as amended by Ordinance 62089 approved October 3, 1990 and Ordinance 63505 approved July 10, 1995, for the payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 58493 approved February 26, 1982, as amended by Ordinance 62089 approved October 3, 1990, authorized the acquisition of property in Kinloch at a total estimated cost of Thirty-Nine Million, Five Hundred Thousand Dollars (\$39,500,000), made an initial appropriation of Two Million Dollars (\$2,000,000), made provision for supplemental appropriations, and contained an emergency clause; and

WHEREAS, Ordinance 63505 approved July 10, 1995, which amended Ordinance 58493 approved February 26, 1982 as amended by Ordinance 62089 approved October 3, 1990, authorized the acquisition of property in Kinloch at a total estimated cost of this project to Seventy-Five Million Dollars (\$75,000,000), amended the legal description of the real property to be acquired for the Airport Noise Project as contained in Section Two of Ordinance 62089 approved October 3, 1990, and contained an emergency clause; and

WHEREAS, Ordinances 58798, 59044, 59399, 59594, 59890, 60111, 60272, 60440, 60662, 60808, 61590, 62023, 62089, 62352, 62409, 62678, 62762, 62905, 63128, 63328 and 63505 made Supplemental Appropriations in the total amount of Thirty-Five Million, Six Hundred & Sixty-Two Thousand Dollars (\$35,662,000) to continue the Kinloch Land Acquisition Program; and

WHEREAS, it is now necessary to authorize a Twenty-Second Supplemental Appropriation in the amount of Two Million Dollars (\$2,000,000), in order to continue the Kinloch Land Acquisition Program.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. There is hereby authorized a Twenty-Second Supplemental Appropriation in the amount of Two Million Dollars (\$2,000,000), from the Airport Development Fund established under authority of Ordinance 59286, Section 13 approved October 26, 1984 into Kinloch Land Acquisition Ordinance 58493 approved February 26, 1982 as amended by Ordinance 62089 approved October 3, 1990 and Ordinance 63505 approved July 10, 1995, for payment of costs authorized therein.

SECTION TWO. This being an ordinance providing additional funds for a Public Works and Improvement Program, it is hereby declared to be an emergency measure as defined in Article IV, Section 20, of the City Charter and shall become effective immediately upon approval of the Mayor of the City of St. Louis.
