

## *St. Louis City Ordinance 63774*

FLOOR SUBSTITUTE

BOARD BILL NO. [96] 46

INTRODUCED BY ALDERMAN JAMES C. SONDERMANN , STEPHEN GREGALI

An ordinance pertaining to speed limits for vehicles, repealing Section 824.040 of Ordinance 57831, approved on April 19, 1979, as codified in Chapter 17.10.040 Revised Code of the City of St. Louis, allowing for the enforcement of speed limits for vehicles, as designated by the Traffic and Transportation Division or the Missouri State Highway Department, upon the roadways within the City of St. Louis, and containing an emergency clause.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. Section 824.040 of Ordinance 57831, approved on April 19, 1979 is hereby repealed.

SECTION TWO. A new section, to be codified as Chapter 17.10.040 of the Revised Code of the City of St. Louis, is hereby enacted as follows: 17.10.040 Posted Speed Limits.

Upon sections of roadways which shall be posted by the traffic and transportation division or the State Highway Commission designating the maximum speed, the speed shall be as indicated in the following schedules, and it shall be unlawful to operate a vehicle in excess of said posted maximum speed limits:

- A. 30 Miles per hour, both day and night;
- B. 35 Miles per hour, both day and night;
- C. 40 Miles per hour, both day and night;
- D. 45 Miles per hour, both day and night;
- E. 50 Miles per hour, both day and night;
- F. 55 Miles per hour, both day and night;
- G. 60 Miles per hour, both day and night;

**SECTION THREE. EMERGENCY CLAUSE.**

This being an ordinance for the preservation of public peace, health, and safety, it is hereby declared to be an emergency measure within the meaning of Sections 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore shall become effective immediately upon its passage and approval by the mayor.
