

## *St. Louis City Ordinance 63833*

FLOOR SUBSTITUTE

BOARD BILL NO. [96] 136

INTRODUCED BY ALDERMAN MARY ROSS

An Ordinance recommended and approved by the Board of Estimate and Apportionment authorizing and directing the Director of Airports and the Comptroller of the City of St. Louis (the "City") to enter into and execute on behalf of the City a first amendment to the Concession Agreement for Passenger Vehicle Rental between the City and Auto Rental, Inc., d/b/a National Car Rental (the "Concessionaire") dated January 28, 1994, which was authorized under Ordinance 63053 approved December 22, 1993; this first amendment approved by the Airport Commission and the Board of Estimate and Apportionment which is attached hereto as Exhibit 1 and made a part hereof, grants to the Concessionaire the right to bus customers to an Off Airport Facility for the purpose of performing customer rental activities or transactions; and containing an emergency clause;

WHEREAS, the City of St. Louis (the "City") and Auto Rental, Inc., d/b/a National Car Rental (the "Concessionaire") are parties to a Concessionaire Agreement for Passenger Vehicle Rental dated January 28, 1994 (the "Agreement"), authorized by Ordinance 63053 approved December 22, 1993;

WHEREAS, the Agreement was originally entered into by the City and the Concessionaire for a five year period to provide passenger vehicle rental services with provisions precluding the transporting of customers by any means, off the premises, for the purpose of performing any customer rental activities or transactions;

WHEREAS, the City and Concessionaire agree that by granting the Concessionaire the right to bus customers to an Off Airport Facility for the purpose of performing customer rental activities or transactions, on premises congestion will decrease;

WHEREAS, the City and Concessionaire desire to amend the Agreement to their mutual benefit to provide for the aforementioned change by amending Sections 101, 201, 301, 503 and 1301.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. The Director of Airports and the Comptroller are hereby authorized and directed to enter into and execute on behalf of the City of St. Louis, a first amendment to a certain Concessionaire Agreement for Passenger Vehicle Rental dated January 28, 1994, with Auto Rental, Inc., d/b/a National Car Rental, authorized under Ordinance 63053 approved December 22, 1993; this first amendment approved by the Airport Commission and the Board of Estimate and Apportionment to read in words and figures as set out in Exhibit 1 which is attached hereto and made a part hereof.

SECTION TWO. This being an Ordinance for the preservation of public peace, health, or safety, it is hereby declared an emergency measure as designed in Article IV, Section 20 of the City Charter and shall become effective immediately upon its approval by the Mayor of the City of St. Louis.
