

## *St. Louis City Ordinance 63876*

FLOOR SUBSTITUTE

BOARD BILL NO. [96] 205

INTRODUCED BY ALDERMAN MARY ROSS

An Ordinance recommended and approved by the Board of Estimate and Apportionment authorizing and directing the Director of Airports and the Comptroller of the City of St. Louis (the "City") to enter into and execute on behalf of the City a first amendment to the Lambert-St. Louis International Airport (the "Airport") Operating Agreement for Public Parking Facilities between the City and APCOA-SRP Parking V, (the "Operator") dated May 1, 1992 (the "Agreement") which was authorized under Ordinance 62607 approved April 7, 1992; this first amendment, approved by the Airport Commission and the Board of Estimate and Apportionment which is attached hereto as Exhibit 1 and made a part hereof, extends the term of the Agreement to April 30, 2000 and adds the management of the Airport's employee parking facilities to the Operator's responsibilities under the Agreement; and containing an emergency clause.

WHEREAS, the City of St. Louis (the "City") and APCOA-SRP V, (the "Operator") are parties to an Operating Agreement for Public Parking Facilities dated May 1, 1992 (the "Agreement"), authorized by Ordinance 62607 approved April 7, 1992;

WHEREAS, the Agreement was originally entered into by the City and the Operator for a three year period, with two one year option periods which have been exercised by the City, to operate the public parking facilities at Lambert-St. Louis International Airport (the "Airport");

WHEREAS, the continuity of quality in the Airport's parking operation is critical during certain terminal and parking construction projects;

WHEREAS, the Airport desires to extend the term of the Agreement to April 30, 2000 and add the management of the Airport's employee parking facilities to the Operator's responsibilities under the Agreement;

WHEREAS, the City and Operator desire to amend the Agreement to their mutual benefit to provide for the aforementioned changes.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. The Director of Airports and the Comptroller are hereby authorized and directed to enter into and execute on behalf of the City of St. Louis (the "City"), a first amendment to a certain Lambert-St. Louis International Airport (the "Airport") Operating Agreement for Public Parking Facilities between the City and APCOA-SRP Parking V, (the "Operator") dated May 1, 1992 (the "Agreement") which was authorized under Ordinance 62607 approved April 7, 1992; this first amendment, approved by the Airport Commission and the Board of Estimate and Apportionment to read in words and figures as set out in Exhibit 1 which is attached hereto and made a part hereof.

SECTION TWO. This being an Ordinance for the preservation of public peace, health, or safety, it is hereby declared an emergency measure as designed in Article IV, Section 20 of the City Charter and shall become effective immediately upon its approval by the Mayor of the City of St. Louis.
