

St. Louis City Ordinance 64477

FLOOR SUBSTITUTE

BOARD BILL NO. [98] 142

INTRODUCED BY ALDERMAN ROBERT RUGGERI

An Ordinance recommended by the Airport Commission and the Board of Estimate and Apportionment authorizing a Third Supplemental Appropriation in the amount of Three Million Dollars (\$3,000,000) from the Passenger Facility Charge Fund established under authority of Ordinance 62501, Section 6, approved February 10, 1992, into the Ferguson Land Acquisition Ordinance 63937 approved December 11, 1996, for the payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 63937 approved December 11, 1996, authorized a multi-year Expansion and Improvement Program (the "Program") at Lambert-St. Louis International Airport for the acquisition of certain real and personal property rights for noise mitigation purposes and other necessary work and services related to the Program at a total estimated cost of Twelve Million Dollars (\$12,000,000), made an initial appropriation of One Million Five Hundred Thousand Dollars (\$1,500,000) for costs authorized therein, made provision for supplemental appropriations as needed to continue the Program, and contained an emergency clause; and

WHEREAS, Ordinance 64066 approved May 28, 1997, authorized the First Supplemental Appropriation in the total amount of Three Million Five Hundred Thousand Dollars (\$3,500,000) from the Passenger Facility Charge Fund into Ordinance 63937 to continue the Program authorized therein; and

WHEREAS, Ordinance 64354 approved April 2, 1998, authorized the Second Supplemental Appropriation in the total amount of Three Million Dollars (\$3,000,000) from the Passenger Facility Charge Fund into Ordinance 63937 to continue the Program authorized therein; and

WHEREAS, it is now necessary to authorize a Third Supplemental Appropriation in the amount of Three Million Dollars (\$3,000,000) into the Ferguson Land Acquisition Ordinance 63937 in order to continue the Program authorized therein.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. There is hereby authorized a Third Supplemental Appropriation in the total amount of Three Million Dollars (\$3,000,000) from the Passenger Facility Charge Fund established under authority of Ordinance 62501, Section 6, approved February 10, 1992, into the Ferguson Land Acquisition Ordinance 63937 approved December 11, 1996, for the payment of costs authorized therein.

SECTION TWO. This being an ordinance providing additional funds for a public works and improvement program, it is hereby declared to be an emergency measure as defined in Article IV, Sections 19 and 20, of the City Charter and shall become effective immediately upon approval by the Mayor of the City of St. Louis.
