

## *St. Louis City Ordinance 64552*

FLOOR SUBSTITUTE

BOARD BILL NO. [98] 168

INTRODUCED BY ALDERMAN PHYLLIS YOUNG

An ordinance recommended by the Board of Public Service declaring the public necessity of acquiring certain land for use as a public parking garage of not less than two hundred (200) spaces to be known as the Criminal Justice Center Parking Garage and other municipal uses and authorizing the acquisition, by purchase or by condemnation proceedings, of parcels 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, and 41 in City Block 206 S for the above stated purpose and containing an emergency clause.

BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

Section One. Upon the recommendation of the Board of Public Service the acquisition of the following described real estate to be used as the site for a public parking garage and/or other municipal facility for the City of St. Louis by the City Treasurer's Office or any other department of the City of St. Louis is hereby authorized:

Lots 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, and 41 of the Henry Chouteau Estate in Block 206 South of the City of St. Louis and more or less bounded North by the South line of the East West alley in said City Block 206 South, on the South by the North line of Clark Street, and East by the West line of Eleventh Street and West by the East line of Tucker (formerly 12th Street) Blvd.

Section Two. If the above described property or any part thereof cannot be obtained by purchase from the owners thereof, the City Counselor is hereby directed to take such steps as are necessary to acquire such property, or interests therein, including condemnation proceedings.

Section Three. This being an ordinance deemed necessary for the immediate preservation of the public health and to provide for a public work and improvement, it is hereby declared to be an emergency measure and shall become effective immediately upon its passage and approval by the Mayor.
