

## *St. Louis City Ordinance 65012*

FLOOR SUBSTITUTE  
BOARD BILL NO. [00] 82

INTRODUCED BY ALDERMAN JAMES F. SHREWSBURY

An ordinance recommended and approved by the Airport Commission and the Board of Estimate and Apportionment authorizing a Fifth Supplemental Appropriation in the amount of Six Million Dollars (\$6,000,000) from the Airport Passenger Facility Charge Fund Account into the Master Plan Implementation Contract Ordinance 63873 approved November 11, 1996, as amended by Ordinance 64096 approved July 1, 1997 and Ordinance 64599 approved February 18, 1999, for the payment of cost authorized therein; and containing an emergency clause.

WHEREAS, the Master Plan Implementation Contract Ordinance 63873 approved November 11, 1996, authorized the Board of Public Service with the advice, consent, and approval of the Director of Airports to let contracts, purchase materials and equipment, employ persons, pay salaries and fees, and otherwise provide for the pre-design and pre-program management services, program management services, and the final processing and the implementation of the Airport Layout Plan as approved by the Federal Aviation Administration, at an estimated total cost of Forty Million Dollars (\$40,000,000), authorized an initial appropriation of Three Million Dollars (\$3,000,000), and contained an emergency clause;

WHEREAS, Ordinance 64096 approved July 1, 1997 amended Section Two of Ordinance 63873 approved November 11, 1996, expressly providing for supplemental appropriations as funds become available in order to continue the program and the payment of cost authorized therein and authorized a First Supplemental Appropriation of Six Million Dollars (\$6,000,000) for the payment of cost authorized therein, and contained an emergency clause;

WHEREAS, Ordinance 64377 approved June 5, 1998, authorized a Second Supplemental Appropriation in the amount of Eight Million Dollars (\$8,000,000) for the payment of cost authorized therein and contained an emergency clause;

WHEREAS, Ordinance 64599 approved February 18, 1999, amended Section Five of Ordinance 63873 as amended by Ordinance 64096, expressly authorizing the deposit of certain funds or reimbursements into Ordinance 63873 as amended to reimburse in part the cost of the work or projects authorized therein and authorized a Third Supplemental Appropriation of Five Million Dollars (\$5,000,000) for the payment of cost authorized therein, and contained an emergency clause;

WHEREAS, Ordinance 64778 approved November 18, 1999, authorized a Fourth Supplemental Appropriation in the amount of Four Million Dollars (\$4,000,000) for the payment of cost authorized therein and contained an emergency clause; and

WHEREAS, it is now necessary to authorize a Fifth Supplemental Appropriation in the amount of Six Million Dollars (\$6,000,000) from the Passenger Facility Charge Fund Account established under authority of Ordinance No. 62501, Section 6, Approved February 10, 1992, into the Master Plan Implementation Contract Ordinance 63873 as previously amended in order to continue the program and the payment of cost authorized therein.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. There is hereby authorized a Fifth Supplemental Appropriation in the total amount of Six Million Dollars (\$6,000,000) from the Passenger Facility Charge Fund Account established under authority of Ordinance No. 62501, Section 6, Approved February 10, 1992, into the Master Plan Implementation Contract Ordinance 63873 approved November 11, 1996, as amended by Ordinance 64096 approved July 1, 1997 and Ordinance 64599 approved February 18, 1999, for the payment of cost authorized therein.

SECTION TWO. This being an Ordinance providing for a public works and improvement program, it is hereby declared to be an emergency measure as defined in Article IV, Section 20, of the City Charter and shall become effective immediately upon approval by the Mayor of the City of St. Louis.
