

St. Louis City Ordinance 65024

FLOOR SUBSTITUTE
BOARD BILL NO. [00] 107

INTRODUCED BY ALDERMAN JAMES F. SHREWSBURY

An ordinance recommended and approved by the Airport Commission and the Board of Estimate and Apportionment authorizing a Twenty Fifth Appropriation in the total amount of Three Million Five Hundred Thousand Dollars (\$3,500,000) from the Passenger Facility Charge Fund established under authority of Ordinance 62501, Section Six, approved February 10, 1992, into the Kinloch Land Acquisition Ordinance 58493 approved February 26, 1982 as amended by Ordinance 62089 approved October 3, 1990, Ordinance 62258 approved March 8, 1991, and Ordinance 63505 approved July 10, 1995, for the payment of costs authorized therein; and containing an emergency clause.

WHEREAS, Ordinance 58493 approved February 26, 1982, as amended by Ordinance 62089 approved October 3, 1990, authorized the acquisition of certain property in Kinloch at a total estimated cost of Thirty Nine Million, Five Hundred Thousand Dollars (\$39,500,000), made an initial appropriation of Two Million Dollars (\$2,000,000) for the payment of costs authorized therein, made provision for supplemental appropriations, and contained an emergency clause;

WHEREAS, Ordinance 62258 approved March 8, 1991, which amended Section Four of Ordinance 58493 as amended, authorized the Board of Public Service to let contracts for the removal of structures and utilities on the acquired real property, authorized the Airport Commission to let contracts and otherwise provide for ground maintenance, and contained an emergency clause;

WHEREAS, Ordinance 63505 approved July 10, 1995, which amended Ordinance 58493 approved February 26, 1982 as amended, authorized the acquisition of certain property in Kinloch at a total estimated cost of this program to Seventy Five Million Dollars (\$75,000,000), amended the legal description of the real property to be acquired for the Airport's noise project as contained in Section Three of Ordinance 58493 as amended, and contained an emergency clause;

WHEREAS, Ordinances 58798, 59044, 59399, 59594, 59890, 60111, 60272, 60440, 60662, 60808, 61590, 62023, 62089, 62352, 62409, 62678, 62762, 62905, 63128, 63328, 63505, 63765, 64065, and 64355 authorized supplemental appropriations in the total amount of Forty Nine Million Six Hundred and Sixty Two Thousand Dollars (\$49,662,000) to continue the program as authorized in Ordinance 58493 as amended; and

WHEREAS, it is now necessary to authorize a Twenty Fifth Supplemental Appropriation in the amount of Three Million Five Hundred Thousand Dollars (\$3,500,000) from the Passenger Facility Charge Fund in order to continue the program as authorized in Ordinance 58493 as amended.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

SECTION ONE. There is hereby authorized a Twenty Fifth Supplemental Appropriation in the amount of Three Million Five Hundred Thousand Dollars (\$3,500,000), from the Passenger Facility Charge Fund established under authority of Ordinance 62501, Section 6, approved February 10, 1992 into Kinloch Land Acquisition Ordinance 58493 approved February 26, 1982 as amended by Ordinance 62089 approved October 3, 1990, Ordinance 62258 approved March 8, 1991, and Ordinance 63505 approved July 10, 1995, for the payment of costs authorized therein.

SECTION TWO. This being an ordinance providing additional funds for a public works and improvement program, it is hereby declared to be an emergency measure as defined in Article IV, Section 20 of the City Charter, and shall become effective immediately upon approval by the Mayor of the City of St. Louis.
