

**BOARD BILL #100      INTRODUCED BY ALDERWOMAN APRIL FORD GRIFFIN**

1    An ordinance authorizing and directing the Mayor and Comptroller of the City of St. Louis to  
2    execute, upon receipt of and in consideration of the sum of One Hundred Thousand Dollars  
3    (\$100,000.00) and other good and valuable consideration, a Quit Claim Deed to remise, release  
4    and forever quit-claim unto Grace Hill Neighborhood Health Centers, Inc., a Missouri non-profit  
5    corporation, certain City-owned property located in City Block 569, which property is known as  
6    1717 Biddle Street, St. Louis, Missouri 63106 (Assessor’s Records 1704-1743 Biddle), and  
7    containing an emergency clause.

8    WHEREAS, the City of St. Louis (“City”) by Ordinance No. 66745 entered into a Lease  
9    Agreement for up to Twenty Five (25) years with Grace Hill Neighborhood Health Centers, Inc.  
10    (sometimes herein called “Grace Hill”), dated October 21, 2005, to secure and provide primary  
11    healthcare, wellness, child day care, adult day care and other social services and to lease the  
12    operation of a medical clinic in the City at 1717 Biddle Street; and

13    WHEREAS, Grace Hill secured a certain grant from HHS, Award No. C8ACS21253-01-00, of  
14    approximately Two Million Two Hundred Thousand Dollars for improvements to said medical  
15    clinic; and

16    WHEREAS, Grace Hill improved said medical clinic with that certain grant and, pursuant to a  
17    First Amendment to the Lease Agreement under Ordinance No. 68856, added certain related  
18    administrative functions and its required information systems in addition to the aforementioned  
19    services; and

1 WHEREAS, Grace Hill will further improve said medical clinic and shall continue to maintain  
2 the secured and provided services, as described herein, and

3 WHEREAS, the City now desires to sell the medical clinic at 1717 Biddle Street to Grace Hill.

4 **NOW THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

5 **SECTION ONE.** The Mayor and Comptroller are hereby authorized and directed to execute,  
6 upon receipt of and in consideration of the sum of One Hundred Thousand Dollars (\$100,000.00)  
7 and other good and valuable consideration, a Quit Claim Deed, attached hereto as **Exhibit A**, to  
8 remise, release and forever quit-claim unto Grace Hill Neighborhood Health Centers, Inc., a  
9 Missouri non-profit corporation, certain City-owned property located in City Block 569, which  
10 property is known as 1717 Biddle Street, St. Louis, Missouri 63106 (Assessor's Records 1704-  
11 1743 Biddle), and which is more fully described in said **Exhibit A**.

12 **SECTION TWO.** Emergency Clause. This ordinance, being necessary for the immediate  
13 preservation of public peace, health, safety, and general welfare, shall be and is hereby declared  
14 to be an emergency measure within the meaning of Sections 19 and 20 of Article IV of the  
15 Charter of the City of St. Louis and, as such, this ordinance shall take effect immediately upon its  
16 passage and approval by the Mayor.
