2 An ordinance authorizing and directing the Mayor and Comptroller of the City of St. Louis to  
3 execute, upon receipt of and in consideration of the sum of Three Thousand One Hundred Dollars  
4 (\$3,100.00) and other good and valuable consideration, a Quit Claim Deed to remise, release and  
5 forever quit-claim unto the STATE OF MISSOURI , certain City-owned property located in City  
6 Block 4879, which property is a parcel of land containing 314 sq. ft. more or less known and  
7 numbered as 4354R West Papin Street 63110.

8 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

9 **SECTION ONE.** The Mayor and Comptroller are hereby authorized and directed to execute, upon  
10 receipt of and in consideration of the sum of Three Thousand One Hundred Dollars (\$3100.00) and  
11 other good and valuable consideration, a Quit Claim Deed, attached hereto as Exhibit A, to remise,  
12 release and forever quit-claim unto, the STATE OF MISSOURI, certain City-owned property  
13 located in City Block 4879, which property is a parcel of land containing 314 sq. ft. more or less,  
14 and which is more fully described in said Exhibit B.

15 **SECTION TWO.** The Mayor and Comptroller of the City or their designated representatives are  
16 hereby authorized and directed to take any and all actions to execute and deliver for and on behalf of  
17 the City any and all additional certificates, documents, agreements or other instruments as may be  
18 necessary, desirable, convenient or proper in order to carry out the matters herein authorized.

### LEGAL DESCRIPTION

The south part of Lot 21 of Dean's Addition and in Block 4879 of the City of St. Louis, beginning at a point in the east line of Tower Grove Avenue 135 feet south of the south line of W.
