

BOARD BILL NO. 163 INTRODUCED BY ALDERMAN TERRY KENNEDY

1 An Ordinance recommended by the Planning Commission on September 5, 2012,
2 to change the zoning of property as indicated on the District Map, from “F”
3 Neighborhood Commercial District to the “C” Multiple-Family Dwelling District, in City
4 Block 4563 (4106 [western portion of parcel only], 4112, 4114-16, 4118, 4122-24 &
5 4126-28 Finney and 4111, 4115-17, 4119, & 4121-23 C D Banks), from “C” Multiple-
6 Family Dwelling District to the “G” Local Commercial & Office District in City Block
7 4564 (3914-16 & 3920-30 Finney) and from “C” Multiple-Family Dwelling District &
8 “G” Local Commercial & Office District to the “G” Local Commercial & Office District
9 only, in City Block 4564 (1037-49 N. Vandeventer) and to change the zoning of property
10 as indicated on the District Map, from “G” Local Commercial & Office District (3900
11 CD Banks and 1015 N. Vandeventer) and “C” Multiple-Family Dwelling District (3906-
12 10, 3912 & 3916 CD Banks) to the “D” Multiple-Family Dwelling District, in City Block
13 4565, so as to include the described parcels of land in City Blocks 4563, 4564 and 4565;
14 and containing an emergency clause.

15 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

16 **SECTION ONE.** The zoning designation of certain real property located in City
17 Block 4563 is hereby changed to the “C” Multiple-Family Dwelling District, in City
18 Block 4564 is hereby changed to the “G” Local Commercial and Office District and in
19 City Block 4565 is hereby changed to the “D” Multiple-Family Dwelling District, real
20 property being particularly described and shown in Exhibit A as follows:


