

BOARD BILL NO. 197 INTRODUCED BY ALDERMAN TERRY KENNEDY

1 An Ordinance, recommended and approved by the Airport Commission, the Board of Public
2 Service, and the Board of Estimate and Apportionment, establishing and authorizing a public works
3 and improvement program (the “Building & Environs Projects”) at Lambert-St. Louis International
4 Airport® (the "Airport"), consisting of capital improvement projects to and for the terminal
5 complexes, concourses, parking facilities, roadways and associated Airport buildings, structures, and
6 facilities, roadways, driveways and environs, and other associated Airport improvements as more
7 fully described in the attached EXHIBIT A, entitled “PROJECT LIST” that is incorporated herein,
8 such authorization including, without limitation, engineering planning and designing services,
9 programming services, technical advice and assistance, inspection services, surveying and
10 mapping services, appraisal services, legal services and related costs, CADD services, the
11 removal or relocation of structures, obstructions, utilities, equipment, and related work, grading
12 and landscaping costs and related work, security services, relocation costs, transportation costs,
13 remediation costs and related work, the demolition of improvements, the costs for the repair,
14 renovation, or relocation of Airport improvements including fixtures and equipment,
15 architectural, engineering and related consultant and management expense pertaining to the
16 planning, design, consulting, installing mock-ups, the preparation and production of contract
17 documents, solicitations, bill of sale, or other agreements or documents, or the advertising and
18 taking of bids, architect and design services, costs for structural and maintenance studies,
19 estimating and cost benefit consulting services, general engineering services, consulting services
20 and other technical advice and assistance, construction management, construction, installation,

1 renovation, rehabilitations, repairs, expansion, reconfiguration, improvement, and inspection
2 work, the equipping and furnishing of Airport property including, without limitation, aircraft
3 rescue firefighter vehicles, runway brooms, supplies, materials and equipment, and other
4 necessary and related work or services for the development, construction, installation,
5 implementation, administration, management or monitoring of the Building & Environs Projects
6 at a total estimated cost of Four Million Two Hundred Fifty Thousand Dollars (\$4,250,000);
7 authorizing an initial appropriation in the total amount of Four Million Two Hundred Fifty
8 Thousand Dollars (\$4,250,000) from the Airport Development Fund established under authority
9 of Ordinance 59286, Section 13, approved October 26, 1984, to be expended for the payment of
10 costs for work and services authorized herein; authorizing the Mayor and the Comptroller of The
11 City of St. Louis (“City”) to enter into and execute on behalf of the City easement agreements
12 granting such easements or right-of-ways as are necessary to the administration or implementation
13 of the Building & Environs Projects and containing such terms, covenants, and conditions that are in
14 the best interest of the City, the City’s residents, and the traveling public; authorizing the Director of
15 Airports with the approval of the Airport Commission and the Board of Estimate and Apportionment
16 to let contracts providing for mapping, appraisal, and escrow services, title work, ground
17 maintenance, security services, legal services, and other related services for the implementation and
18 administration of the Building & Environs Projects; authorizing and directing the Board of Public
19 Service with the advice, consent, and approval of the Director of Airports to let contracts for all
20 other approved work or services, purchase materials, supplies, and equipment, employ labor, pay
21 salaries, wages, fees, retain consultants and otherwise provide for the work or services authorized

1 herein; providing that any contract let hereunder, shall be subject to the City's Charter and
2 applicable City ordinances and Missouri State laws or regulations applicable thereto; authorizing
3 and directing the Comptroller of the City to draw warrants from time to time on the Treasury of the
4 City for payment of expenses authorized herein upon submission of properly certified vouchers in
5 conformance with procedures established by the Comptroller and, authorizing, as necessary and
6 appropriate, the Comptroller, Treasurer, City Counselor, and other appropriate officers, agents and
7 employees of the City to make such applications or certifications and provide such data to the
8 appropriate parties, and to take whatever action necessary in order to provide for the payment or
9 reimbursement of eligible costs authorized herein; authorizing the Director of Airports to make such
10 applications and provide such data and to take whatever action necessary to seek funds under the
11 Airport Improvement Program, the Passenger Facility Charge Program or other federal, state or local
12 programs for projects herein authorized where such costs or expenditures are deemed eligible and
13 monies made available for those costs under federal, state, or local law or contract, and to authorize
14 the deposit of such funds as may be appropriate into this Ordinance to reimburse or pay in part for
15 the costs of the Building & Environs Projects herein authorized; directing that all contracts let under
16 authority of this Ordinance be in compliance with all applicable minority and women or
17 disadvantaged business enterprise requirements and in compliance with all applicable federal, state,
18 and local laws, ordinances, regulations, court decisions and executive orders relating to equal
19 employment opportunity; and containing a severability and an emergency clause.

20 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

21 **SECTION ONE.** There is hereby established and authorized a public works and

1 improvement program (the "Building & Environs Projects") at Lambert-St. Louis International
2 Airport® (the "Airport"), consisting of capital improvement projects to and for the terminal
3 complexes, concourses, parking facilities, and associated Airport buildings, structures, and facilities,
4 roadways, driveways and environs, and other associated Airport improvements as more fully
5 described in the attached EXHIBIT A, entitled "PROJECT LIST" that is incorporated herein, such
6 authorization including, without limitation, engineering planning and designing services,
7 programming services, technical advice and assistance, inspection services, surveying and
8 mapping services, appraisal services, legal services and related costs, CADD services, the
9 removal or relocation of structures, obstructions, utilities, equipment, and related work, grading
10 and landscaping costs and related work, security services, relocation costs, transportation costs,
11 remediation costs and related work, the demolition of improvements, the costs for the repair,
12 renovation, or relocation of Airport improvements including fixtures and equipment,
13 architectural, engineering and related consultant and management expense pertaining to the
14 planning, design, consulting, installing mock-ups, the preparation and production of contract

1 necessary and related work or services for the development, construction, installation,
2 implementation, administration, management or monitoring of the Building & Environs Projects
3 at a total estimated cost of Four Million Two Hundred Fifty Thousand Dollars (\$4,250,000).

4 **SECTION TWO.** There is hereby authorized an initial appropriation in the total amount
5 of Four Million Two Hundred Fifty Thousand Dollars (\$4,250,000) from the Airport Development
6 Fund established under authority of Ordinance 59286, Section 13, approved October 26, 1984,
7 into this Ordinance to be expended for the payment of costs for work and services authorized
8 herein.

9 **SECTION THREE.** The Mayor and the Comptroller of The City of St. Louis (“City”)
10 are hereby authorized to enter into and execute on behalf of the City easement agreements granting
11 such easements or right-of-ways as are necessary to the administration or implementation of the
12 Building & Environs Projects and containing such terms, covenants, and conditions that are in the
13 best interest of the City, the City’s residents, and the traveling public.

14 **SECTION FOUR.** The Director of Airports with the approval of the Airport
15 Commission and the Board of Estimate and Apportionment is hereby authorized to let all contracts
16 providing for mapping, appraisal, and escrow services, title work, ground maintenance, security
17 services, legal services, and other related services for the implementation and administration of the
18 Building & Environs Projects.

19 **SECTION FIVE.** The Board of Public Service with the advice, consent and approval of
20 the Director of Airports is hereby authorized and directed to let contracts, bill of sale or other
21 agreements, purchase materials, supplies, and equipment, employ labor, pay salaries, wages, fees,

1 retain consultants and advisors and otherwise provide for all work or services authorized herein,
2 except for the work or services covered by procedures contained in Section Three and Section Four
3 of this Ordinance.

4 **SECTION SIX.** It is hereby provided that any contract or agreement let hereunder shall
5 be subject to the City's Charter and applicable City ordinances and any Missouri State laws or
6 regulations applicable thereto.

7 **SECTION SEVEN.** The Comptroller of the City is hereby authorized and directed to
8 draw warrants from time to time on the Treasury of the City for payment of expenses authorized
9 herein upon submission of properly certified vouchers in conformance with procedures established
10 by the Comptroller and, as necessary and appropriate, the Comptroller, Treasurer, City Counselor,
11 and other appropriate officers, agents and employees of the City are hereby authorized and directed
12 to make such applications or certifications and provide such data to appropriate parties, and to take
13 whatever action necessary in order to provide for the payment or reimbursement of eligible costs
14 authorized herein.

15 **SECTION EIGHT.** The Director of Airports is hereby authorized to make such
16 applications and provide such data and to take whatever action necessary to seek funds under the
17 Airport Improvement Program, the Passenger Facility Charge Program or other federal, state or local
18 programs for projects herein authorized where such costs or expenditures are deemed eligible and
19 monies made available for those costs under federal, state, or local law or contract, and to authorize
20 the deposit of such funds as may be appropriate into this Ordinance to reimburse or pay in part for
21 the costs of the Building & Environs Projects herein authorized.

1 **SECTION NINE.** All contracts let under authority of this Ordinance shall be in compliance
2 with all applicable minority and women or disadvantaged business enterprise requirements and in
3 compliance with all applicable federal, state and local laws, ordinances, regulations, court decisions
4 and executive orders relating to equal employment opportunity.

5 **SECTION TEN.** The sections or provisions of this Ordinance or portions thereof shall
6 be severable. In the event that any section or provision of this Ordinance or portion thereof is
7 held invalid by a court of competent jurisdiction, such holding shall not invalidate the remaining
8 sections or provisions of this Ordinance unless the court finds the valid sections or provisions of
9 this Ordinance are so essentially and inseparably connected with, and so dependent upon, the
10 illegal, unconstitutional or ineffective section or provision that it cannot be presumed that the
11 Board of Aldermen would have enacted the valid sections or provisions without the illegal,
12 unconstitutional or ineffective sections or provisions; or unless the court finds that the valid
13 sections or provisions, standing alone, are incomplete and incapable of being executed in
14 accordance with the legislative intent.

15 **SECTION ELEVEN.** This being an ordinance providing for public work and improvement,
16 it is hereby declared to be an emergency measure as defined in Article IV, Section 20 of the City's
17 Charter and shall become effective immediately upon its approval by the Mayor of the City.
