

1 **BOARD BILL NO. 201** **INTRODUCED BY ALDERWOMAN JENNIFER**

4 An ordinance submitting to the qualified voters residing in the Tower Grove South
5 Concerned Citizens Special Business District Special Business District as designated in
6 Ordinance No. _____, approved _____ a proposal to renew and continue
7 the levy a tax on the real property located in said district; submitting said proposal to the
8 voters of said district at an Election on March 5, 2013; and containing an emergency
9 clause.

10 BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

11 SECTION ONE. The following proposition is hereby submitted to the qualified voters
12 residing in the Tower Grove South Concerned Citizens Special Business District Special
13 Business District, as designated in Ordinance No. _____, approved _____ and
14 shall be voted upon at the election to be held as hereinafter provided. The proposition
15 shall read substantially in words and figures as follows:

16 Shall a tax not to exceed sixty-eight cents (\$.68) per \$100.00 valuation be
17 imposed for the tax years 2014, 2015, 2016, 2017 and 2018 on all real property located in
18 the Tower Grove South Concerned Citizens Special Business District as defined in
19 Ordinance No. _____, approved _____ for the purposes as set
20 forth in said Ordinance?

21 SECTION TWO. The foregoing proposition shall be submitted to qualified voters
22 residing in the Tower Grove South Concerned Citizens Special Business District at a
23 special election in said District to be held on Tuesday, March 5, 2013. If the proposition
24 shall receive in its favor the votes of the majority of the qualified voters voting at said
25 election for or against said proposition, the tax as set forth within said proposition shall

1 be authorized and adopted and become part of the laws of the City of St. Louis from the
2 date of said election. The qualified voters may, at such election, vote a ballot
3 substantially in the following form:

4 OFFICIAL BALLOT

5 Shall a tax not to exceed sixty-eight cents (\$.68) per \$100.00 valuation be imposed for
6 the tax years 2014, 2015, 2016, 2017 and 2018 on all real property located in the Tower
7 Grove South Concerned Citizens Special Business District as defined in Ordinance No.
8 _____, approved _____ for the purposes as set forth in said
9 Ordinance?

12 SECTION THREE. Notice of the election on such proposition shall be published and said
13 election shall be conducted in the manner provided by law.

14 SECTION FOUR. Immediately upon the passage and approval of this Ordinance, the
15 City Register shall certify a copy thereof to the Board of Election Commissioners for the
16 City of St. Louis for action and proceedings by said Board in accordance herewith and as
17 required by law.

18 SECTION FIVE. This being an ordinance calling and providing for an election and vote
19 by the people and fixing a tax rate, it is declared to be an emergency measure as defined
20 by Article IV, Sections 19 and 20 of the Charter of the City of St. Louis and shall take
21 effect and be in force from and after its adoption and approval by the Mayor.
