12 An ordinance amending Ordinance 69984 (which established the City of St. Louis  
13 Civilian Oversight Board, known as the “COB”) to empower the COB to issue subpoenas  
14 to compel the appearance of witnesses, produce documents, recordings and other  
15 evidence which the COB determines in its reasonable judgment are relevant and  
16 necessary to its thorough Inspection and Review of Complaints of misconduct by  
17 members of the St. Louis Metropolitan Police Department which may be subject to COB  
18 Independent Investigation.

1 hereby revised to read as follows:

2 **SECTION FOUR. Authority and Duties**

3 1. Authority: the COB shall have the authority to receive Complaints,  
4 monitor IAD Investigations regarding Complaints, and review completed IAD  
5 Investigations of Complaints in accordance with the provisions of this Ordinance,  
6 **and to issue both subpoenas ad testificandum, to compel the appearance of**  
7 **witnesses, and subpoenas duces tecum, to compel the production of**  
8 **documents, recordings, materials, and other physical evidence which the COB**  
9 **determines in its reasonable judgment are relevant and necessary for its**  
10 **thorough Inspection and Review of Complaints.**

12 **SECTION TWO. EMERGENCY CLAUSE.** This being an Ordinance for the  
13 preservation of public peace, health and safety, it is hereby declared to be an immediate  
14 measure within the meaning of Sections 19 and 20 of Article IV of the Charter of the City  
15 of St. Louis and therefore this Ordinance shall become effective immediately upon its  
16 passage and approval by the Mayor.
