

1 **BOARD BILL NO. 237 INTRODUCED BY ALDERWOMAN SHARON TYUS**

3 An ordinance pertaining to parking within "The 4200-4400 North Euclid
4 Avenue Residential Parking District"; authorizing the Traffic Administrator to designate
5 the location and restrictions for curb parking of residential parking zones within the
6 4200-4400 North Euclid Avenue Residential Parking District Parking District;
7 authorizing the placement of Residential Permit Parking Only signs within the District;
8 and prohibiting the parking, within the District, of any vehicle which does not display the
9 authorized permit; containing definitions, a penalty clause and an emergency clause.

10 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

11 **Section One. Definitions.**

12 A. "The 4200-4400 Blocks of North Euclid Avenue Residential Parking
13 District" is the 4200-4400 Blocks of North Euclid Avenue that is bounded on the north by
14 Bircher Boulevard and bounded on the south by Penrose Street.

15 B. "Parking permit" is a valid resident or visitor parking permit issued for the
16 4200-4400 Blocks of North Euclid Avenue Residential Parking District by the Traffic
17 and Transportation Administrator of the City of St. Louis.

18 C. "Resident" is a person who lives in property abutting a street designated in
19 whole or in part as a residential parking zone.

20 D. "Residential parking zone" is any street, or any portion of a street, within
21 the boundaries of the 4200-4400 Blocks of North Euclid Avenue Residential Parking
22 District which is designated and posted by the Traffic and Transportation Administrator
23 as a residential parking zone with specific parking restrictions.

1 E. "Visitor" is any person who is a household guest, a visitor, a worker
2 performing services for, or domestic help for, a resident.

3 **Section Two. Designation of residential parking zones.**

4 The Traffic and Transportation Administrator is hereby authorized to designate
5 the location and restrictions for curb parking of residential parking zones within the
6 4200-4400 Blocks of North Euclid Avenue Residential Parking District on any street, or
7 any portion of a street, on which the predominant land used is zoned A single-family
8 dwelling district, when 65 percent of the registered voters living on said street indicate by
9 petition that they desire a street, or a portion of a street, to be made a residential parking
10 zone and when the Alderman from the ward, wherein the street is located, indicate that
11 such alderman recommends the designation.

12 **Section Three. Permit use.**

13 A. When signs are erected upon streets in residential parking zones
14 designating "Residential Permit Parking Only" during certain hours of the day on certain
15 days, no person, firm or corporation shall park or cause to be parked any vehicle during
16 such hours of such days that does not display either a resident or visitor parking permit.

17 B. When signs are erected upon streets in residential parking zones
18 restricting public curb parking to certain amounts of time during certain hours of the day
19 on certain days, no person, firm or corporation shall park or cause to be parked in excess
20 of the prescribed parking time limit any vehicle that does not display either a resident or
21 visitor parking permit.

22 **Section Four. Permit issuance.**

23 The Traffic and Transportation Administrator may issue annual parking
24 permits to the residents of any designated residential parking zone. The Traffic and
25 Transportation Administrator may designate an individual or group of individuals

1 residing within the 4200-4400 Blocks of North Euclid Avenue Residential Parking
2 District, at no cost to the City, to procure, assign and distribute such annual parking
3 permits, and to procure and install such signs.

4 **Section Five. Penalty for violation.**

5 A. Any person, firm or corporation who shall park or cause to be parked any
6 vehicle in violation of the provisions of this ordinance shall upon the conviction thereof
7 be fined twenty dollars (\$20.00) for each such offense.

8 B. Any person, firm or corporation who shall distribute a resident or visitor
9 parking permit to any person, firm or corporation not authorized to display such parking
10 permit shall have his or her parking permits suspended by the Traffic and Transportation
11 Administrator for a period not to exceed one year.

12 **Section Six. Emergency Clause.**

13 This being an ordinance for the preservation of public peace, health, and
14 safety, it is hereby declared to be an emergency measure within the meaning of Sections
15 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore shall become
16 effective immediately upon its passage and approval by the mayor.
