

1 **BOARD BILL NO. 250** **INTRODUCED BY ALDERMAN TERRY KENNEDY**

2 An ordinance pertaining to parking within "The North Newstead Avenue Residential
3 Parking District"; authorizing the Traffic Administrator to designate the location and restrictions
4 for curb parking of residential parking zones within the North Newstead Avenue Residential
5 Parking District; authorizing the placement of Residential Permit Parking Only signs within the
6 District; and prohibiting the parking, within the District, of any vehicle which does not display
7 the authorized permit; containing definitions, a penalty clause and an emergency clause.

8 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

9 **SECTION ONE.** Definitions.

10 A. "The North Newstead Avenue Residential Parking District" is the area comprising the
11 east side of the 200 Block of North Newstead Avenue bounded on the east by Lindell Boulevard
12 and bounded on the north by Maryland Avenue.

13 B. "Parking permit" is a valid resident or visitor parking permit issued for the North
14 Newstead Avenue Residential Parking District by the Traffic and Transportation Administrator
15 of the City of St. Louis.

16 C. "Resident" is a person who lives in property abutting a street designated in whole or in
17 part as a residential parking zone.

18 D. "Residential parking zone" is any street, or any portion of a street, within the
19 boundaries of the North Newstead Avenue Residential Parking District which is designated and
20 posted by the Traffic and Transportation Administrator as a residential parking zone with
21 specific parking restrictions.

1 E. "Visitor" is any person who is a household guest, a visitor, a worker performing
2 services for, or domestic help for, a resident.

3 **Section Two. Designation of residential parking zones.**

4 The Traffic and Transportation Administrator is hereby authorized to designate the
5 location and restrictions for curbside parking of residential parking zones within the North Newstead
6 Avenue Residential Parking District on any street, or any portion of a street, on which the
7 predominant land used is zoned A single-family dwelling district, when 65 percent of the
8 registered voters living on said street indicate by petition that they desire a street, or a portion of
9 a street, to be made a residential parking zone and when the Alderman from the ward, wherein
10 the street is located, indicate that such alderman recommends the designation.

11 **Section Three. Permit use.**

12 A. When signs are erected upon streets in residential parking zones designating
13 "Residential Permit Parking Only" during certain hours of the day on certain days, no person,
14 firm or corporation shall park or cause to be parked any vehicle during such hours of such days
15 that does not display either a resident or visitor parking permit.

16 B. When signs are erected upon streets in residential parking zones restricting public curbside
17 parking to certain amounts of time during certain hours of the day on certain days, no person,
18 firm or corporation shall park or cause to be parked in excess of the prescribed parking time limit
19 any vehicle that does not display either a resident or visitor parking permit.

20 **Section Four. Permit issuance.**

21 The Traffic and Transportation Administrator may issue annual parking permits to the
22 residents of any designated residential parking zone. The Traffic and Transportation

1 Administrator may contract with a Missouri nonprofit corporation at no cost to the City for the
2 procurement, assignment and distribution of said annual parking permits, and the procurement
3 and installation of said signs.

4 **Section Five. Penalty for violation.**

5 A. Any person, firm or corporation who shall park or cause to be parked any vehicle in
6 violation of the provisions of this ordinance shall upon the conviction thereof be fined twenty
7 dollars (\$20.00) for each such offense.

8 B. Any person, firm or corporation who shall distribute a resident or visitor parking
9 permit to any person, firm or corporation not authorized to display such parking permit shall
10 have his or her parking permits suspended by the Traffic and Transportation Administrator for a
11 period not to exceed one year.
