

1 **BOARD BILL NO. 254 INTRODUCED BY ALDERMAN STEPHEN**  
2 **CONWAY**

4 An ordinance submitting to the qualified voters residing in the Gardenside Subdivision  
5 Special Business District as designated in Ordinance No. \_\_\_\_\_, approved  
6 \_\_\_\_\_ a proposal to renew and continue the levy a tax on the real  
7 property located in said district; submitting said proposal to the voters of said district at  
8 an Election on August 7, 2012; and containing an emergency clause.

9 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

10 **SECTION ONE.** The following proposition is hereby submitted to the qualified voters  
11 residing in the Gardenside Subdivision Special Business District, as designated in  
12 Ordinance No. \_\_\_\_\_, approved \_\_\_\_\_, 2012, (Board Bill No.---- )and shall be voted upon  
13 at the election to be held as hereinafter provided. The proposition shall read substantially  
14 in words and figures as follows:

15 Shall a tax not to exceed \$.85 per \$100.00 valuation be renewed and continued for  
16 the tax years 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021 and 2022 on  
17 all real property located in the Gardenside Subdivision Special Business District as  
18 defined in Ordinance No. \_\_\_\_\_, approved \_\_\_\_\_, 2012, ( Board Bill No. ---) for the  
19 purposes as set forth in said Ordinance?

20 **SECTION TWO.** The foregoing proposition shall be submitted to qualified voters  
21 residing in the Gardenside Subdivision Special Business District at a special election in  
22 said District to be held on Tuesday, August 7, 2012. If the proposition shall receive in its  
23 favor the votes of the majority of the qualified voters voting at said election for or against  
24 said proposition, the tax as set forth within said proposition shall be authorized and  
25 adopted and become part of the laws of the City of St. Louis from the date of said

1 election. The qualified voters may, at such election, vote a ballot substantially in the  
2 following form:

4 Shall a tax not to exceed \$.85 per \$100.00 valuation be renewed and continued for  
5 the tax years 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021 and 2022 on  
6 all real property located in the Gardenside Subdivision Special Business District as  
7 defined in Ordinance No. \_\_\_\_\_, approved 2012, (Board Bill No.---) for the purposes  
8 as set forth in said Ordinance?

11 **SECTION THREE.** Notice of the election on such proposition shall be published and  
12 said election shall be conducted in the manner provided by law.

13 **SECTION FOUR.** Immediately upon the passage and approval of this Ordinance, the  
14 City Register shall certify a copy thereof to the Board of Election Commissioners for the  
15 City of St. Louis for action and proceedings by said Board in accordance herewith and as  
16 required by law.

17 **SECTION FIVE.** This being an ordinance calling and providing for an election and  
18 vote by the people and fixing a tax rate, it is declared to be an emergency measure as  
19 defined by Article IV, Sections 19 and 20 of the Charter of the City of St. Louis and shall  
20 take effect and be in force from and after its adoption and approval by the Mayor.
